The South African National Roads Agency SOC Limited (SANRAL) invites tenders for the provision of **CONSULTING ENGINEERING SERVICES FOR THE IMPROVEMENT OF NATIONAL ROUTE 14 SECTION 6 FROM JENKINS FARMS (KM 22.4) TO KATHU (KM 49.24)**. This project is in the province of the Northern Cape and in the Gamagara Local Municipality and the approximate programme is for design and construction documentation to be completed by January 2026 followed by supervision of 27 months, including three months mobilisation period, commencing July 2026.

Only tenderers who are registered on the National Treasury Central Supplier Database and meet the minimum requirements for the key persons as stipulated in Clause C.2.1 at the tender closing date, are eligible to tender.

Joint Ventures (JV) will be allowed on condition that one JV partner is a Targeted Enterprise. The JV partner will, however, not contribute to sub-contract target for Targeted Enterprises.
