1.2.10 Telephonic, telegraphic, telex, facsimile or e-mailed bid offers will not be accepted.

1.2.11 The bid offer validity period is ninety (90) days.

**1.2.14 The procedure for the evaluation of responsive bids will be on 80/20 points system, where 80 points are for price and 20 points are for Municipal Specific goals**

1.2.15 Bid offers will only be accepted if:

- 1.2.15.1 The bidder has registered with the central supplier database (CSD);
- 1.2.15.2 The bidder or any of its directors is not listed on the Register of Bid Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector;
- 1.2.15.3 The bidder has not:
  - abused the Employer's Supply Chain Management System; or
  - failed to perform on any previous contract and has been given a written notice to this effect;
- 1.2.15.4 The bidder has completed the Compulsory Enterprise questionnaire and there are no conflicts of interest which may impact on the bidder's ability to perform the contract in the best interests of the employer or potentially compromise the bid process; and
- 1.2.15.5 Proof of municipal rates and taxes for both the company and the directors are attached not older than three months of the closing date of the tender.
- 1.2.15.6 The bidder or any of its directors is not employed by the state.

## **CRITERIA FOR THE AWARDING OF CONTRACTS**

- a. The points scored by a tenderer in respect of the specific goals above must be added to the points scored for price.
- b. Only the tender with the highest number of points scored may be selected.

## **2.1. Criteria for breaking deadlock in scoring**

- (1) If two or more tenderers score an equal total number of points, the contract must be awarded to the tenderer that scored the highest points for specific goals.
- (2) If two or more tenderers score equal total points in all respects, the award must be decided by the drawing of lots.

## **2.2. Exemption**

The Minister may, on request, exempt an organ of state from any or all the provisions of this Act if-

- (a) It is in the interest of national security
- (b) The likely tenderers are international suppliers; or
- (c) It is in the public interest

## **AWARD OF CONTRACTS TO TENDERERS NOT SCORING HIGHEST POINTS**



##### **1.GENERAL**

- ✓ **The Bags to be supplied are to be of the “single trip” type and are intended for use as liners to refuse bins of the type normally used for the outdoor storage of domestic refuse**
- ✓ **The Bags must perform satisfactorily under normal field conditions and not tear**

##### **2.BAGS COLOURS**

- ✓ **The Bags shall be manufactured and delivered in three colours as follows:**
  - **Black** : for Domestic Waste
  - **Yellow** :for Garden Waste
  - **Green** :for disposable nappies
- ✓ All bags to be supplied /delivered must be printed in 20mm **“MAKHUDUTHAMAGA LOCAL MUNICIPALITY –WASTE MANAGEMENT” as follows:**
  - Black Bags to be written in White ink
  - Yellow Bags in blank ink
  - Green Bags in black ink

##### **3.TECHNICAL SPECIFICATION**

- ✓ The bags must be gusseted
- ✓ Fabrication be on tubular basis with a heat seal at the bottom
- ✓ The Seal shall be able to withstand a ten minute tensile loading of **20kg per meter length of seal without failure or tear**
- ✓ Seals will be critically examined and inadequate seals shall lead to rejection of the consignment
- ✓ All bags should be readily opened by hand and be free from
  - Visible Pinholes
  - Blisters
  - Die-lines
  - Tears
  - Or other deleterious defects

  - Minimum “lay-flat” length of 910 mm and a
  - Minimum “lay-flat” width of 760mm and
- ✓ The Bags must be manufactured from a mix of 50%recycled and 50% virgin material
