1. INTRODUCTION AND PURPOSE

Quotation for the emergency occupational health and safety equipment and signage at various sites within Environmental Management and Parks.

2. BACKGROUND

The purpose of the quote is to ensure that the Crematorium, Nursery, Resorts and Nature Conservation Facilities comply with the Occupational Health and Safety requirements.

These various facilities are required to comply with basic Health and safety requirements which include safety signage, safety equipment and personal protective equipment.

The quotation comprises the following Items:

3. PROJECT SCOPE

The Division is looking to appoint one bidder for the following emergency occupational health and safety equipment required for supply and or installation at various facilities of Environmental Management and Parks.

3.1 SUPPLY, DELIVERY, AND INSTALLATION OF VARIOUS SAFETY SIGNAGE

The following items will be required to be supplied and installed on site.

The signage will either be ordered as supply and delivery only or supply, delivery and installation.

Installation:

The signage boards can be installed in the following ways:

1. Install against a brick or concrete wall – install with 4 5mm plug and screws. Drill holes in the wall to install the sign.
2. Install against a metal surface, like a cupboard door etc. – use pop rivets. Drill holes in the metal surface and install with the pop rivets.
3. Install on a pole – drill 4 holes in the centre of the board and install with a clamp or pop rivets to the pole.
4. The bidder is to supply their own drill, drill bits, ladders, extension leads and in many case a generator for power where the boards need to be installed in places where there is no electricity.

The bidder must supply 2 signed reference letters for sites where Safety boards have been supplied and installed (for Item 1 Only). It must be on the client's letterhead. The reference must be less than 36 months old.

4.3 STAGE 3: PREFERENTIAL SCORING

The preferential points to be used will be the 80/20 system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- 80 points for price
- 20 points for Specific Goals

5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
 - (a) has been requested to submit a bid in response to this bid invitation;
 - (b) could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
 - (c) provides the same goods and services as the bidder and/or is in the same line of business as the bidder

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.
7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
