### **3. EVALUATION CRITERIA**

Proposals will be evaluated in accordance with the 80/20 preference point system, as contemplated in the Preferential Procurement Policy Framework Act (Act 5 of 2000). The evaluation shall be conducted as follows:

- Stage 1: Phase 2: Administrative Compliance
- Stage 2: Phase 1: Price and Specific Goals

#### **3.1 Stage 1 : Phase 1 Special Conditions**

##### **Bidders must submit the following :**

- 3.1.1 A letter/proof from the local manufacturer confirming local production and content outlining types and sizes of the items used on the wheelchair and examination bed.
- 3.1.2 Declaration Certificate for Local Content Annexure C must be submitted with the proposal by the closing date and time as stipulated in the invitation to quote

##### **Terms for Wheelchair and Examination bed:**

- ✓ The stipulated minimum threshold percentage for local production and content for the following as stipulated by the Department of Trade, Industry and Competition (the DTIC)

is applicable:

- **Wheelchair = 80%**
- **Mattress of the examination bed = 80%**
- **Steel base of the examination bed = 100%**

- ✓ An exemption letter from the DTIC must be obtained as per the exemption process followed by the DTIC for items or materials that are imported and in cases whereby local content requirements cannot be met for various reasons (see *exemption process* followed by the DTIC).
- ✓ Substantial supporting documents may be required at any point in time before and after the award of the contract.
- ✓ Due diligence, which includes verification of information, may be conducted in this regard.
