Documents will only be available for collection at the compulsory clarification meeting if tenderers booked their tender documents in advance, with proof of payment. Tenders should be booked before Friday, 17 February 2023 at 12:00. No tenderers will be allowed to attend the compulsory clarification meeting after 11:15.**

A non-refundable fee of R 250.00 (Two hundred and Fifty Rand), is payable for a set of documents. Bids will then be opened in the presence of anyone who wishes to attend, in the Supply Chain Management Committee Room in the Sanlam Building Shop Nr 7, Donkin Street, Beaufort West.

Telegraphic, facsimile, e-mail and late bids will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

The bid must be valid for a period of 120 (One Hundred and Twenty) days after the closing date. The bid will be subject to Council's Supply Chain Management Policy, Preferential Procurement Policy, the Preferential Procurement Policy Framework Act and the Preferential Procurement Regulations, 2022. Points will be allocated for the following specific goals: (a) contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability; and (b) promotion of enterprises located in the municipal area (WC053).
