TERMS OF REFERENCE:

PROVISION OF MAINTENANCE AND SUPPORT TO THE ELECTRONIC CONTRACT MANAGEMENT SYSTEM FOR THE FILM AND PUBLICATION BOARD (FPB)

1. Introduction

1.1. The Film and Publication Board (FPB) is a statutory body established in terms of the Films and Publications Act, 1996 (Act No. 65 of 1996) (FP Act), whose main objective is to regulate, both on physical and online platforms, the creation, production, possession and distribution of films, games and certain publications in order to protect children from disturbing and harmful content and to provide content information to adults that will enable them to make informed reading, viewing and gaming choices for both themselves and children in their care.

2. Objectives

2.1. The FPB is obliged in terms of its Contract Management Policy to ensure that contracts entered into by the FPB are managed throughout the lifecycle of same based on the level of management control appropriate for the classification of that contract.

2.2. The purpose of appointing a Service Provider is to provide maintenance and support for the contract management system which shall include upgrading of the system to ensure that the FPB effectively manage all contracts throughout their lifecycle for a period of three (3) years.

3. Invitation

- 3.1. Service Providers are invited to send proposals to the FPB for consideration. In preparing a proposal, it is crucial that a Service Provider demonstrate expertise in the provision of contract management system (electronic contract management tool).

4. Scope of Work

- 4.1. The Service Provider will be required to provide maintenance which shall corrective maintenance such as fixing errors and preventive maintenance such as upgrades and patch installations and support which shall include adding new feature, responding to calls logged etc. of the Contract Management System for the FPB for such system for a period of three (3) years.

5. Training and support

- 5.1. The Service Provider will be required to train all the FPB users (SCM personnel, Contract Managers, Legal and Regulatory Affairs unit members and Exco members) to be able to effectively utilise the system.
- 5.2. Make available its technical personnel for support telephonically assistance, MS teams, etc. on the proper use of online content.

6. Reporting Relationship

6.1. The Service Provider will engage with the Manager: Legal and Regulatory Affairs Unit of the FPB as and when it is necessary.

6.2. Intellectual property rights

6.2.1. All copyright and intellectual property rights that may result as consequences of the work to be performed will become the property of the FPB.

6.2.2. The Service Provider must hand over all documents and information in any format, including copies thereof, that it received from the FPB or that it had access to during the assignment immediately after completion of the assignments to the FPB.

6.3. Procurement policies and procedures

6.3.1. The general conditions of bid, contract and order will be applicable to this bid.

7. Evaluation Phases

7.1. The evaluation of bids will be performed using 80/20 preferential points.

7.2. The received bid proposals will be evaluated in different phases in order to arrive to the final phase of bid award, and the phases will be as follows:

7.2.1. Stage 1: Minimum Screening Requirements

- (a) In this phase All bids received will be verified for compliance and completeness of the submitted proposal per the below set of mandatory requirements. Bidders who fails to comply with the below requirements will be disqualified and bidders who comply with the below progress progresses to the next phase of technical evaluation.
 - (i) Bid forms must be properly received on the bid closing date and time specified on the invitation, fully completed, dated and signed in ink.
 - (ii) Bid forms must be properly fully completed, dated signed in ink and initial every page of the bid.
 - (iii) The bid document must be (1) bound (2) without tearing and (3) contain all pages.
 - (iv) Invitation to bid (SBD 1) must be fully completed.
 - (v) Submission of fully completed SBD 4 (Bidder Disclosure).

(vi) Submission of fully completed SBD 6.1 (Preference Claim Certificate), accompanied by the relevant proof of B-BBE contribution Level.
