SECTION 1: BACKGROUND, OVERVIEW AND RFP SCOPE OF REQUIREMENTS

1. Introduction

The National Lotteries Commission (The Commission) is a public entity established by Lotteries Act No. 57 of 1997, as amended to regulate the South African lotteries industry. The functions of the Commission can be divided into two categories, namely “regulation of National Lottery and other Lotteries” and “administration of the National Lottery Distribution Trust Fund (NLDTF)”.

The Distributing Agencies (DA's) who are appointed by the Minister of Trade & Industry are responsible for the adjudication of the funding applications as per the Lotteries Act and applicable Regulations.

2. Background

The Company Secretary's (CS) Office is responsible for ensuring that the NLC and the Board conduct themselves in a way that is consistent with the recommendations outlined by the King IV Report on Corporate Governance for South Africa 2016; and to assist the Board with discharging their duties and responsibilities. Therefore, there is a need to implement electronic Board Portal Software for a reliable, real-time and easily accessible platform to the Board and its stakeholders.

The NLC invites suitably qualified and experienced bidders to submit proposals for the supply, installation, configuration, and after sales & technical support of an electronic Board Portal Software in line with the requirements of the Public Finance Management Act (PFMA) No. 1 of 1999, as amended and Treasury Regulations.

The purpose of the request for proposal (RFP) is to appoint a suitable, qualified, and experienced service provider to supply, install, configure, provide technical support and training of an electronic Board Portal Software that will promote efficient, effective and timely organising, planning and facilitation of Board meetings of the NLC for a period of three (3) years. This RFP seeks to achieve the following objectives:

- Acquisition of electronic Board Portal Software that will ensure a seamless and efficient facilitation of Board meetings.
- Acquisition of an electronic Board Portal Software that will ensure convenient access of Board meeting packs by the Board;
- Acquisition of an electronic Board Portal Software that will ensure cost saving measures when it comes to planning, organising and facilitating Board meetings; and
- Acquisition of an electronic Board Portal Software that will ensure that the Board discharges its governance duties efficiently, effectively, and in a timely manner.

3. RFP Scope of Requirements

The service provider should have competencies over the following expectations and requirements by the NLC:

- Supply of the electronic Board Portal Software;
- Installation of the system;
- Configuration of the system to the preference of the NLC;
- After sales/technical support;
- Frequent maintenance of the system;
- Version and security updates;
- Alignment of system with NLC's security protocols;
- Provision of fifteen (15) software licences; and
- User Training as and when required.
- Backup, restoration and related cybersecurity protocols

4. Deliverables

The electronic Board Portal Software should as a minimum provide for the following:

- securely accessible by all board members from any location and should support strong security features such as encryption or two-phase authentications; The system must be capable of providing enhanced security tools like remote locking;
- caters for users on mobile platforms and should also support most modern web browsers;
- allows for seamless scheduling of meetings with an online, collaborative meeting space where you can include venue maps; agendas; attendee list; meeting minutes; pre-and post-meeting actions and add related documents;
- provides for a meeting pack function which allows one to easily collate meeting documents, including agendas, index, minutes, dividers, and page numbering, into one file. Board members should be able to perform annotations (highlight text, make notes etc.) and document sign off on their meeting packs, complete questionnaires, ask questions, place votes with or without Wi-Fi;
- provides an intuitive and functionally rich knowledge store;
- provides a centralised, collaborative platform where everyone can access and contribute to good decision making by capturing all decisions made and allowing easy to create surveys;
- extensive end user as well as administrator training on the use of the system;
- allows creation and distribution of resolutions for voting by Board members and tracking thereof;
- allows Board members to use its functions and content both online and offline and provide Board members with full access to minutes and resolutions;
- customizable permissions for data access can be personalized down to the document-level and user-level to improve privacy and security;
- has the ability to create virtual rooms for board committees or smaller groups to allow secure collaboration before and after meetings;

- editing capabilities of meeting packs;
- has minute-taking capabilities to enhance minute-taking processes and matters arising processing and tracking; and
- Compliance with Cybersecurity standards and NLC ICT related policies.

Through the deployment of this system, the NLC could achieve the following benefits:

- Immediate implementation (plug and play) no system development requirements
- Cloud Based for easy and convenient access;
- Administrative time and cost saving;
- Instant and secure distribution of meeting packs;
- Collaborative, engaging, and easier to manage meetings;
- Apps available for Apple, Android, and Windows devices;
- Mitigation of risks through procedures, and
- Transparency in decision making procedures.

5. Reporting Requirements

The service provider will report to the CS Office

6. Duration of the Project

The expected duration of the project is three (3) years.

SECTION 2: NOTICE TO BIDDERS

1. Terms and conditions of Request for Proposals (RFP)

- 1.1 This document may contain confidential information that is the property of the Commission.
- 1.2 No part of the contents may be used, copied, disclosed, or conveyed in whole or in part to any party in any manner whatsoever other than for preparing a proposal in response to this RFP without prior written permission from the Commission.
- 1.3 All copyright and intellectual property herein vests with the Commission.
- 1.4 Late and incomplete submissions will not be accepted.
- 1.5 No services must be rendered, or goods delivered before an official Commission Purchase Order form has been received.
- 1.6 This RFP will be evaluated in terms of the 80/20 preference point system prescribed by the Preferential Procurement Regulations, 2022.
- 1.7 Suppliers are required to register on the Central Supplier Database at www.csd.gov.za.
- 1.8 Suppliers must provide their CSD registration number (and attach a CSD Summary report) and ensure that their tax matters are compliant.
- 1.9 All questions regarding this RFP must be forwarded to maureen@nlcsa.org.za or bids@nlcsa.org.za, no later than within 24 hours of the RFP closing date.
- 1.10 Any supplier who has reasons to believe that the RFP specification is based on a specific brand must inform the Commission via the email addressed in 1.9.

2. General rules and instructions

2.1 News and press releases

- 2.1.1 Bidders or their agents shall not make any news releases concerning this RFP or the awarding of the same or any resulting agreement(s) without the consent of, and then only in co-ordination with, the Commission.

2.2 Precedence of documents

- 2.2.1 This RFP consists of a number of sections. Where there is a contradiction in terms between the clauses, phrases, words, stipulations or terms and herein referred to generally as stipulations in this RFP and the stipulations in any other document attached hereto, or the RFP submitted hereto, the relevant stipulations in this RFP shall take precedence.
 - 2.2.2 Where this RFP is silent on any matter, the relevant stipulations addressing such matter, and which appear in the PPPFA shall take precedence. Bidders shall refrain from incorporating any additional stipulations in its proposal submitted in terms hereof other than in the form of a clearly marked recommendation that the Commission may in its sole discretion elect to import or to ignore. Any such inclusion shall not be used for any purpose of interpretation unless it has been so imported or acknowledged by the Commission.
 - 2.2.3 It is acknowledged that all stipulations in the PPPFA are not equally applicable to all matters addressed in this RFP. It, however, remains the exclusive domain and election of the Commission as to which of these stipulations are applicable and to what extent. Bidders are hereby acknowledging that the decision of the commission in this regard is final and binding. The onus to enquire and obtain clarity in this regard rests with the Bidder(s). The Bidder(s) shall take care to restrict its enquiries in this regard to the most reasonable interpretations required to ensure the necessary consensus.
- ### **2.3 Preferential procurement reform**
- 2.3.1 The commission supports B-BBEE as an essential ingredient of its business. In accordance with government policy, the commission insists that the private sector demonstrates its commitment and track record to B-BBEE in the areas of ownership (shareholding), skills transfer, employment equity and procurement practices (SMME Development) etc.
 - 2.3.2 The Commission shall apply the principles of the Preferential Procurement Policy Framework Act, (Act No. 5 of 2000) to this proposal read together with the Preferential No. 5 of 2000) to this proposal read together with the Preferential Procurement Regulations published in Government Notice No.32 in Government Gazette No. 40553 dated 20 January 2022 (“the Preferential Procurement Regulations, 2022”).
- ### **2.4 National Industrial Participation Programme**
- 2.4.1 The Industrial Participation policy, which was endorsed by Cabinet on 30 April 1997, is applicable to contracts that have an imported content. The NIP is obligatory and therefore must be complied with. Bidders are required to sign and submit the Standard Bidding Document (SBD).
- ### **2.5 Language**
- 2.5.1 Bids shall be submitted in English.
- ### **2.6 Gender**
- 2.6.1 Any word implying any gender shall be interpreted to imply all other genders.

2.7 Headings

2.7.1 Headings are incorporated into this RFP document and submitted in response thereto, for ease of reference only and shall not form part thereof for any purpose of interpretation or for any other purpose.

2.8 Occupational Injuries and Diseases Act 13 of 1993

2.8.1 The Bidder warrants that all its employees (including the employees of any sub-contractor that may be appointed) are covered in terms of the Compensation for Occupational Injuries and Diseases Act 13 of 1993 and that the cover shall remain in force for the duration of the adjudication of this RFP and/ or subsequent agreement. The commission reserves the right to request the Bidder to submit documentary proof of the Bidder's registration and "good standing" with the Compensation Fund, or similar proof acceptable to the commission.

2.9 Processing of the Bidder's Personal Information

2.9.1 All Personal Information of the Bidder, its employees, representatives, associates and sub-contractors ("Bidder Personal Information") required under this RFP is collected and processed for the purpose of assessing the content of its tender proposal and awarding the bid. The assessment and award of the bid shall be conducted in accordance with applicable legislation including the PPPFA read with the Preferential Procurement Regulations, 2022. The Bidder is advised that Bidder Personal Information may be passed on to third parties to whom the commission is compelled by law to provide such information. For example, where appropriate, the commission is compelled to submit information to National Treasury's Database of Restricted Suppliers.

2.9.2 All Personal Information collected will be processed in accordance with POPIA and with the commission Data Privacy Policy.

2.9.3 The following persons will have access to the Personal Information collected:

2.9.3.1 The commission personnel participating in procurement/award procedures; and

2.9.3.2 Members of the public: within seven working days from the time the bid is awarded, the following information will have to be made available on National Treasury's e-Tender portal:

2.9.3.2.1 contract description and bid number;

2.9.3.2.2 names of the successful bidder(s) and preference points claimed;

2.9.3.2.3 the contract price(s) (if possible);

2.9.3.2.4 contract period;

2.9.3.2.5 names of directors; and

2.9.3.2.6 date of completion/award.

2.9.4 The commission will ensure that the rights of the Bidder and of its employees and representatives (i.e., the right of access and the right to rectify) are effectively guaranteed in accordance with the procedures as specified in the commission PAIA manual.

2.9.5 In signing this document, the Bidder consents to the use of its Personal Information for the purposes as specified in section 2.9.1 above.

3. Formal Briefing Session

- 3.1 There will be no briefing session for this RFP.

4. Validity Period

- 4.1 The Commission requires a validity period of 90 [ninety] business days [from 27 June 2023 to 28 September 2023] against this RFP.
- 4.2 Bidders are to note that they may be requested to extend the validity period of their bids, on the same terms and conditions, if the internal evaluation process is not finalised within the validity period.

5. National Treasury's Central Supplier Database

- 5.1 Bidders are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information.
- 5.2 The Commission may not award business to a bidder who has failed to register on the CSD.
- 5.3 Only foreign suppliers with no local registered entity need not register on the CSD.
- 5.4 The CSD can be accessed at <https://secure.csd.gov.za/>

6. Confidentiality

- 6.1 Bids submitted for this Request for Proposals will not be revealed to any other bidders and will be treated as contractually binding;
- 6.2 The Commission reserves all the rights afforded to it by POPIA in the processing of any of its information as contained in Bid Proposals.
- 6.3 The Bidder acknowledges that it will obtain and have access to personal information of The Commission and agrees that it shall only process the information disclosed by the Commission in terms of this bid award and only for the purposes as detailed in this RFP and in accordance with any applicable law.
- 6.4 The Bidder shall notify the Commission in writing of any unauthorised access to personal information and the information of a third party, through cybercrimes or suspected cybercrimes, in its knowledge and report such crimes or suspected crimes to the relevant authorities in accordance with applicable laws, after becoming aware of such.

7. Communication

- 7.1 Specific queries relating to this RFP should be submitted maureen@nlcsa.org.za or bids@nlcsa.org.za, before the closing date.
- 7.2 In the interest of fairness and transparency the Commission's response to such a query may be made available to other bidders.
- 7.3 It is prohibited for bidders to attempt, either directly or indirectly, to canvass any officer or employee of the Commission in respect of this RFP between the closing date and the date of the

award of the business.

- 7.4 Bidders found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of the state for a specified period.

SECTION 3: EVALUATION CRITERIA

The Commission will evaluate all proposals in terms of the Preferential Procurement Regulation of 2022 and Preferential Procurement Policy Framework Act. No. 5 of 2000 (PPPFA). Six (6) phase evaluation criteria will be considered in evaluating the proposals as follows:

Stage 1: Tender Closing and Opening

1.1 Tender closing details

1.2. Bid Formats

Bid submissions must be submitted in a PDF format that is protected from any modifications, deletions, or additions.

Financial/pricing information must be presented in a separate attachment from the Technical/Functional Response information. The onus is on the Bidder to ensure that all mandatory and required documents are included.

Submissions must be prominently marked with the full details of the tender namely Bidder's Name, Tender No and Tender Title.

Stage 2: Administrative Compliance
