### BACKGROUND



In brief, the Supplier will be responsible for the Replacement of Roller Shutter Doors at O. R. Tambo International Airport. This will include the supply of all required skill, expertise, labour, materials and tools to complete the delivery of the goods and services, the installation of all listed roller shutter doors, removal from site of disused parts of or whole roller shutter doors, all required commissioning and testing of each replaced or refurbished roller shutter door and all required handover procedures (including the operation and maintenance manuals).

Tenderers should make provision for working at night where the works may interrupt airports operations

The objective is to replace the Roller Shutter Doors to renew the life-span of the selected Roller Shutter Doors to improve their serviceability, operability,

and safety compliance at O.R. Tambo International Airport. The Contractor will ensure that the Replacement is carried out in compliance with the

regulations/ applicable laws over a 12 month period. Any revenue generated from the disposal of the material from replacement process will be paid back

to ACSA.

#### ROLLER SHUTTER DOOR EQUIPMENT/COMPONENT LIST PER ROLLER SHUTTER DOOR

#### A typical electrical roller shutter door comprises:

Roller shutter motor: This is the power unit that drives the door up and down.

Control systems: These are the systems that control the operation of the door. This includes remotes, switches, sensors, timers, and keypads.

Roller shutter curtain: This is the actual door that rolls up and down. It is made up of interlocking slats that are joined together with hinges. The curtain can be made of different materials such as steel, aluminium or PVC.

Guides and tracks: These are the channels that guide the movement of the door as it rolls up and down.

Bottom bars: These are the bars that run along the bottom of the door. They provide additional security and prevent the door from being forced open.

Safety devices: These are devices that ensure the safety of people and property. This includes safety edges, photo cells, and emergency stop buttons.

Locks and latches: These are the mechanisms that keep the door closed and secure. They can be manual or automatic.
