

## **TERMS OF REFERENCE**

### **INVITATION FOR EXPRESSION OF INTEREST TO CREATE A DATABASE OF FINANCIAL INSTITUTIONS FOR A PERIOD OF THREE (3) YEARS IN THE EASTERN CAPE DEPARTMENT OF PUBLIC WORKS & INFRASTRUCTURE**

#### **BACKGROUND**

Due to high level of unskilled labour and unemployment in the Eastern Cape, vast majority of people are venturing in Construction sector and become forced entrepreneurs. A lack of required skills and experience to apply for jobs result in most people opening their own companies.

The Department of Public Works & Infrastructure through Innovation and Empowerment section under the Expanded Public Works Programme drive skills development programme through contractor incubator programme called ICDP (Integrated Contractor Development Programme), Small Medium Micro Enterprise (SMMEs) and Mayibuye Property Incubator Programme (MPIP) to transform the Construction and Property Industries in the Eastern Cape. The section trusts that through the establishment of a database of financers to assist contractors and property developers, the industry can be transformed.

The Innovation and Empowerment section has appointed 160 emerging contractors from grade 1 to grade 6 for a period of 3 years under the ICDP programme and SMME contractors to be developed in their CIDB grading by awarding projects, mentorship, technical skills, soft skills training and providing other support. The section has also appointed 50 new entrants in the Mayibuye Property Industry under the MPIP for a period of 5 years, to be developed in Facilities management, property development, leasing and estate agency.

#### **GOALS AND OBJECTIVES**

The goals and objectives for this project shall focus on creating a database for selected financial institutions for a period of 3 years to provide development finance to SMMEs, Integrated Contractor Development Programme (ICDP) and Mayibuye Property Incubator Programme (MPIP) with Bridging finance.

#### **PROJECT OBJECTIVES**

The department as part of its project goals and objectives, seeks the financial support to achieve the following project deliverables:

- to make sure that Eastern Cape has more reliable contractors, SMMEs, or property developers that will improve the economy of the Eastern Cape Province.
- To advance development finance to ICDP, SMMEs contractors and Property Incubator Contractors in the form of a working capital or expansion finance depending on the needs of the Contractor.
- To accelerate the personal professional development of the contractors.
- To prioritize Women, Youth and Disability with technical abilities e.g. Women, youth and disability that have built environmental qualification



## OTHER BID CONDITIONS

In order to qualify to be in the database, financial institutions must submit the following:

1. An expression of interest for Service providers to be on the database in order to assist contractors with development finance:
  - a. Advancing development finance to the selected ICDP, SMMEs contractors and new entrants in the property sector in the form of a working capital or expansion finance depending on the needs.
  - b. Providing non-financial support in the form of financial literacy training: (Financial management).
  - c. Financial institutions shall give the SMMEs feedback within the maximum of 21 days upon receipt of all necessary documents whether they will fund SMMEs or not.
  - d. The selected financial institutions shall screen all 210 participants within the programmes before being awarded with projects so as to fast track funding application period.
2. Respondents may not register in more than one region. Preferable, respondent must register in the Region they reside. First address in CSD will determine residency of the bidder. This will be looked at during the bid evaluation stage. If a responded omits to select an appropriate region, the Department will after the evaluation of the applications, place the respondents in the region the respondent residing in as per the first address in the CSD
3. If there are no responsive respondents in a region, the department will look for financial institutions in the closest region to where the project will be conducted
4. Vetting will be conducted to the selected financial institutions to ensure that no Public Servant will be selected.

### Financial institutions need to take note of the following:

1. Financial institutions must be registered with National Credit Regulator (NCR)
2. The financial institutions must be registered on the Central Supplier Database (CSD) prior the inclusion in the database.
3. Contractors has a choice to request funding from any financer on the approved database.
3. Contractors have a choice to request funding outside this database if need arise.

**4. Invitation for Expression of interest will be issued every year to allow a new intake into the database: Financial service providers that are already in the database will not be required to resubmit the application form.**

## SCOPE OF WORKS

### a) The Department of Public Works & Infrastructure:

1. Department will appoint contractors (ICDP, SMMEs or MPIP) in the database
2. EPWP will provide a list of financial institutions in the database to ICDP, SMMEs & MPIP contractors who require financial assistance
3. Sign a cession agreement after the awarded contractor and the chosen financial institution by the contractor has signed it.
4. Appoint a Mentor for ICDP, SMMEs or MPIP if need arise.
5. Pay directly to the financial institution, the agreed amount on the cession agreement.

### b) The Contractor will:

1. Receive a list of financial institutions to request development finance.
2. Comply with the financial institution requirements
3. Sign a cession agreement with his/her choice of financial institution.
4. Submit the signed cession to the Department.
5. Submit the signed cession by all parties to the Financial Institution
6. Make sure that the amount on the cession agreement is paid by the client directly to the financial institution



**c) Financial Institution will:**

1. Check viability of the tender awarded to the contractor by the Department.
2. Sign a cession agreement together with the awarded contractor.
3. Offer finance to contractor
4. Submit an invoice for payment to the contractor to include on monthly payment Certificate.
5. Offer non-financial support (Training on finance)



## 5 EVALUATION CRITERIA

Financial service provider's document must meet the following minimum requirements and supporting documents must be submitted with the completed Expression of Interest document in a sealed envelope in the bid box at the closing date and time. Failure to comply will automatically eliminate the application for further consideration.

- 3.6 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
