Important Note: - Bidders to take note that this panel will be utilized on an ad hoc basis (as and when required) throughout the duration of the panel. Submission of plant ownership is compulsory for this bid and this tender may be awarded as a whole or part of the scope of work.

The 80/20 point system will be applicable at project appointment stage in terms of Preferential Procurement Regulations, 2022.

It is the responsibility of the Tenderer to ensure that the Data Base registration documents are received by the Supply Chain Management Office. Definitions

The following terms shall be interpreted as indicated:

- (i) “**Closing time**” means the date and hour specified in the bidding documents for the receipt of bids.
- (ii) “**Contract**” means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- (iii) “**Contract price**” means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- (iv) “**Corrupt practice**” means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- (v) “**Countervailing duties**” are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- (vi) “**Country of origin**” means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- (vii) “**Day**” means calendar day.
- (viii) “**Delivery**” means delivery in compliance of the conditions of the contract or order.
- (ix) “**Delivery ex stock**” means immediate delivery directly from stock actually on hand.
- (x) “**Delivery into consignees store or to his site**” means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- (xi) “**Dumping**” occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- (xii) “**Force majeure**” means an event beyond the control of the supplier and not involving the supplier’s fault or negligence and not foreseeable, events may include, but is not restricted to,

acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

- (xiii) “**Fraudulent practice**” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- (xiv) “**GCC**” means the General Conditions of Contract.
- (xv) “**Goods**” means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- (xvi) “**Manufacture**” means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- (xvii) “**Order**” means an official written order issued for the supply of goods or works or the rendering of a service.
- (xviii) “**Project site,**” where applicable, means the place indicated in bidding documents.
- (xix) “**Municipality or Client**” means the organization purchasing the goods and services.
- (xx) “**Republic**” means the Republic of South Africa.
- (xxi) “**SCC**” means the Special Conditions of Contract.
- (xxii) “**Services**” means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- (xxiii) “**Written**” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.
- (xxiv) “**Certified copy**” means true and accurate representation of original by an authorized person (Not a copy of a certified copy).

2. INSTRUCTIONS AND CONDITIONS OF TENDER

2.1 ELIGIBILITY TO TENDER

2.2 RETURN OF DOCUMENT

The completed and signed set of Tender Documents shall be sealed in an envelope endorsed **“THREE YEAR PANEL FOR HIRE OF YELLOW PLANT AS AND WHEN REQUIRED”** must reach the Municipal Manager, uMlalazi Municipality, by hand and placed in the Tender Box at the SCM offices, KV Challenor road (industrial Area), by no later than 12:00 pm on the date as per advert where they will be opened in public. NB: Late tenders, telegraphic or facsimile tenders will not be considered.

2.3 COMPLETION OF TENDER DOCUMENT

- Tender document must duly completed in very manner
- Forms in this tender document must be completed and signed.
- All pages allocated signing spaces must be signed
- Tenderers will make provision for all machinery, labour, material, equipment and all non-incidentals needed for the execution and completion of the project in accordance with the tender documents.

2.4 AUTHORITY FOR SIGNING

Authority to sign the documents on behalf of the tenderer must be submitted with the tender and remain in force unless replacement submission is made and accepted by the municipality.

2.5 ACCEPTANCE OF TENDERS

- 2.5.1. The Bidder or a competent authorised representative of the Professional Service Provider who submitted the tender has attended the compulsory briefing meeting (if applicable to this tender).
- 2.5.2. The tender offer is signed by a person authorised to sign on behalf of the Bidder.
- 2.5.3. A Bidder who submitted a tender as a Joint Venture if accepted in the bid document, must include an acceptable Joint Venture Agreement in this bid.
- 2.5.4. Acceptance of the tender will not guarantee that the programme, methods and other details will be approved. Municipality may consider reviewing such prior entering into a contract agreement.
- 2.5.5. The Municipality does not bind itself to accept the lowest or any other bid and reserves the right to accept the whole part of the bid.
- 2.5.6. The uMlalazi Municipality will not be held responsible for any cost incurred for submitting this tender.
- 2.5.7. Failure to comply with the foregoing instructions may lead to the tender not being considered.
- 2.5.8. When the bid is accepted, the successful tenderer will be informed and the contract negotiated indicating the financial implications and terms of service will be entered into.
- 2.5.9. **In terms of Section 38 of the Supply Chain Management Policy the Municipality reserves the right to reject any Bid:**

- (i) If any municipal rates and tariffs or municipal service charges owed by that Company owner or any of its directors to the municipality or municipal entity or to any other municipality or municipal entity are in arrears for more than 3 (three) months.
- (ii) Who in last 5 (five) years has failed to perform satisfactory on a previous contract with the municipality or municipal entity or any other organization of state after written notice was given to that Service Provider that performance was unsatisfactory.

2.5.10. Canvassing in gift of Municipality is strictly prohibited and will lead to disqualification of the Proposal.

2.5.11. Registration on the Councils Database shall be mandatory to the successful bidder. This will apply on final award of this tender.

2.7. EVALUATION METHOD

- a) Compulsory returnable documents.
- b) Functionality

2.8.VALIDITY PERIOD

The tender undertakes that bid will be valid for a period of **120 (Hundred and twenty)** days and that the Tenderer will not retract or change the tender during the period that the uMlalazi Municipality is scrutinizing the acceptance thereof.

2.9. COMPETENCE OF KEY PERSONNEL AND QUALITY

- 2.9.1.** To carry out and complete work the Professional Service Provider shall employ only such person as are careful competent and efficient in their various professions. All key personnel presented by the tenderer during bidding stage for evaluation purposes must be maintained or remain unchanged for the duration of the contract “no substitution without municipality’s written approval will be allowed”
- 2.9.2.** Appointed bidder will be required to maintain all quality presented during bidding process which has significantly influenced decision making in awarding of this tender, this shall be part of the service level agreement.

2.10. LOCATION AND GEOGRAPHICAL SIZE OF THE MUNICIPALITY

The administrative center of uMlalazi Local Municipality (KZN284) (Eshowe) is situated along the north eastern coast of Kwa Zulu Natal, 140km north east of Durban. Umlalazi municipality is located within King Cetshwayo District. Geographically, the municipal area covers 2 217km² and consist of 28 electoral wards with dominance of rural wards, and there are 14 tribal authority areas of which AmaKhosi are custodians thereof on behalf of the Ingonyama Trust Board.

2.11. INSPECTION

The successful tenderer must be acquainted with uMlalazi Municipality area. The service provider must make his own arrangements to familiarize themselves with area of work.

2.12. CRITERIA FOR APPOINTMENT FOR SPECIFIC PROJECT/ WORK

- 2.12.1.** Yellow plant will be hired individually to complement municipal owned yellow plant.
- 2.12.2.** Where yellow plant is required to operate as a combo, only service providers who presented full capacity will be invited to submit quotations due to operational purposes.
- 2.12.3.** Where plant is required for short period of time, local service providers on this panel shall take preference.
- 2.12.4.** Appointment will be on competitive bidding of all service providers in the panel through rotation system.

- 2.12.5.** If it is impractical to follow competitive bidding, issuing of works orders will be on rotation basis amongst appointed service providers subject to ability to deliver within specified timeframe as determined by the municipality from time to time.
- 2.12.6.** During the panel period certain returnable documents will be requested as needed to verify validity or compliance.
- 2.12.7.** Additional requirements applicable to tenders estimated from R10 million and above, shall apply (e.g. audited annual financial statement and declaration for bids of R10 million and above)
- 2.12.8.** Project specific functionality will be issued on each project as may be required, e.g. qualifications of plant operators.
- 2.12.9.** Further functionality specific to the nature of work/ project may apply as attributed by project complexity.
- 2.12.10.** The rotation will cut across all services incorporated in the scope of work.
- 2.12.11.** The municipality will generate and issue works order based on **the accepted quotation submitted by the service provider.**
- 2.12.12.** Amount of work to be given to the appointed service providers will be determined by the municipality based on the need for each occasion.
- 2.12.13.** The municipality does not bind itself to ward work or projects to service providers appointed in this panel.
- 2.12.14.** The municipality will raise works orders as and when required during period of this contract.
- 2.12.15.** The works order will indicate type of work, quantity and amount of work to be provided by the appointed Service provider.

2.13. PRICING INSTRUCTIONS/CONDITIONS FOR PROJECTS/WORK

- 2.13.1.** Pricing is not applicable at this stage, however bidders to note that each request for quotation will include pricing instruction and conditions based on the nature, amount of work and duration of the required service.
- 2.13.2.** Work will be quoted on wet rate

2.14. PAYMENT INSTRUCTIONS:-

- 2.14.1.** No payment will be made if such work beyond the ambit of the awarded project **price**, all variation orders must be approved in writing by a person authorized to do so.
- 2.14.2.** No payment will be made if hour meter readings are not provided, or completed municipality time sheet with insufficient information.
- 2.14.3.** Payment will be made by the municipality to the Service Provider upon delivery of service, which payment will be made via electronic transfer of funds to the Contractor's financial institution subject receipt of a valid tax invoice accompanied with relevant supporting documents such as signed job cards, time sheets etc.
- 2.14.4.** Valid tax invoice must be submitted on the last day of each month and payment shall be made in 30 days after date of invoice.
- 2.14.5.** The Service Provider is obliged to submit the invoice together with a signed job card or municipal time sheet (whichever is applicable) and job card/time sheet must be properly filled and reflect worked hours / quantity of work done, site name etc. Failing which no work shall be certified for payment.
- 2.14.6.** The Municipality reserves the right to negotiate a reasonable price with successful bidder during projects ward stage.
- 2.14.7.** In the event of the entire amount or a portion of the invoice being disputed by the Municipality, only that portion in dispute shall be withheld from payment, until the dispute is resolved. The undisputed portion shall be paid to the Service Provider within the stipulated time frames.
- 2.14.8.** The Service Provider shall immediately give notice of any circumstances preventing execution of work from completing its obligations in terms of the contract.

2.15. PENALTIES

- 2.15.1.** If within the period(s) specified in the contract, the Municipality shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, an amount of **R500 per calendar day** of the delay until actual delivery or performance. The Municipality may also consider applying termination clause of the contract should non-compliance with delivery timeframes constitutes gross breach of this contract.
- 2.15.2.** Failure to deliver the goods or service within the period(s) specified in the contract is as a result of an event of force majeure, the service provider must report in writing with

evidence required and Municipality shall assess the submission on its discretion.

- 2.15.3.** Notwithstanding the provisions of **penalties and termination clauses** , the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure

2.16. OTHER GENERAL TERMS AND CONDITIONS OF THIS BID

- 2.16.1.** Awarding of contract will be subject to the Service Provider's acceptance of offer in writing.
- 2.16.2.** Project personnel requirements will be confirmed during project initiation and shall remain unchanged for the duration of the project, unless prior written consent has been granted by the Municipality.
- 2.16.3.** All secretarial services such as arranging meetings, setting of agenda's and minute taking shall be the responsibility of the Service Provider.
- 2.16.4.** No material or information derived from the provision of the services under the contract may be used for any other purposes except for those of the uMlalazi Local Municipality except where duly authorized to do so in writing by the uMlalazi Local Municipality.
- 2.16.5.** The successful Service Provider agrees to keep all records and information of, or related to the project confidential and not discloses such records or information to any third party without the prior written consent of uMlalazi Local Municipality.

2.17. AMENDMENTS UPWARD OF TENDERED PRICE

- 2.17.1.** Tenders must further note and accept that any variance upward of the prices tendered will not be considered by Municipality as a reason to amend the said tendered price.
- 2.17.2.** Any attempts to invoke an increase in tendered price will render the tender invalid and it will be discarded.

2.18. COST OF TENDER

The Municipality does not hold itself liable for any or all of the costs involved by the tender in compiling a tender. Should a tender withdraw an offer after being given written acceptance thereof all costs of re-advertising will be for that tenderer's account.

2.19. ALTERNATIVE

Should a tenderer wish to submit an alternative, he may do so subject to the tender being submitted additional to and based on the specifications as listed in the tender document. Any letter or documents describing such alternative must be in duplicate.

2.20. MANDATORY OBJECTION PERIOD

All administrative actions and decisions taken by the Municipality through its officials may become subject to an appeal process. As such, in terms of Section 62 of the Municipal Systems Act 32 of 2000, a period of fourteen (14) days will be set aside to allow for the submission of appeals against the award / process of making the award to a particular bidder by any interested party. Except in scenarios where the decision of a duly appointed appeal panel sets aside the appointment of the successful bidder as the service provider for this contract, the appointment will then be confirmed by the municipality in writing.

2.21. CONTRACT AGREEMENT/SERVICE LEVEL AGREEMENT

- a) The successful Service Provider shall sign a Service Level Agreement/ Contract with the Municipality.
- b) Project specific contract will be signed once a project is awarded.

3. SPECIFICATIONS AND SCOPE OF WORK

3.1. BACKGROUND

Due to limited municipal owned yellow plant, uMlalzi Municipality is experiencing a huge backlog on provision of proper roads maintenance of unpaved roads, mostly located in rural areas. Therefore, supplementary yellow plant is required on agent or emergency situations to provide this service.

3.2. The contract period shall be thirty six (36) months, read together with the other relevant clauses in the service level agreement.

3.3. SCOPE OF WORK

The scope of work includes the following individual Yellow Plant; read together with other conditions of this tender

- i) Motor Graders
- ii) Minimum 10m³ tipper trucks
- iii) D20 Dozers (minimum)
- iv) 4x4 Tractor loader backhoe (TLB)
- v) Excavators (20 ton minimum)
- vi) Vibrator Rollers (12 to Minimum)
- vii) Water tankers (10 000L Minimum)

3.4. PLANT TECHNICAL SPECIFICATIONS

3.4.1. MOTOR GRADERS SPECIFICATION

- i) The motor grader must not be older than 12 years from date of first registration.
- ii) Hour meter must be functional at all times to measure time worked (**no payment will be made if hour meter readings are not provided**)
- iii) Motor Grader to be fitted with rippers
- iv) Engine output ranges between 123 kw – 138 kw
- v) Blade width not less than 4m wide.
- vi) Operating weight not less than 15 000 kg

3.4.2. TIPPER TRUCK

- i) Tipper truck must not be older than 15 years from date of first registration.
- ii) Hour meter must be functional at all times to measure time worked (**no payment will be made if mileage readings are not provided**)
- iii) Minimum 10m³ double diff.
- iv) Plant must road worthy

3.4.3. DOZER SPECIFICATION OR EQUIVALENT

- i) The dozer must not be older than 20 years from date of first registration.
- ii) Hour meter must be functional at all times to measures time worked (**no payment will be made if hour meter readings are not provided**)
- iii) Base weight (incl. ripper) 20 252 kg, Blade weight Semi –U 1326 kg
- iv) Gross Power: 143 KW SAE @ 1,800 rpm
- v) Net Power: 152 KW SAE @ 1,800 rpm
- vi) Cylinders: 6
- vii) Blade Type: Outside dozer Semi –U
- viii) Must be fitted with rippers

3.5.4. 4X4 TRACTOR LOADER BACKHOE (TLB) SPECIFICATION

- i) Tractor loader backhoe (TLB) must not be older than 12 years from date of first registration.
- ii) Hour meter must be functional at all times to measures time worked (**no payment will be made if hour meter readings are not provided**)
- iii) Plant must be road worth

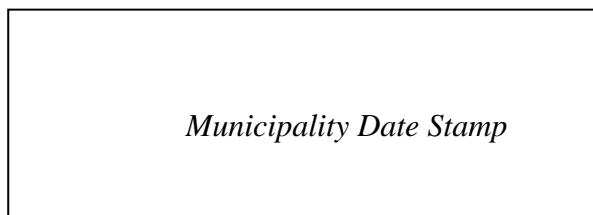

And whereas the parties hereto are desirous of reducing the terms and conditions of agreement between them to writing.

Now therefore the parties hereto agree as follows:-

1. PERIOD OF AGREEMENT

The appointment of the Service Provider is for the period of **thirty six (36)** months, the contract shall commence from **xx November 2025**.

1.1 Completion.

Unless terminated under one of the other clauses, the appointment shall be completed at the expiry of the contract period which is **xx November 2028**.

2. PURPOSE OF THIS CONTRACT

UMlalazi Municipality seek to appoint a panel of service providers to be used as and when required subject to availability of budget. Due to limited municipal owned yellow plant, uMlalzi Municipality is experiencing a huge backlog on provision of proper roads maintenance of unpaved roads, mostly located in rural areas. Therefore, supplementary yellow plant is required on agent or emergency situations to provide this service.

3. SPECIFICATIONS AND SCOPE OF WORK

The scope of work includes the following individual yellow Plant; read together with other conditions of this tender.

- i) Motor Graders

- ii) 10m³ tipper trucks
- iii) Dozer

- ii) The other yellow plant shall work from **07h00 to 16h: 00, 8.5 hours** per day for number of days determined by the municipality on each case.
- iii) The stipulated working hours includes half hour lunch time.
- iv) Standing time claim will be subjected to conditions stated on each invitation to submit quotations.
- v) The services provider shall be obliged to work on the weekends if there is an emergency or urgent work to be attended, irrespective of pay weekend or similar nature.
- vi) Hour meter or mileage reading for all plant must be functionally at all times to measures time worked.
- vii) The plant (Grader, TLB and trucks) may be compelled to make long travels without a low-bed due to fragmentation of wards from one to another and emergencies/ urgent work to be attended.
- viii) Where plant is transported by municipal low-bed truck as agreed in writing between the parties, municipality accept no liability for any damages that may occur.
- ix) Plant shall be supervised by municipality if no provision made for supervision in the request for quotation.
- x) Company to comply with Health and Safety Regulations in terms of OHS act.
- xi) Wet rate per hour Inclusive of VAT to be quoted. NB: Fuel shall be filled up on site (not on fuel stations).
- xii) To provide accommodation for operators within the work area.

3.9. AREA OF WORK

6.7. DUTIES OR OBLIGATIONS OF SERVICE PROVIDER

- i) To supply hired plant to maintain gravel or unpaved roads or alike within the uMlalazi Municipality jurisdiction as per requirements of this tender as determined for specific work or task.
- ii) Provide, perform and complete the services in a proper, efficient and prompt manner and in accordance with the project specifications and contract requirement in terms of this agreement.
- iii) Ensure that the fuel is supplied on site promptly (no delays due to fuel shortage will be accepted).
- iv) Ensure that if there is a break downs, plant is fixed with within three days, failing which, back up plant must be provided.
- v) Ensure Municipal time sheet is filled in (completed) properly and signed by the ward Cllr and Municipal Supervisor every afternoon.
- vi) To returned municipality's time sheet to the Supervisor every the last day of the month, no payment will made is timesheet is not completed properly, not signed by responsible municipality official or if the information provided is not clear, inadequate of insufficient.
- vii) The time sheet must kept on site with operator every time for inspection purposes.
- viii) To keep time sheet clean and tidy as a crucial supporting document for payments
- ix) To maintain all quality presented during bidding process which has significantly influenced decision making in awarding of this tender which shall form part of annexures on the contract agreement.
- x) To ensure that tax matters are in order for duration of the contract.
- xi) Must be in good standing central supplier data base for the duration of the contract.
- xii) The service provider to provide achievable response time and be available 24 hours to attend to emergencies.
- xiii) RESPONSE TIME: Respond within **five (5) days** from time of request.
- xiv) To adhere to response time frames as specified in the request for quotation document.
- xv) To deliver quality service in line with specifications.
- xvi) No work to be performed without an official purchase order or written instruction from Municipality.
- xvii) All documentation such as Invoices, relating to the services provided must be forwarded at latest within first **seven (7) calendar days** of the month or from time of service completion to the Civil Section.

6.8. EXPERTISE/ STAFF

- i) Service provider to use experienced and trained operators for specific plant (holding training certificated form accredited provider).
- ii) Expertise must be maintained for the duration of the contract.
- iii) Experience of the key staff (assigned personnel) in relation to the scope of work shall reflect the following:
 - a) General experience (total duration of professional activity), level of education and training and positions held of each key staff member/expert member;
 - b) The education, training and experience of the key staff member/experts in the specific plant, field. The key staff members'/experts' knowledge of issues which the tenderer considers pertinent to the assignment eg. Plant operators skills and experience.
 - c) The CV should be structured under the following headings:
 - Personal Particulars
 - Name of institutions for tertiary education and dates associated therewith;
 - Qualifications (e.g. diploma; degrees etc., grades of membership of professional societies and professional registrations);
 - Name of current employer and position in enterprise;
 - Overview of experience (year, organization and position); and outline of recent assignments / experience that has a bearing on the scope of work.

6.9. MONITORING, REPORTING REQUIREMENTS AND PERFORMANCE MANAGEMENT

- i) This contract will be monitored on time based and performance.
- ii) **Format of communication** - All requests for formal approval from the Employer, or any other body, shall be submitted in writing in hardcopy format. Interim payment claims shall be submitted in the same format, accompanied by an original tax invoice. Ad-hoc communication between the Employer and the Service Provider may be conducted per facsimile or in electronic format (e-mail). All plans and contract documents submitted for approval shall be in hardcopy format.

6.10. MEETINGS

- (i) To be able to manage the contract, the service provider will be required to attend meetings as and when required by municipality. The attendees shall have the necessary delegated authority to make decisions in respect of matters discussed at such meetings.
- (ii) Regular meetings of a general nature may be convened and chaired by the responsible municipal official.
- (iii) All meetings shall be recorded using minutes or a register prepared and circulated by the person who convened the meeting. Such minutes or register shall not be used for the purpose of confirming actions or instructions under the contract.

5. RESPONSIBILITIES AND OBLIGATIONS OF THE CLIENT

- 5.1. Pay the Contractor in accordance with the service performed;
- 5.2. Provide the Contractor with clear specifications and scope of work to enable the Contractor to quote and carry out the required services;

6. CRITERIA FOR APPOINTMENT FOR SPECIFIC PROJECT/ work

- 6.1. Yellow plant will be hired individually to complement municipal owned yellow plant.
- 6.2. Where yellow plant is required to operate as a combo, only service provider presented full capacity will be invited to submit quotations for operational purposes.
- 6.3. Where plant is required for short period of time, local service providers on this panel shall take preference.
- 6.4. Appointment will be on competitive bidding of all service providers in the panel through rotation system.
- 6.5. If it is impractical to follow competitive bidding, issuing of works orders will be on rotation basis amongst appointed service providers subject to ability to deliver within specified timeframe as determined by the municipality from time to time.
- 6.6. During the panel period certain returnable documents will be requested as needed to verify validity or compliance.
- 6.7. Additional requirements applicable to tenders estimated from 10 million and above, shall apply (e.g. audited annual financial statement and declaration of bids of 10 million and above)
- 6.8. Project specific functionality will be issued on each project as may be required, e.g. qualifications of plant operators.
- 6.9. Further functionality specific to the nature of work/ project may apply as attributed by project complexity.
- 6.10. The rotation will cut across all services incorporated in the scope of work.
- 6.11. The municipality will generate and issue works order based on **the accepted quotation submitted by the service provider.**
- 6.12. Amount of work to be given to the appointed service providers will be determined by the municipality based on the need for each occasion.
- 6.13. The municipality does not bind itself to ward work or projects to service providers appointed in this panel.
- 6.14. The municipality will raise works orders as and when required during period of this contract.
- 6.15. The works order will indicate type of work, quantity and amount of work to be provided by the appointed Service provider.

7. PRICING INSTRUCTIONS/CONDITIONS FOR PROJECTS/ WORK

- 7.1. Pricing is not applicable at this stage, however bidders to note that each request for quotation will include pricing instruction and conditions based on the nature, amount of work and duration of the required service.

7.2. Work will be quoted on wet rate

8. PAYMENT

- 8.1.1. No payment will be made if such work beyond the ambit of the awarded project **price**, all variation orders must be approved in writing by a person authorized to do so.
- 8.1.2. No payment will be made if hour meter readings are not provided, or completed municipality time sheet with sufficient information.
- 8.1.3. Payment will be made by the municipality to the Service Provider upon delivery of service, which payment will be made via electronic transfer of funds to the Contractor's financial institution subject receipt of a valid tax invoice accompanied with relevant supporting documents such as signed job cards, time sheets etc.
- 8.1.4. Valid tax invoice must be submitted on the last day of each month and payment shall be made in 30 days after date of invoice.
- 8.1.5. The Service Provider is obliged to submit the invoice together with a signed job card or municipal time sheet (whichever is applicable) and job card/time sheet must be properly filled and reflect worked hours / quantity of work done, site name etc. Failing which no work shall be certified for payment.
- 8.1.6. The Municipality reserves the right to negotiate a reasonable price with successful bidder during projects ward stage.
- 8.1.7. In the event of the entire amount or a portion of the invoice being disputed by the Municipality, only that portion in dispute shall be withheld from payment, until the dispute is resolved. The undisputed portion shall be paid to the Service Provider within the stipulated time frames.

9. INSPECTION

- 9.1. The successful tenderer must be acquainted with uMlalazi Municipality area. The service provider must make his own arrangements to familiarize themselves with area of work.

10. COMPETENCE OF KEY PERSONNEL AND QUALITY

- 10.1. The Service Provider must ensure that services are performed by the key personnel nominated in the Contract or who have been substituted for one or more of such nominated personnel with the written consent of the Municipality.
- 10.2. If any of the nominated key personnel are not available to perform any of the Services, or unable properly to do so because of physical or mental incapacity or incompetence, the

Service Provider must immediately give notice to the municipality and arrange a replacement of that person with a person acceptable to the municipality, at no additional cost to the Municipality.

- 10.3. Appointed bidder will be required to maintain all quality presented during bidding process which has significantly influenced decision making in awarding of this tender, this shall be part of the service level agreement.

11. PROJECT MANAGER

- 11.1. There shall be a Project Manager appointed by the municipality who shall administer the Contract and oversee the work of the Service Provider in its performance of the Services.
- 11.2. The Project Manager mentioned above shall be the Senior Manager Engineering Services unless a person is appointed officially to act on his/her behalf.
- 11.3. The Service Provider shall submit nominated project manager to administer this contract.
- 11.4. The Service provider must liaise with, report to and communicate with the Project Manager on all technical matters relating to this Contract.

12. BACK UP SERVICE

In case of break down or any other similar situation that maybe applicable, back up plan shall be provided by the Service Provider within **24 hours** when required, failing which the municipality may apply the penalty Clause 16 of this contract and continuous breakdowns may lead to termination of this contract.

13. INDEMNITY

The Service Provider acknowledges hereby in favor of the uMlalazi Council, that this agreement is signed by both parties on the basis that the Service Provider is an independent Contractor.

The Service Provider accordingly hereby indemnifies the uMlalazi Municipality and it's officials in respect of all personal accidents, damages, loss (inclusive of theft) and any other actions, claims, legal actions of whatever nature, instituted or threatened to be instituted by whomsoever which actions etcetera are a direct result of the Contractor's or his/her substitutes conduct in terms of this agreement.

14. CONTRACT MONITORING AND EVALUATION

14.1. Monthly Reporting

This Contracts will be monitored on time based or performance based. The Municipality reserves the right to introduce or put in place additional performance measures as and when required subject to the agreement of both parties.

14.2. Poor performance

- (i) The Municipality may, in the event of unsatisfactory performance or conflict of interest at any time by prior written notice to the Service provider, suspend the carrying out of the Services or any part thereof for **03 (three)** days in order to afford the Service provider the opportunity to rectify the cause for the unsatisfactory performance or conflict of interest. In the event that the Service provider fails to remedy the situations as envisaged herein, then the provisions of the terms below shall apply, until such time as the Municipality may determine.
- (ii) Subject to the next paragraph, if amount have not been agreed in advance, the Municipality must pay to the Service provider the fees and the amount reasonably incurred by the Service provider in carrying out the Services to the date of suspension. The Municipality shall not be liable to compensate for any loss of profits or any other loss.

15. PENALTY

- 15.1. If within the period(s) specified in the contract, the Municipality shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, an amount of **R 500 per** calendar day of the delay until actual delivery or performance. The Municipality may also consider applying termination clause of the contract should non-compliance with delivery timeframes constitutes gross breach of this contract.
- 15.2. Failure to deliver the goods or service within the period(s) specified in the contract is the result of an event of force majeure, the service provider must report in writing with evidence required and Municipality shall assess the submission on its discretion.
- 15.3. Notwithstanding the provisions of Clauses “Penalties” and “Termination”, the Service Provider shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

16. CANCELLATION

The municipality reserves the right to cancel this agreement by way of three (3) months written Notice, in cases where:-

- 16.1.** Budget becomes unavailable to continue rendering the service.
- 16.2.** The municipality review its service delivery strategies and mechanisms.
- 16.3.** It became financial strenuous for the municipality to continue rendering the service.

17. TERMINATION

17.1. Termination due to Default by Service Provider

- 17.1.1. If the Service provider commits a breach of Contract, the Municipality may suspend payment under the Contract and give to the Service provider a written notice to rectify.
- 17.1.2. A notice to rectify must:
 - 17.1.2.1. State that it is as notice given under this sub-clause of these Conditions;
 - 17.1.2.2. Specify the alleged breach in detail;
 - 17.1.2.3. Specify the date by which the Service provider must respond to this notice which date shall **not be less than 7 (seven) days** after the date of the notice, and, if, by the time specified in the notice to rectify, the Service provider fails to propose steps to remedy the breach that are satisfactory to the Municipality or fails to actually remedy the breach to the satisfaction of the Municipality, the Municipality may, by further written notice, terminate the contract and claim any other remedies that are available to the Municipality in law;

17.2. Termination on Notice

- 17.2.1. The Municipality may terminate the Contract at any time by giving the Service provider at least 30 (thirty) days prior written notice.
- 17.2.2. The period of this notice shall run from the date upon which the notice is received by the Service Provider
- 17.2.3. If the Contract is terminated pursuant to this sub-clause, the Municipality must pay to the Service provider the fees and the expenses reasonably incurred by the Service provider in Carrying out the Consultancy Services to the date of termination together.
- 17.2.4. The Municipality shall not be liable for payment to the Service provider for any amount in excess of the amount due and payable for the services already provided by the Service provider and, specifically, no compensation for loss of profits or any other loss shall be payable by the Municipality .

17.3. Termination on Default by Municipality

- 17.3.1. Should the Municipality fail to perform its obligations of payment in terms of this agreement, the Service provider may, on written notice, require the Municipality to pay sixty (60) days of the date of the receipt of the notice.
- 17.3.2. Should the Municipality fail to pay in that time, the Service provider may terminate this agreement.

17.4. Effect of Termination

- 17.4.1. In the event that the Service provider is a joint venture or a consortium upon termination of this Contract, the Service provider might at the discretion of the Municipality be held

liable jointly and severally for whatever expenses or damages the Municipality should be entitled to claim in law and/or in terms of this agreement.

17.4.2. On the date of termination, the rights and obligations of the Parties described in this contract shall cease.

17.4.3. The Service provider will be obliged to hand back all the records and Contract Material that it made use of, or was otherwise in possession and control of, throughout the duration of this Contract and vacate site immediately.

18. DISPUTE RESOLUTION

18.1. If any dispute or difference of any kind whatsoever arises between the Council and the Service Provider in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

18.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Council or the Service Provider may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

18.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.

2. The SERVICE PROVIDER undertakes to fully comply with all relevant duties, obligations and prohibitions imposed in terms of the ACT and Regulations: Provided that should the EMPLOYER have prescribed certain arrangements and procedures that same shall be observed and adhered to by the SERVICE PROVIDER, his officials and employees. The SERVICE PROVIDER shall bear the onus of acquainting himself/herself/itself with such arrangements and procedures.

The SERVICE PROVIDER hereby accepts sole liability for such due compliance with the relevant duties, obligations, prohibitions, arrangements and procedures, if any, imposed by the ACT and Regulations, and the SERVICE PROVIDER expressly absolves the EMPLOYER and the Employer's CONSULTING ENGINEERS from being obliged to comply with any of the aforesaid duties, obligations, prohibitions, arrangements and procedures in respect of the work included in the contract, and I further undertake to ensure that any subcontractors employed by me will enter into an Occupational Health and Safety Agreement separately, and that such subcontractors comply with the conditions set.
4. The SERVICE PROVIDER agrees that any duly authorized officials of the EMPLOYER shall be entitled, although not obliged, to take such steps as may be necessary to ensure that the SERVICE PROVIDER has complied with his undertakings as more fully set out in paragraphs 1 and 2 above, which steps may include, but shall not be limited to, the right to inspect any appropriate site or premises occupied by the SERVICE PROVIDER, or to take such steps it may deem necessary to remedy the default of the SERVICE PROVIDER at the cost of the SERVICE PROVIDER.
5. The SERVICE PROVIDER shall be obliged to report forthwith to the EMPLOYER any investigation, complaint or criminal charge which may arise as a consequence of the provisions of the ACT and Regulations, pursuant to work performed in terms of this agreement, and shall, on written demand, provide full details in writing of such investigation, complaint or criminal charge.

Occupational Health and Safety Conditions

1. The Chief Executive Officer of the Contractor shall assume the responsibility in terms of Section 16(1) of the Occupational Health and Safety Act (as amended). Should the Contractor assign any duty in terms of Section 16(2), a copy of such assignment shall immediately be provided to the representative of the Employer as defined in the Contract.
2. All work performed on the Employer's premises shall be performed under the supervision of the construction supervisor who understand the hazards associated with any work that the Contractor performs on the site in terms of Construction Regulations 2014.
3. The Contractor shall appoint a Competent Person who shall be trained on any occupational health and safety aspect pertaining to them or to the work that is to be performed.
4. The Contractor shall ensure that he familiarises himself with the requirements of the Occupational Health and Safety Act and that he/she, his/her employees, and any sub-contractors, comply with them.
5. Discipline in the interests of occupational health and safety shall be strictly enforced.

6. Personal protective equipment shall be issued by the Contractor as required and shall be worn at all times where necessary.
7. Written safe work procedures and appropriate precautionary measures shall be available and enforced, and all employees shall be made conversant with the contents of these practices.
8. No substandard equipment/machinery/articles or substances shall be used on the site.
9. All incidents referred to in terms of Section 24 of the Occupational Health and Safety Act shall be reported by the Contractor to the Department of Labour and the Employer.
10. The Employer hereby obtains an interest in the issue of any formal inquiry conducted in terms of Section 32 of the Occupational Health and Safety Act and into any incident involving a Contractor and/or his/her employees and/or his/her sub-contractor/s.
11. No use shall be made of any of the Employer's machinery/plant/equipment/ substance/ personal protective equipment or any other article without prior arrangement and written approval.
12. No alcohol or any other intoxicating substance shall be allowed on the site. Any person suspected of being under the influence of alcohol or any other intoxicating substance shall not be permitted access to or allowed to remain on the site.
13. Prior to commencement of any work, verified copies of all documents mentioned in the agreement, must be presented to the Employer.
