4. SCOPE OF WORK

The provision of drone-based security surveillance at Eskom's Transmission Substations in Gauteng.

The service will include:

- Night operations around the vicinity of various Eskom Transmission substations.
- Nighttime patrolling of specified areas near and around the substation up to a 2 km radius.
- The carrying out of patrols along a predefined flight path as well as randomly, depending on the suspicious activity that may be detected while on site.
- Detection of suspicious movements or behavior of people or vehicles in the surveillance area, without being noticed.
- To provide support to armed or non-armed security response teams. This will entail directing
 the teams to safely effect arrests and/or recovery of Eskom assets.
- Special events monitoring such as strikes or crowd management.
- Any other request pertaining to security needs where the aerial advantage will assist in or remove the danger to human personnel.
- Provide a video feed output that can be relayed to other nearby teams or security control rooms.

- Provision of a suitable vehicle that is equipped with a large size video display monitor so that
 the surveillance video feed from the drone may be viewed by other staff members forming
 part of the security operation at the time.
- To provide assistance to law enforcement as part of response activities or any investigations that may result from the surveillance operation.

All work will be done in accordance with Eskom's plant procedures and safety regulations.

All service provider's staff will need to undergo Transmission Division induction before commencement of any work on site.

Specification of Product or Goods

- The service provider must have a valid RPAS Operators Certificate (ROC) license.
- The service providers Operations Specification (Ops Spec) must be approved for operations at National Key Points and Strategic Installations, over road infrastructure, over crowds of people and controlled or restricted airspaces.
- The service providers Ops Spec must be approved for V-LOS and BV-LOS operations up to at least 15 km.
- One primary Pilot will be required to fly the drone (i.e. Pilot in Command) and one secondary staff will be required to assist with Spotting, driving, to assist with the aircraft setup or to act as a relief Pilot. Both staff will need to undergo the Eskom Induction and initial mission briefings.
- The drone must have a night vision (i.e. thermal) camera that can zoom-in on suspicious activities from higher than the sound envelope of the aircraft. In other words, the camera should be able to zoom in on suspects from a height where it cannot be heard from the ground.
- Should the primary drone and/or camera not be available for the operation, the supplier should have at least one registered back-up drone and one thermal camera available.
- Drone should be able to fly using preprogrammed waypoints around the sites as well as manually when required.
- All footage (video and or photographs) from each flight will be downloaded and provided to Eskom on a portable drive.
