## SPECIFICATIONS FOR SOFTWARE

The requirements outlined focus on the integration of CAD (Computer-Aided Design) and GIS (Geographical Information Systems) technologies, particularly in the context of managing infrastructure features like manholes, valves, and pipes. Below is a detailed analysis of the key functionalities and considerations necessary for such a system.

### Integration of CAD and GIS

1. **Detailed Mapping:** System should be able to capture, digitise and convert analogue as-builts drawing (water and sewer pipes, valves, hydrants, manholes, and other key assets), digital data (GPS, DWG's, kmz/l, shapefiles) into GIS data models. Accurately locate and attribute each asset with details like material, diameter, depth, and installation date
2. **Linking Models and GIS Cadastre:** The system must create and maintain links between models' manholes and the GIS Cadastre. This ensures that spatial data is accurately represented and updated, reducing discrepancies between design data and actual conditions.
3. **Updating Appurtenant Information:** The ability to update details related to valves, hydrants, and stand connections in the GIS environment. This includes maintaining accurate records that can be easily accessed and modified as needed.
4. **Infrastructure Feature Support:** The system must cater to a wide range of infrastructure features, including pumps, gravity pipes, valves, chambers, diversion structures, and manholes etc. This versatility is essential for comprehensive infrastructure management.

### Data Processing and Workflow

4. **Efficient Data Handling:** A CAD and GIS platform should be designed for fast processing of large datasets, utilizing sophisticated database techniques to allow for seamless editing similar to working with a spreadsheet. This enhances user experience and efficiency.
5. **Exposing CAD/GIS Functions:** The system must expose all functionalities of the CAD/GIS engine to power users, enabling quick processing of extensive model datasets and automated error detection in GIS features, such as identifying duplicate lines or misclosures.
6. **Transition from CAD to GIS:** The transition between CAD and GIS should be fluid, supporting the workflow of engineering projects. This involves ensuring that updates in CAD are instantly reflected in GIS and vice versa, facilitating efficient project management.

### Compatibility and Data Integration

7. **GIS Dataset Compatibility:** The GIS environment must be compatible with ESRI Shapefiles and support detailed CAD background drawings in AutoCAD DWG format. This compatibility is vital for integrating various data sources and maintaining accurate spatial representations.
8. **Loading Digital Terrain Models:** The tool should support the loading of large Digital Terrain Model (DTM) point files, which are essential for building 3D meshes for rendering contours or interpolating elevations of model elements like manhole levels.
9. **Geo-located Aerial Photography:** The ability to accurately underlay geo-located aerial photography images in formats like JPG, TIFF, and BMP is necessary for tracing against or

informing vector layers. Full compatibility for import/export of GIS, CAD, or DTM file formats must be guaranteed, even if proprietary formats are used.

#### **User Interaction and Query Capabilities**

10. **User-Friendly SQL Query Builder:** A SQL query builder that operates across multiple layers and databases is essential. This feature should allow users to build relational database views and perform complex queries on the data, ensuring robust data integration with various SQL database formats.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;



- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Municipal Bidding Document (MBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
