## **DETAILED SPECIFICATION**

### **REQUEST FOR QUOTATION (RFQ) HANDYMAN SERVICES ON AN AS-AND-WHEN REQUIRED BASIS FOR THE PORTS REGULATOR OF SOUTH AFRICA FOR A PERIOD OF THREE (3) YEARS.**

#### **1. BACKGROUND**

1.1 Ports Regulator of South Africa (PRSA) is a Schedule 3A public entity in terms of the Public Finance Management Act, 1 of 1999 (PFMA). Port Regulator South Africa must fully comply with all the requirements of the PFMA.

1.2 The Ports Regulator is the independent National Regulator for the South African ports, governed by the National Ports Act, 2005 (Act No. 12 of 2005).

In terms of section 30 (1) and (2) of the National Ports Act, the main function of the Regulator is to:

- Exercise economic regulation for the ports system in line with government's strategic objectives.
- Promote equity of access of ports and facilities and service provider by ports.
- Monitor the activities of the National Ports Authority to ensure that it performs its functions in accordance with the act; and
- Hear appeals and complaints contemplated in terms of Section 48 of the Act.

#### **2. PURPOSE**

2.1 This Request for Quotation (RFQ) invites qualified service providers to submit quotations for the provision of handyman services for a period of three (3) years. PRSA requires the services of qualified and experienced handyman service providers to perform general maintenance, repairs, and related services on an as-and-when-required basis.

#### **3. SCOPE OF WORK**

##### **3.1 General Services Required**

The successful bidder(s) will be required to provide the following handyman services on an as-and-when-required basis:

##### **3.2 Carpentry Work:**

- Repair and installation of doors, windows, and frames.
- Repair and installation of shelving, cupboards, and cabinets.
- Replacement of locks and handles.
- Repair of furniture and wooden fixtures.

##### **3.3 Plumbing Services:**

- Repair of leaking taps, pipes, and cisterns.
- Replacement of washers and fittings.
- Minor installation work.

#### **3.4.1 Electrical Work (Minor):**

- Replacement of light bulbs, tubes, and ballasts.
- Repair of light fittings and switches.
- Testing and replacement of plugs and sockets.
- Minor repairs to electrical appliances (Note: Must be performed by certified electricians).

#### **3.5 Painting and Decorating:**

- Touch-up painting of walls, ceilings, and doors
- Painting of office areas and common spaces
- Preparation of surfaces for painting

#### **3.6 General Maintenance:**

- Repair and replacement of ceiling tiles
- Repair of walls and plastering
- Installation and repair of blinds and curtains
- Assembly of furniture and equipment
- General building maintenance and repairs
- Replacement of door closers and hinges
- Repair and maintenance of notice boards

#### **3.7 Other Services:**

- Emergency call-out services
- Any other minor maintenance work as required by PRSA

#### **3.8 Response Time**

- Routine work: Within 48 hours of request
- Urgent work: Within 24 hours of request
- Emergency work: Within 4 hours of request

### **4 EVALUATION CRITERIA**

#### **4.1 SCM Administrative (Phase 1):**

- 4.4.1 The service provider must submit proof of registration on CSD (Central Supplier Database).
- 4.4.2 The SBD 4 form must be completed, signed by the authorised company representative.
- 4.4.3 The SBD 6.1 must be completed and signed by the authorised company representative.
- 4.4.4 Valid and original Tax Clearance Certificate/Valid Tax Pin Number
- 4.4.5 The POPIA consent form must be completed and signed by the authorised company representative.
- 4.4.6 Valid SANAS Accredited B-BBEE Certificate/ Sworn Affidavit – if no certificate is submitted or certificate is not valid, no points will be allocated for B-BBEE

#### **4.5 Mandatory Requirements (Phase 2):**

- 4.5.1 The service provider must provide 3 reference letters issued by the Bidders' previous client for similar work completed on the referees Company's Letterhead. The letters should have contactable references.

5.4.4 Specific goal: At least 51% or more Black women owned business. Weighs **10 Points**.
