BACKGROUND and SCOPE OF WORK:

Umgeni water requires a contractor for the supply & delivery of sand and stones to various sites.

Client's / employer's objectives

Umgeni Water is requiring services for the supply and delivery of various construction/building sands and stones to various sites of Umgeni Water within the inland region/UMgungundlovu District area of Supply.

1. Description of the services

The scope involves the supply and delivery of

- Bedding River Sand/Umgeni Sand
- Building Sand for brick laying and plastering
- G5 Gravel material
- Concrete aggregate/19 mm stone
- Crusher Sand
- Dolerite Gabion Rock fill
- Dump Rock

2. Extent of the services

- Delivery to the various site travel cost based on a rate per kilometer using 6 m³, 10 m³ and 20 m³ trucks
- Supply quantities and delivery on as and when required basis as per call-off by the civil foreman

3. Technical Specifications

Bedding Sand

- Granular bedding cradle and backfilling sand is required. The bedding and backfilling (blanket) sand must meet the following specification:

1.	9.5 mm	100
2.	6.7 mm	90 - 100
3.	4.75 mm	80 - 90
4.	2.36 mm	65 - 80
5.	1.18 mm	50 - 65
6.	0.600 mm	35 - 50

Building Sand

- Sand shall either comply with all of the following requirements or, if required in terms of the specification, the requirements of SANS 1090 for mortar sand (natural or manufactured): a) sand shall contain no organic material (material produced by animal or plant activities); b) sand shall not contain any particles which are retained on a sieve of nominal aperture size 5 mm; c) when 2,5 kg of cement is mixed with 12,5 kg of air-dry sand, the mixture shall not require more than 3,0 l of water to be added to reach a consistency suitable for the laying of masonry units; and d) when

mixed with the cement in accordance with the mix proportions, the sand shall have workability suitable for the laying of masonry units.

G5 Gravel Material

- **Grading Requirements:** The material shall have a maximum dimension not exceeding sixty three millimetres (63 mm) for uncrushed material after compaction and fifty three millimetres (53 mm) for crushed material, before compaction. The total percentage by mass passing the two comma nought millimetre (2,0) sieve shall preferably not be less than twenty (20) nor more than fifty (50). The latter value may be allowed to reach sixty five (65) percent for supply only (constraint seventy {70} percent after compaction) where so indicated in the Project Specification or agreed to by the Materials Engineer (typically applicable to calcrete, weathered granite, weathered dolerite)

Gabion Rock Fill/stones

- dolerite gabion rock fill material to be used with hexagonal woven double twist Type 80 mm mesh gabion basket, River /Reno mattresses, foundations and stone pitching. The dolerite rock must be un-weathered and solid without flaking or weathering evidence. The rock sizes should be 100 – 250 mm.

Dump Rock

- Dolerite rock fill material to be used for stone pitching, landscaping and road works. The dolerite rock must be un-weathered and solid without flaking or weathering evidence. The rock sizes should be 70 – 150 mm.

Gabion Rock Fill/stones

- dolerite gabion rock fill material to be used with hexagonal woven double twist Type 80 mm mesh gabion basket, land scaping and stone pitching. The dolerite rock must be un-weathered and solid without flaking or weathering evidence. The rock sizes should be 100 – 300 mm.
