Lesithombe kade kunombhalo obhalwe ukuthi KwaZulu Natal, kubikwe ukhukhulelwa kwabesifazane abayizi- 26 515 phakathi kuka nyakenye.

Kanti bekuyizingane ezingapantsi kweminyaka eli-14 noma ngapansi kuka-1 254. NgoNewaba ingane ibhale emsakazweni yathi, ineminyaka eli-15 ubudala ilungiselela ukushada umshado wesintu njengonkosikazi wesithathu. Isidingo sokuthi umthetho ungenelele futhi uvikele izingane uyinselela enkulu esibhekene nayo. Kungalesi sizathu umthetho kufanele udlale indima yawo futhi zonke izinhlangano zisukume ziqale ukubhekana nezinkinga njengoba zinjalo, ikhakhulukazi lapho kuthinteka khona ilungelo lengane.

EVALUATION CRITERIA

Nkandla Local Municipality subscribes to the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000). The amended PPPFA Regulation 2022 will be used. The detailed Evaluation criteria will be available on the tender document.

- First Stage: Compliance (returnable documents).
- Second Stage: Functionality, 100 points (Minimum threshold of 70 points) being 50 points for Experience, 50 points for capacity.
- Third Stage: Preferential Points System (80/20): 80 for Price and 20 for Specific goals. Only bidders who pass the first stage with a minimum of 70 points will then be evaluated further in the third stage.
