08h30 – 15h00 as from 16 November 2023. A non-refundable fee of R450.00 is payable to Drakenstein Municipality for collection of documents. **No fee will be charged when the tender documents are requested electronically.**

A compulsory clarification meeting will be held on 22 November 2023 at 10:00 at the Drakenstein Municipality's Paarl Waste Depot located at 18a Distillery Street, Paarl. The meeting will include a visit to the site of works where important information pertaining to pricing the tender offer will be shared. Bidders need to make sure that they are represented by staff that can accurately relay the information given. Bidders that fail to attend the compulsory clarification meeting will be disqualified. A representative may only represent one tenderer at this meeting. Bidders that arrive after the starting time of the compulsory clarification meeting as indicated, will be disqualified.

Bids may only be submitted on the bid documentation provided by the municipality and must remain valid for a minimum of 120 days after bid closing.

Telegraphic, telephonic, telex, facsimile, e-mailed or late tenders will not be accepted. The lowest, only or any bid shall not necessarily be accepted and the Council reserves the right to accept any part of the bid.

TENDERS TO BE DEPOSITED IN: The tender box 1 in the foyer of the Civic Centre, Drakenstein Municipality, Berg River Boulevard, PAARL, 7620.
