However, after further extensive work in assessing the drawings and tender documentation and after commencing with the compilation of a program, we have concluded that we previously underestimated the time required to complete the bid due to its size, complexity and programming challenges.</p> <p>We therefore request that the tender closing date be extended by a further four weeks to enable us to submit a compliant, well-prepared and competitive tender.</p>	Tender period will be extended by a further two weeks, to provide sufficient time for tenderers to prepare bids. Revised closing date is Thursday, 16 October 2025.
5	Please send a request to SANRAL requesting the positions/locations of the employer's designated spoil sites as referenced in bill item C4.2.8	The spoil sites will most likely be at schools in the villages alongside the N2, to create sports fields.
