In accordance to PPPFA Regulation 4 (1) this tender is open to the following entities:

- Entities having a B-BBEE status level 1 to 4
- Only those Tenderers who commits to subcontracting a **minimum of 30%** to -
  - i. an EME or QSE which is at least 51% owned by black people;
  - ii. an EME or QSE which is at least 51% owned by black people who are youth;
  - iii. an EME or QSE which is at least 51% owned by black people who are women;
  - iv. an EME or QSE which is at least 51% owned by black people with disabilities;
  - v. an EME or QSE which is 51% owned by black people living in rural or under-developed areas or townships;
  - vi. a cooperative which is at least 51% owned by black people;
  - vii. an EME or QSE which is at least 51% owned by black people who are military veterans
