## 3 **PROPOSAL SUBMISSION**

Transnet has implemented a new electronic bid submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where Bidders can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system. The Transnet e-Tender Submission Portal can be accessed as follows:

#### 4 RFP INSTRUCTIONS

- 4.1 Please sign the documents [**sign and date the bottom of each page**] before submission. The person(s) signing the submission/documents must be legally authorised by the Bidder to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 11 below (Legal Review) and **Section 6** of the RFP, alterations, additions, or deletions **must not** be made by the Bidder to the actual RFP documents.

#### 5 PREFERRED BIDDER GUARANTEE

- 5.1 After the receipt of Bid responses After the receipt of Bid Responses to the RFP and evaluation thereof, the Preferred Bidder will be required to lodge a guarantee (the "Preferred Bidder Guarantee") with TNPA in an amount equal to R1 000 000.00 (One Million Rand). A Bidder which has been provisionally informed of its Preferred Bidder status will be considered to have been appointed by TNPA as the Preferred Bidder once the Preferred Bidder Guarantee has been submitted to TNPA in accordance with this Clause.
- 5.2 The preferred Bidder Guarantee must be:
  - a) An unconditional and irrevocable bank guarantee in the form set out in Annexure 8 (Form of preferred Bidder Guarantee).
  - b) lodged with TNPA within 15 (fifteen) Business Days of a Bidder being notified of its provisional Preferred Bidder status
  - c) issued by a bank which is licensed to conduct banking business in South Africa under the Banks Act, 94 of 1990 and, if TNPA so requires in its sole and absolute discretion, which has a South African rating of BBB or better by Standard & Poor's or equivalent; and
  - d) be valid and effective for the period from the date of issue of the Preferred Bidder Guarantee until the earlier of the expiry of the Bid Submission Validity Period, as defined in Clause 50 of Part



I (General Requirements, Rules and Provisions) of this RFP, (as extended from time to time) and the Effective Date as defined in Annexure F of the Draft Terminal Operator Agreement.

- e) If a provisionally appointed preferred bidder fails to deliver the preferred bidder guarantee within the time allowed, TNPA shall be entitled to revoke the status of that Bidder as Preferred Bidder. TNPA may substitute the Preferred Bidder with a Reserve Bidder nominated by it and to request such Reserve Bidder lodge a Preferred Bidder Guarantee with TNPA within 15 (fifteen) Business Days of being notified of its Preferred Bidder status. The provisions of this Clause 6 (*Preferred Bidder Guarantee*) shall apply *mutatis mutandis* to such new Preferred Bidder Guarantee in each such case.

## 6 RELEASE OF GUARANTEE

- 6.1 The Preferred Bidder Guarantee of the Preferred Bidder in respect of the Project will be returned within 15 (fifteen) Business Days of the Effective Date of the Terminal Operator Agreement or expiry of the Bid Submission Validity Period whichever is the earlier

## 7 FORFEITURE OF GUARANTEE

- 7.1 TNPA may call on the Preferred Bidder Guarantee more than once (provided that the aggregate amount payable thereunder shall not exceed the maximum amount of the Preferred Bidder Guarantee) without notice or legal process, if the Preferred Bidder:
- (a) Is in breach of any law relating to the RFP or is disqualified from the RFP as a result of its actions or omissions;
  - (b) Fails to extend the term of guarantee after agreeing to TNPA's request to extend the expiry date of the preferred bidder guarantee (in which case TNPA will hold it as security in lieu of such extended or renewed preferred bidder guarantee) provided that such Guarantee has not yet expired:
  - (c) Fails to sign the terminal operator agreement within the agreed period of this general requirements, rules and provisions of this RFP
  - (d) Revokes, repudiates or withdraws its bid response.

## 8 JOINT VENTURES

- 8.1 Bidders who would wish to respond to this RFP as a Joint Venture [**JV**] with B-BBEE entities, must state their intention to do so in their RFP submission. Such Bidders must also submit a signed JV agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV agreement is submitted to Transnet.
- 8.2 Bidders are to note that for the purpose of evaluation, **a JV will be evaluated based on one consolidated B-BBEE score card** (a consolidated B-BBEE Status Level verification certificate). Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in paragraph 4.1 of Section 9 of the specific goals Claim Form.

- 5.3 The Bid evaluation for stages 1 and 2 of the evaluation methodology (Section 3 of this Bid) will be conducted on the majority shareholder for of the JV. Should a JV become the preferred Bidder, all essential documents of the JV entities will be required to be evaluated as part of the due diligence process.

## **9 COMMUNICATION**

- 9.1 For specific queries relating to this RFP, an RFP Clarification Request Form should be submitted onto the system before **18 JULY 2025 AT 16H00** substantially in the form set out in **Section 8** hereto. In the interest of fairness and transparency, Transnet's response to such a query will be published on the e-tender portal and Transnet website.
- 9.2 After the closing date of the RFP, a Bidder may only communicate via email address [RCBREALSTATETENDERS@transnet.net](mailto:RCBREALSTATETENDERS@transnet.net) on any matter relating to its RFP Proposal.
- 9.3 Bidders are to note that changes to its submission will not be considered after the closing date.
- 9.4 It is prohibited for Bidders to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 9.5 Bidders found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- 9.6 Transnet will publish the outcome of this RFP in the National Treasury e-tender portal and Transnet website within 10 days after the award has been finalised. Bidders are required to check the National Treasury e-tender Portal and Transnet website for the results of the tender process. All unsuccessful bidders have a right to request Transnet to furnish individual reasons for their bid not being successful. This request must be directed to the contact person stated in the SBD 1 form.

## **10 CONFIDENTIALITY**

All information related to this RFP is to be treated with strict confidence. In this regard Bidders are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent agreement, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent agreement, written approval must be obtained from Transnet.

## **11 COMPLIANCE**

The successful Bidder shall be in full and complete compliance with any and all applicable laws and regulations.

## **12 EMPLOYMENT EQUITY ACT**

Bidders must comply with the requirements of the Employment Equity Act (Act No. 55 of 1998) applicable to it including (but not limited to) **Section 53** of the Employment Equity Act.

## **13 DISCLAIMERS**

Bidders are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 13.1 modify the RFP and request Bidders to re-bid on any such changes;
- 13.2 reject any Proposal which does not conform to instructions and scope of requirements which are detailed herein;
- 13.3 disqualify Proposals submitted after the stated submission deadline [closing date];

- 13.4 award an agreement in connection with this Proposal at any time after the RFP's closing date;
- 13.5 award an agreement for only a portion of the proposed Premises which are reflected in the scope of this RFP;
- 13.6 split the award of the agreement between more than one Bidder, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost, or developmental considerations;
- 13.7 cancel the bid process;

### SECTION 3: EXECUTIVE OVERVIEW AND SCOPE OF REQUIREMENTS

#### 1 EXECUTIVE OVERVIEW

- 1.1. Transnet National Ports Authority (TNPA) is established through the National Ports Act 12 of 2005 to be a Ports authority and landlord, responsible for the safe, efficient, and economic functioning of the national ports system, which it manages, controls and administers on behalf of the State.
- 1.2. **Section 11** of the National Ports Act prescribes the core functions of TNPA, to include the following:
  - 1.2.1. to plan, provide, maintain, and improve port infrastructure;
  - 1.2.2. prepare and periodically update a Port Development Framework Plan (PDFFP) for each Port;
  - 1.2.3. to promote the use, improvement and development of Ports and control land use within the Ports, having the power to lease Port land under conditions that it determines;
  - 1.2.4. to promote greater representation, in particular to increase participation in Port operations of historically disadvantaged people;
  - 1.2.5. to provide or arrange marine-related services, i.e., pilotage services, tug assistance, berthing services, dredging and hydrographic services;
  - 1.2.6. to ensure that adequate, affordable, and efficient Port services and facilities are provided, including regulatory oversight of all Port activities; and
  - 1.2.7. to provide aids to assist the navigation of vessels within Port limits and along the coast.
- 1.3. At an operational level, TNPA occupies a strategic position in the country's transport logistics chain, managing South Africa's eight (8) commercial seaports, namely Cape Town, Durban, East London, Mossel Bay, Ngqura, Port Elizabeth, Richards Bay and Saldanha Bay.
- 1.4. The Ports under the control of the TNPA span the South African coastline, which measures approximately 2 800 km. TNPA's asset base consists of Port land, basic Port infrastructure and marine fleet at the eight (8) commercial ports. TNPA manages Port land of approximately 43,4 million m<sup>2</sup> across the Port system.
- 1.5. Operating within the Port industry, TNPA provides its services to Port users, namely terminal operators, shipping lines, shipping agents, cargo owners and the clearing and forwarding industry.
- 1.6. TNPA also carries a distinctive feature of being self-sustaining, unlike most other landlord Port authorities that rely on National or Provincial governments for financial support.
- 1.7. This RFP is issued in terms of Section 11 of the Act and specifically does include any operations which are required to be undertaken under conditions determined through the issuance of a license to operate in terms of other provisions of the act pertaining thereto.

#### 2 SCOPE OF REQUIREMENTS

- 2.1. The objective of this document is to invite interested parties to submit to TNPA RFP responses for the lease of premises at the **Port of Richards Bay**.
- 2.2. The below property is to be leased on as is basis (**voetstoots**), as reflected on attached Site/Lease Plan

(Annexure 1).

- 2.3. The property is currently **vacant** and according to the PDFP the property is earmarked for dry bulk storage.
- 2.4. Exclusions: Handling and storage of hazardous chemicals, staging of trucks, truck refueling station, contained handling depot activities. No dust minerals stored in the open areas. Subject to compliance with all relevant laws to usage.
- 2.5. The Successful/Preferred Bidder must note that it shall be obliged to undertake whatever refurbishment, repairs, upgrades, and capital improvements as may be necessary.
- 2.6. It may require, at its own costs, to ensure that the leased premises is fit for purpose and that its use complies with all relevant and applicable laws and legislation unless negotiated otherwise and agreed to by the TNPA.
- 2.7. Depending on the extent of work required, which will be evaluated based on the submission made by the Bidder, beneficial occupation may be considered and negotiated.
- 2.8. Bidders are to note that should beneficial occupation be required, this must be properly motivated and justified in the Business Plan which will be subject to approval by TNPA Governance structures, in line with policies and procedures. The Bidder will be liable for all property holding costs during the beneficial occupation period.
- 2.9. Bidders bear the onus to carry out whatever inspections they may deem necessary prior to submitting any RFP Responses. In terms of this RFP, bidders must ensure that an inspection of the property is conducted prior to submitting the applications to ensure a full understanding and appreciation of the condition of the property. TNPA accepts no responsibility or any liability for any failure and or refusal of a prospective applicant to do so. ### **3. GREEN ECONOMY / CARBON FOOTPRINT**

Transnet wishes to understand your company's position regarding environmental commitments, including key environmental characteristics such as waste disposal, recycling, and energy conservation.

### **4. ENVIRONMENTAL MANAGEMENT REQUIREMENTS**

Transnet wishes to understand your company's position regarding environmental commitments, to ensure environmental sustainability including, environmental climate change adaptation and energy conservation.

The bidder must provide Environmental Assessment Plan relating to their operations.

### **5. SAFETY MANAGEMENT REQUIREMENTS**

The bidder must provide a detailed fire management plan.

### **6. INFRASTRUCTURE REQUIREMENTS**

- 6.1. The bidder must provide concept designs of the proposed refurbishments for properties infrastructure and bulk services such as, storm water line, water line, electrical substation, etc.
- 6.2. The bidder must note that prior to any refurbishment or upgrade of the infrastructure, TNPA will require detail designs

- 6.3. The design will be performed by a professional team according to his areas of responsibility as included in the Engineering Professions Act 2000, published by the Engineering Council of South Africa.
- 6.4. The bidder is to design the works, for acceptance by the Port Engineer.
- 6.5. Acceptance of documentation or designs by the Port Engineer will in no way relieve the bidder of his responsibility for the correctness of information, or conformance with his obligation to provide the Works. This obligation rests solely with the bidder.
- 6.6. The bidder grants the TNPA a licence to use the copyright in all design data presented to TNPA in relation to the works for any purpose in connection with the construction, re-construction, refurbishment, repair, maintenance and extension of such licence being capable of transfer to any third party without the consent of the bidder.
- 6.7. The bidder vests in the Employer (TNPA) full title guarantee in the intellectual property and copyright in the design data created in relation to the works as follows:
- Detailed drawings
  - Design calculations
  - Shop drawings for the construction of the equipment supports
  - Any design alterations that the Contractor may formulate to ensure the correct execution of the works.
- 6.8. The bidder compiles and delivers the Maintenance and Operating Manuals and Data Books to the Port Engineer.
- 6.9. These shall be supplied by the bidder as manuals in a loose-leaf A4 hard covered, red, grease- and water-proof 4D-ring binder.
- 6.10. Drawings and charts larger than A4 shall be folded and those greater than A3 shall be enclosed in an A4 plastic pocket of adequate strength.
- 6.11. Manuals shall be well indexed and user friendly.
- 6.12. Manuals shall include a summarised Table of Contents and in manuals comprising a number of files/volumes there should be one summarised Table of Contents in each of the files/volumes.
- 6.13. The draft Table of Contents shall be submitted for review to the Port Engineer prior to the compilation and official submittal of the manuals.
- 6.14. The technical content of manuals shall be specified by the Port Engineer.
- 6.15. The originals of all brochures shall be issued to the Port Engineer. When a general brochure is applicable to a range of equipment, then a specific item, catalogue number or model number shall

be stated, which is best achieved by introducing a separate index page, which cross-references the specific item to a tag number.

## **7. SECURITY REQUIREMENTS**

- 7.1. The bidder must include a security plan for the facility.
- 7.2. The bidder must comply with all TNPA security protocols.

## **8. OPERATIONS REQUIREMENTS**

- 8.1 The bidder must provide a logistics operations plan which will accommodate road and railway freight. The plan must indicate timelines of achieving 20% road freight and 80% railway freight over the first 5 years after resuming operations. The bidder must conduct continuous logistics improvements over the full contract period.

## **9. GENERAL BIDDER OBLIGATIONS**

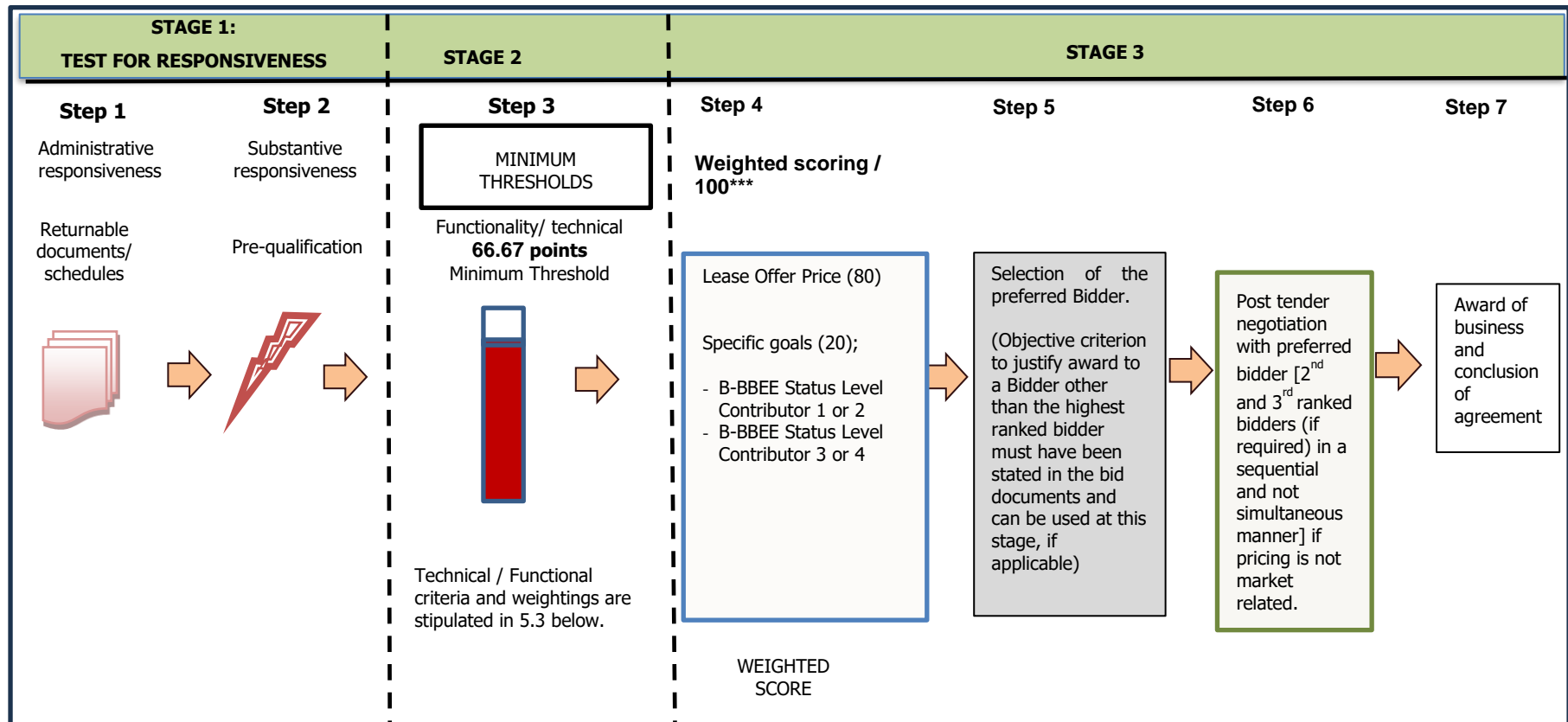
- 9.1. The Bidder shall be fully responsible to Transnet for the acts and omissions of persons directly or indirectly employed by them.
- 9.2. The Bidder must comply with the requirements stated in this RFP.

## **10. EVALUATION METHODOLOGY**

**10.5. STEP FIVE: Objective Criteria**

Transnet reserves the right to award the business to the highest scoring Bidder unless objective criteria justify the award to another Bidder as per the requirements of the PPPFA. The objective criteria Transnet may apply in this bid process include:
