Emakhazeni Local Municipality hereby invites quotations from suitably qualified service providers for quotations for the following items:

1	The felling and removal of hazardous trees - Machadodorp (4) - Belfast (8) - Emgwenya (4) - Dullstroom (4)	20

The following conditions will apply:

- Quotations shall remain valid for a period of 90 days from closing date
- Quotes will be evaluated on 80/20 preferential points
- The means of verification for the allocation of specific goals points will be performed through the full CSD report, CIPC Registered Address, verification of B-BBEE certificate, Medical Certificate.
- Members or Directors of Companies or Service Providers who are state employees are not allowed to bid or quote;
- The cutting and removing of trees can be dangerous and should be done by professionals who have been trained in safety, climbing, block and tackles, rigging and roping.
- The following minimum requirements will be applicable:
 - Company Experience: Minimum of 1 project completed previously (Attach reference letter and appointment letter/purchase order)
 - Public liability of at least R5m (proof)
 - Registration as Pest Control Officer (Attach registration certificate)
 - Chainsaw Operator Certificate (Attach registration certificate)
 - Herbicide Applicator Certificate (Attach registration certificate)
 - Registration of workers with the Compensation Fund – registration certificate must be attached
- Specific goals will be awarded as follows:
 - (a) A total of 10 preference points shall be allocated on a proportional or pro rata basis for contracting an enterprise owned by historically disadvantaged persons or individuals who meet the following requirements-
 - (i) 2,5 points for 100% black person or people owned enterprise;
 - (ii) 2,5 points for more than 30% woman or women shareholding or owned enterprise;
 - (iii) 2,5 points for more than 30% youth shareholding or owned enterprise;
 - (iv) 2,5 points for more than 30% people living with disability shareholding or owned enterprise.
 - (b) A total of 10 preference points shall be allocated for implementing of programmes for RDP-
 - (i) 10 points shall be allocated to only those enterprises regarded as EMEs or Start-Ups located within the local area of jurisdiction, supported by the local Municipality through various Local Economic Development Strategies and/or Policies initiatives and programmes, subject to meeting the requirements stated on section 7.6 of this Policy.
