## Scope of Work (Terms of Reference)

The National Museum is in the process of appointing a qualified Electrical Engineer to conduct a thorough conditional assessment on the National Museum Electrical power network. The National Museum electrical network has been deteriorating due to untraceable connections and old infrastructure, the aim of this project is to improve the power quality to the building premises to ensure smooth operation of all electrical equipment.

#### SERVICES REQUIREMENT SPECIFICATION

The Electrical Engineer should carry out the services as outlined on the 'Guideline for Services and Processes for Estimating Fees for Persons Registered in terms of the Engineering Profession Act, 2000, (Act No.46 of 2000)'.

#### 3. SCOPE OF WORK FOR THE ELECTRICAL ENGINEER

- 3.1 The Electrical Engineer must carry out an audit on the Electrical Infrastructure and provide a report on the findings, together with any recommendations that may improve and safeguard the electrical network through regulation/alternation of power feeds from council, and the generator, with the ultimate view to ensure a consistent and uninterrupted supply to the rest of the building premises.
- 3.2. The Electrical Engineer or Firm must advise on a suitable energy efficient consumption methods that will reduce overloading of power & decrease in power consumption

### 4. UPDATING AND GENERATION OF NETWORK DRAWINGS

2.1. Compile new network configuration especially with the addition of the solar and generator to the municipal supply. Where there are no drawings to assist with this exercise, the Electrical Engineer will be required to generate drawings according to the network configuration.

#### 5. FINAL REPORT AND RECOMMEDATIONS

4.1. The service provider must compile a full final audit report detailing the findings of the study, their impact on the network, the recommendations to ensure a safe network and provide a high-level costing of the exercise together with a proposed schedule.

- 2. Failure by this preferred service provider to rectify its tax matters to a compliant status within the grace period provided will lead to an automatic disqualification.
- 3. Validity period for bids or formal written quotations submitted shall be valid for a minimum period of thirty (30) days. The formal written price quotations received from the service provider/supplier will be regarded as valid for 30 days despite expiry date less than 30 days indicated on a quote.

All bidders will be subject to a three stage evaluation process, i.e.

- 5.1 Pre-screening, i.e. determination of compliance to compulsory requirements. The will be required to pass pre-screening to be eligible for further evaluation.
- 5.2 Technical assessment, measurement of capability. The bidder will be required to obtain a minimum of 60 points in order to be eligible for preferential procurement evaluation.
- 5.3 Preferential procurement calculation 80/20, whereby 80 is for price and 20 points for BBBEE points.

## Preference Point System

In accordance with the Preferential Procurement Regulations of 2022, NM has determined the following specific goals for which preference points will be awarded:

## Goal 1: Broad-Based Black Economic Empowerment

Section 10 of the B-BBEE Act enjoins every public entity to take into account and apply the B-BBEE Codes of Good Practice in determining and implementing a preferential

procurement policy. NM will thus award preference points to suppliers based on their B-BBEE status level of contributor.

# Goal 2: Empowerment of Local Businesses

NM is located in the Free State, a rural province on the margins of economic activity. In an effort to develop and empower local businesses based in the Free State, NM will award preference point to suppliers based in the Free State.

### Goal 3: Youth Empowerment

Youth participation in the economy is crucial for the growth and development of the South African economy, but their participation has been limited by several factors. One of the main challenges for youth has been the high levels of unemployment. The unemployment rate for young people in South Africa is much higher than the national average, which makes it difficult for them to enter the labour market and participate in the economy. In an effort to empower youth and encourage their participation in the economy, NM will award preference points to businesses which are at least 51% owned by youth.

#### Goal 4: Women Empowerment

Women participation in the economy is crucial for the growth and development of the South African economy, but their participation has been limited by several factors. For women, the challenge has been unequal access to economic opportunities, including education, training, and employment. Women in South Africa often face discrimination and gender-based violence, which can limit their ability to participate in the economy. Additionally, women tend to be concentrated in low-paying, informal sector jobs, which offer little security and limited opportunities for advancement.

In an effort to empower women and encourage their participation in the economy, NM will award preference points to businesses which are at least 51% owned by women.

# Goal 5: Empowerment of People with Disabilities

People with disabilities face significant barriers to participating in the South African economy. According to the World Bank, about seven million South Africans have some form of disability, and they are more likely to experience poverty and unemployment compared to those without disabilities.

People with disabilities often face discrimination in the labour market and have limited access to education, training, and employment opportunities. They may also face physical and attitudinal barriers, making it difficult for them to fully participate in the economy.

In an effort to empower people with disabilities and encourage their participation in the economy, NM will award preference points to businesses which are at least 51% owned by people with disabilities.
