A **compulsory clarification meeting** with the representative of the employer shall take place on Thursday, 29 January 2026 at Denel SOC Ltd, trading as DENEL AEROSPACE OVERBERG TEST RANGE, located in the Overberg Region of the Western Cape, Waenhuiskrans (Arniston), South Africa. It is +/- 210 kilometres from Cape Town on the R316 road. Suppliers shall assemble at the security main gate at 12:00, whereby they will be escorted to the site, for inspection. Bids close on Friday, 06 February 2026 at 11:00.

### **DRILLING OF BOREHOLES:**

#### **DESCRIPTION OF DRILLING WORKS**

This service needed to be rendered in this contract include the drilling and insertion of pvc casing of one(1) water bore hole at Denel Aerospace Overberg Test Range, in Arniston. The borehole will be drilled in a position indicated by Denel Aerospace Overberg Test Range. Final dept is not expected to be more than 40 meter and the the final casing internal diameter is not to be less than 230mm. A concrete platform 600mm width x 600mm length x 200mm high also needs to be constructed.

#### **DESCRIPTION OF SITE AND ACCESS**

Denel SOC Ltd, trading as DENEL AEROSPACE OVERBERG TEST RANGE, is located in the Overberg Region of the Western Cape, Waenhuiskrans (Arniston), South Africa. It is +/- 210 kilometres from Cape Town on the R316 road. Drill site is next to a gravel road and is easily accessible.

Accommodation facilities are available at The Dunes at Arniston at the tenderers expense

### **DRILLING SPESIFICATIONS:**

#### **APPROACH AND RESPONSIBILITIES**

Contractor will function under supervision of Denel Aerospace Overberg Test Range. Contractor will not be absolved from any responsibility, but just to have a better communication and discussion approach between Denel Aerospace Overberg test range and the contractor to have the most suitable and acceptable final finished product.

#### **EQUIPMENT AND MATERIAL**

Contractor will provide all labour, transport, plant tools, materials including for drilling and appurtenances necessary to satisfactorily complete the drilling program as to the specifications determined by Denel Aerospace Overberg test range. It is upmost important that contractor supplies equipment of a suitable size and capability to drill the boreholes up to 40 meter if so required, accommodates large quantities of water and overcome if necessary any difficult drilling conditions.

The Contractor shall supply their own suitable generator to power the compressor they provide.

All equipment brought onto site must be listed on an itemized register, to be submitted prior to commencement of work. It is the sole responsibility of the Contractor to ensure they arrive onsite with all necessary equipment, materials, and chemicals required to complete the job without interruption. Failure to do so may result in penalties, charged at rates equivalent to those tendered for standing time by the Contractor.

Denel Aerospace Overberg Test Range reserves the right to inspect all equipment prior to the commencement of work. If any equipment or plant is found to be inefficient or inadequate in capacity, the Contractor will be required to rectify the issue within seven (7) days, or to remove and replace such equipment with plant or machinery that meets the requirements of the contract.

If this requirement is not met, Denel Aerospace Overberg Test Range reserves the right to terminate the contract immediately.

### **DRILLING TECHNIQUES AND CAPABILITY**

The preferred drilling technique is rotary air-percussion (DTH)

## **LOST BOREHOLES**

A borehole will be declared lost by Denel Overberg Test Range representative in the event that it cannot be completed satisfactory due to:

-irrecoverable loss of drilling equipment

-materials or tools therein

-accidents to plant or heavy machinery

-Failure to pass straightness or vertically test.

Drilling contractor will have the option either to remedy the situation to our satisfaction or declare the situation irretrievable.

No payment shall be made for any work done, materials used or time used by contractor on a lost borehole, also any materials recovered in a damaged state from a lost borehole will be borne by the contractor.

All lost and unsuccessful boreholes are to be equipped with a standpipe, sanitary seal and concrete collar. The concrete mix shall consist of water, cement, stone aggregate (10mm) and clean sand.

## **DATA RECORDING AND REPORTING**

A detailed and accurate record of all information arising from the borehole drilling activity must be recorded.
