Phase 4:

Preference Points system

The bid will be awarded in terms of Regulation 4: Preferential Procurement Regulations, 2022 pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000).

Bid proposals will be evaluated based on the 80/20 preference points where a maximum of 80 points will be awarded in respect of price and a maximum of 20 points will be awarded for goals.

Points claimed will be according to a bidder's specific goals claimed as indicated in Table 4 below.

Specific goals” means specific goals as contemplated in section 2(1)(d) of the PPPFA Act which may include contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender and disability including the implementation of programmes of the Reconstruction of Development Programme as published in *Government Gazette* No. 16085 date 23 November 1994.

“Ownership” means the percentage of ownership and control, exercised by individuals within an enterprise.

“Disability” means, in respect of a person, a permanent impairment of a physical, intellectual, or sensory function, which results in restricted, or lack of, ability to perform an activity in the manner, or within the range, considered normal for a human being.

- i. A blind person (in terms of the Blind Persons Act, 1968 (Act no.26 of 1968);
- ii. A deaf person, whose hearing is impaired to such an extent that he/she cannot use it as a primary means of communication;
- iii. A person who, as a result of permanent disability, requires a wheelchair, caliper or crutch to assist him/her to move from one place or another;
- iv. A person who requires an artificial limb; or
- v. A person who suffers from a mental illness (in terms of the Mental Health Act, 1973 (Act no. 18 of 1973).

“Youth” means, in respect a person younger than 35 years of age.

Location of enterprise” Local equals province. Where a project cuts across more than one province, the bidder may be located in any of the relevant provinces to claim and be allocated the points.

Women, disability, and youth will be measured by calculating the pro-rata percentage of ownership of the bidding company which meets the criterion. E.g., Company A has five shareholders each of whom owns 20% of the company. Three of the five shareholders meet the criterion, i.e., they are women/disabled/youth. Therefore, this bidder will obtain 60% of the points allowable for this goal.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1. "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2. "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3. "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4. "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5. "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6. "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7. "Day" means calendar day.
 - 1.8. "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10. "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11. "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12. "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14. "GCC" means the General Conditions of Contract.
 - 1.15. "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

- 1.16. "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17. "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18. "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19. "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20. "Project site," where applicable, means the place indicated in bidding documents.
- 1.21. "Purchaser" means the organization purchasing the goods.
- 1.22. "Republic" means the Republic of South Africa.
- 1.23. "SCC" means the Special Conditions of Contract.
- 1.24. "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25. "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2. With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1. The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.
- 5.2. The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3. Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4. The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1. The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2. The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3. The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4. The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1. All pre-bidding testing will be for the account of the bidder.
- 8.2. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.

- 8.5. Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7. Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2. The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1. Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2. Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1. The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1. Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1. The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
 - (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

- 14.1. As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
 - (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

- 15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the

contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

- 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

- 16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.
- 16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4. Payment will be made in Rand unless otherwise stipulated in SCC.

17. Prices

- 17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. Contract amendments

- 18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. Assignment

- 19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

- 20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under these contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.

- 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

- 22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

- 23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
 - (b) if the Supplier fails to perform any other obligation(s) under the contract; or
 - (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

- 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.
- 23.5. Any restriction imposed on any person by the Accounting Officer /Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.
- 23.6. If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- (i) the name and address of the supplier and / or person restricted by the purchaser;
 - (ii) the date of commencement of the restriction
 - (iii) the period of restriction; and
 - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

- 23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

- 24.1. When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

25. Force Majeure

- 25.1. Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

- 25.2. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

- 26.1. The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4. Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5. Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
 - (b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of liability

- 28.1. Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
 - (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

- 29.1. The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

- 30.1. The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

31. Notices

- 31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3. No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.

33. National Industrial Participation (NIP) Programme

- 33.1. The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

34. Prohibition of Restrictive practices

- 34.1. In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2. If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.
- 34.3. If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

C3.2 PROJECT SPECIFICATION

PS 1. DESCRIPTION OF THE PROJECT

The Department of Water and Sanitation's Construction Division has been appointed to undertake the raising of the Clanwilliam dam.

The raised dam wall will be approximately 370 m in length and 49 m in maximum height. At full supply level the reservoir will cover a surface area of approximately 2 022 ha and capacity of 344,3 million cubic metre. The works include addition of concrete on the downstream side, extending the apron, construction of a free-standing intake tower, river outlet control house, a power generating house, short tunnel and coffer dam works on the upstream side, as well as various other pipe outlet structures on the downstream side. This work must be done without interfering with the day-to-day operation of the dam.

PS 2. SCOPE OF THE CONTRACT

PS2.1 General

The following service is required for DUST, NOISE AND WATER QUALITY:

1. Dust and Noise stations installation / establishment
2. Monthly Dust, Noise and Water Quality Monitoring

at Clanwilliam Dam Construction Site and surrounding area, for a **10 months' period** and or up to a threshold of R 999 999.00 Rand including VAT.

NOTE: On own cost, if there is a need, arrangements can be made for a site visit (for tendering purposes only).

PS2.2 Dust and Noise Station Installation / Establishment

Different locations are identified on the Clanwilliam Dam Construction Site, and in the surrounding Clanwilliam Town area as indicated in Annexure A, Annexure B. The GPS co-ordinates for these locations is provided in Table 1 and Table 2.

PS2.3 Monthly Dust, Noise and Water Quality Monitoring and Reporting

A database with all the results for dust, noise and water monitoring shall be developed and maintained and used for the monthly analysis and reporting to the Department. These databases will be the property of the Department.

The Service Provider shall submit a monthly report on the dust, noise, and water quality monitoring. This shall include description of prevailing weather conditions, including wind direction and speed, air temperature and precipitation in the air quality monitoring report. Monthly reports shall be submitted to the Department.

PS 2.4.1 Dust Monitoring and Reporting

The Service Provider shall compile dust monthly monitoring reports based on all monitoring locations allocated within a radius of 10 kilometres from the site. See below Table 1 indicating all identified stations, as well as Appendix A. The report shall be provided to the Department three week after the collection of dust sampling measurements.

The Service Provider shall provide the Department with a method statement for the monitoring of the dust before commencement of works. The method will include the method to be used for the sampling, storage, and transport techniques of the dust.

Monitoring shall be undertaken according to SANS 1929. A database of the results shall be developed, maintained, and used for monthly analysis and reporting to the contractor.

Dust Fallout Monitoring:

The Department has identified ten (10) Dust fallout monitoring stations. The monitoring stations may increase depending on the project needs. The Service Provider shall collect the dust fallout from dust buckets from the specified monitoring sites according to ASTM D1739. This dust will be analysed by an accredited SANAS laboratory. The data to be approved analyses and express the results as the average dust fallout per day over the sample period against the thresholds for each station provided in Table 1 and Appendix A.

PM₁₀ Monitoring:

The Service Provider shall collect PM₁₀ concentration samples from an air sampler of a type approved by the Department and Employers Agent Supervising Engineer (i.e. Minivol air sampler or similar), at point, BK1 as identified in Table 1. These data collected must be analysed and the results express as average PM₁₀ concentrations per day over the sample period, monthly. Monthly report on the PM₁₀ measured concentrations shall be submitted to the Department.

Occupational Hygiene Air Quality Assessment and Reporting

In addition to the monthly dust monitoring, the Service Provider shall conduct once off dust or air quality assessment at the following five (5) locations within the project site for occupational hygiene purpose:

- In the mechanical workshop
- In the welding workshop
- In the carpenter workshop
- In the material laboratory
- At the batch plant area

The Service Provider shall provide or submit the dust or air quality assessment report to the Department electronically three weeks after the sampling measurements.

PS 2.4.2 Noise Monitoring and Reporting

The Service Provider shall monitor the noise at eight (8) different identified sampling points/locations as indicated in Table 2, as well as Appendix B. The Department may request the Service Provider to increase the number of noise sampling points. This monitoring shall be done in accordance with SANS 10103. A database with the results shall be developed and maintained and used for monthly analysis and reporting to the contractor. The report shall be provided to the Department three weeks after the noise measurements.

The Service Provider shall provide the Department with a method statement for the monitoring of the noise before commencement of works.

Occupational Hygiene Noise Assessment and Reporting

In addition to the monthly noise monitoring reports, the Service Provider shall conduct once off noise assessment at the following four (4) locations within the project site for occupational hygiene purpose:

- In the mechanical workshop
- In the welding workshop
- In the carpenter workshop

- In the laboratory

The noise assessment report shall be provided to the Department electronically three weeks after the sampling measurements.

PS 2.4.3 Water Quality Monitoring and Reporting

The monitoring in the Olifants River must be done once a month. The water samples shall be collected, preserved, and analysed according to protocol approved by the Department. These analyses of water samples must be done by SANAS accredited analytical laboratory.

Two (2) water quality samples, at the Clanwilliam dam construction site, shall be taken from the Clanwilliam Dam (upstream of the dam wall) and downstream of the construction works in the Olifants River, refer to Appendix C. The Department may increase water quality monitoring points depending on the project requirements. The samples shall reach the SANAS accredited laboratory within 24 hours after being sampled/collected.

The Service Provider to submit a Method Statement for the approval of the Department, on the method to be used for the sampling, storage, and transport techniques of the water. The method shall be in line with SANS 241. The Method Statement shall be supplied to the Department before work can commence.

The water quality monitoring shall include, but not limited to:

- Visual observations.
- Colour, odour (as per SANS)
- Collection of water samples for chemical and biological analysis (see Table 3 below);
- Suspended Solids (not to exceed 10mg/l)
- pH
- Recording; and
- Reporting

Labelling on the samples taken shall include the date and number of the sampling position, as well as the name of the person taking the samples.

The water quality analysis shall be carried out by SANAS accredited laboratory in terms of SANS 10259.

The monthly water quality monitoring report shall be submitted to the Department electronically three weeks after taking the water samples.

PS 3. THE SITE

PS 3.1 Location and access to site

The dam site is situated on the Olifants River, in the Western Cape, approximately 2 km South- West of Clanwilliam town in the Western Cape province.

The site is immediately next to the N7 and accessed through a controlled gate. The gravel site roads will be regularly maintained but could get challenging under abnormal rainfall conditions.

PS 3.2 Road Conditions and Distance

Bidders are advised to acquaint themselves with roads, road conditions, distances, etc. on and to the site and the different station locations before bidding.

PS 4 FACILITIES PROVIDED BY SERVICE PROVIDER FOR WORKS

PS4.1 General

The Service Provider shall provide and maintain the stations (facilities) for the duration as required by the contract.

The management, operation and maintenance of the facilities shall be in accordance with the specifications as indicated in this document and to the approval of the Department.

All the Service Provider's charges for such maintenance and operations shall be deemed to be included in the rates and prices.

PS4.2 Station Installation / Establishment

The Service Provider shall provide the required tools, materials, and equipment for the installation of all the monitoring stations to be erected and be secured from intruders.

The Service Provider shall be entirely responsible for the design, provision, construction, and maintenance of all stations which is required by the Department for the due fulfilment of the contract. The Department will indicate each area where the monitoring must be done.

All cost (travelling, accommodation, labour, equipment, materials, tools etc) to be inclusive in the station installation price.

PS 4.2.1 Records

Detailed report, inclusive of photographs for the station installation / establishment shall be given to the Department within a period of 28 days from starting on site. This report shall cover photographs for before any work has been done, and photographs for after station installation, for each station. The report shall be provided to the Department via email in PDF format. Cost for this report shall be inclusive of the station installation/ establishment cost.

PS4.3 Electrical Power and Distribution

The Service Provider shall make his own arrangements to provide his own power supply (i.e monitoring equipment. etc.).

Failure or interruption of the power supply shall not relieve the Service Provider of any of his obligations under the Contract.

PS4.4 Communications

The Service Provider shall make his own arrangement with regards to his communication requirements for any monitoring equipment or personnel to carry out the monitoring.

PS4.5 Equipment to be provided

The Service Provider will provide the materials and equipment needed for dust, noise and water quality to perform the monitoring successfully. The equipment shall be according to specified standards and approved by the Department. Cost for the equipment shall be inclusive of the price.

PS4.6 Accommodation and Travelling

Any cost for the monthly travelling and/or accommodation (if needed) to be included in the station installation / establishment as well as the monthly site inspection and maintenance rate.

PS 4.6.1 Accommodation

The Service Provider shall make his own arrangements for accommodation for his staff if needed. No accommodation is allowed on the site.

PS 4.6.2 Travelling

All transportation and / or traveling costs for the collection of samples, site maintenance or visit needs to be all included in the pricing schedule.

All other transport / traveling/ courier cost if needed needs to be included in the pricing of the relevant items. i.e. courier of samples to SANAS accredited laboratory.

PS4.7 Access control and security

The Department will be responsible for access control and security for the Dam construction site. The Service Provider will abide by the access control measures.

The Department will assist obtain permission to access the different stations and or private owners' ground as needed.

The Service Provider is responsible for the safeguarding and protection of their own equipment at the different monitoring stations. The Department will not be held liable for the Service Provider in terms of security whatsoever.

PS4.8 Bidders Vehicles

All vehicles and plant to be operated and maintained according to Construction Regulations 23. The Department will have the right to instruct the Service Provider to repair or replace a vehicle which is considered unsafe.

PS 5. WORKING TIMES

PS5.1 Standard Official Working Times

PS 6. CONTRACTUAL MATTERS

PS 6.1 General Responsibilities

The company needs to be an Approved Inspection Authority (AIA) with the Department of Labour in Occupational Hygiene and must be SANAS accredited. Proof of this Certification to be submit together with this bid document for tender evaluation (as specified in section 1 – evaluation).

Company needs to earmark a registered Occupational Hygiene technologist (or similar technologist) for the dust, noise and water quality assessment and monitoring. Proof of this person registration certificated needs to be submitted together with this bid document for tender evaluation.

Non-performance of the Department shall not relieve the Service Provider of any of his obligations under the Contract.

PS 6.2 Competence of Workmen

The Service Provider shall ensure that only competent personnel are employed in operations involving skills affecting the quality of the works. Should the competence of any member of the Service Provider's workforce be in doubt, the Department may order that the member be sent for additional training at the Service Provider's account and/or that member be replaced with a competent person to perform that work.

PS 6.3 Service Provider's Returns

Records and returns shall be reported to the Department in an agreed format.

The Service Provider shall keep accurate records detailing work carried out on the works and shall submit them to the Department.

Databases will be developed for the dust, noise and water quality data collect and analysis, and provide to the Department monthly.

The collection of the data shall be as agreed between the Service Provider and Department, and the report within three weeks after collecting and analysis of the data, for the dust, noise, and water quality.

PS 6.3.1 Reporting

The monthly report shall be three separate reports for the dust, noise, and water quality monitoring.

The reports shall be submitted to the Department within three weeks from the collection of data each month.

The reports shall include mitigating measures to be implemented where allowable thresholds have been exceeded on (the dust, noise, and water quality) prescribed limits.

The reports shall be emailed to the Department in a PDF format (or as agreed upon).

Invoice will only be payable once the reports have been received and approved (signed off).

PS 6.4 Payments

- Payments will be made monthly on receipt of specified approved tax invoices.
- Payment will not be made for consignment unless supported by delivery notes duly signed by the designated official checking the delivery.
- No escalation will be considered.
- Payment will be done within 30 days of receipt and approval of original invoice by depositing the payment directly into the bank account of the successful Tenderer. No cash payment or cheque payment will be done.

All-inclusive bid prices are required, transport and any other cost mentioned in the specification for the Bidders account shall be included in the unit price.

PS 7. HEALTH AND SAFETY

For this contract, the Department will be the mandatory of the Employer (Client), as defined in the Act (OHSA 1993), which means that the Service Provider, as an employer in his own right in respect of the contract, will be responsible for all the duties and obligations of an employer as set out in the Act (OHSA 1993) and the Construction Regulations 2003. Furthermore, the Service Provider shall comply with any additional current statutory requirements of any relevant Government Departments regarding health and safety and specifically environmental health issues.

Nothing specified in this document shall relieve the Service Provider of any obligations or responsibilities with regards to health and safety responsibilities.

Where safety precautions are not being observed, the Department may order the Service Provider to comply with minimum safety requirements at the Service Provider's expense, and compliance with such an order will not absolve the Service Provider from any of his responsibilities and obligations under the Contract.

All Covid-19 related regulatory specification needs to be implemented and adhered to by the Service Provider.

Before commencement of work under the contract the Service Provider shall:

1. Enter into an agreement with the Employer's Agent to confirm his status as mandatory (employer) for the contract under consideration.
2. A health and safety file to be submitted before any work will commence on site The list of documents to be part of the health and safety file will be supplied once Service Provider is appointed.

The Service Provider personnel shall be required to undergo Safety, Security and Environmental induction before commencing with the contract.

All vehicles and plant to be operated and maintained according to Construction Regulations 23.

Failure by the Service Provider to comply with safety requirements will entitle the Employer's Agent to order a temporary halt of work within the affected areas until the specified requirements are met, without any extension of time being granted and without any additional payment.

All incidents which occur on-site while the Service Provider is performing service delivery to the Construction South must be reported immediately to the DWS contact person or safety personnel.

PS 8. ENVIRONMENTAL REQUIREMENTS

The Service Provider shall take full responsibility for protecting the natural environment and eliminating or minimising the negative impacts on the environment.

The Service Provider shall implement necessary environmental protection measures in each area before any work proceeds. The Employer may suspend the works at any time should the Service Provider, fail to implement, operate, or maintain the environmental protection measures adequately. The costs of such suspension shall be to the Service Provider's account.

PREAMBLE TO THE SBD 3.1 – PRICING SCHEDULE

1. GENERAL

The Schedule of Quantities forms part of the Contract Documents and must be read and priced in conjunction with all the other documents comprising the Contract Documents which include the Conditions of Tender, Conditions of Contract, the Specifications (including the Project Specification) and the Drawings.

2. DESCRIPTION OF ITEMS IN THE SCHEDULE

The Schedule of Quantities has been drawn up generally in accordance with Civil Engineering Quantities 1990 issued by the SA Institution of Civil Engineers.

The short descriptions of the items in the Schedule of Quantities are for identification purposes only and the measurement and payment clause of the Standardised Specifications and each Particular Specification, read together with the relevant clauses of the Project Specification and directives on the drawings, set out what ancillary or associated work and activities are included in the rates for the operations specified.

3. QUANTITIES REFLECTED IN THE SCHEDULE

The quantities given in the Schedule of Quantities are estimates only, and subject to remeasuring during the execution of the work. Where quantities or sums are indicated as "Provisional,, the Employer reserves the right to adjust the quantity or sum upwards or downwards as necessary, or the item can be omitted altogether. The Contractor shall obtain the Engineer's detailed instructions for all work before ordering any materials or executing work or making arrangements for it.

The Works as finally completed in accordance with the Contract shall be measured and paid for as specified in the Schedule of Quantities and in accordance with the General and Special Conditions of Contract, the Specifications and Project Specifications and the Drawings. Unless otherwise stated, items are measured net in accordance with the Drawings, and no allowance has been made for waste.

The validity of the contract will in no way be affected by differences between the quantities in the Schedule of Quantities and the quantities finally certified for payment.

4. PRICING OF THE SCHEDULE

The prices and rates to be inserted in the Schedule of Quantities shall be the full inclusive prices to be paid by the Employer for the work described under the several items, and shall include full compensation for all costs and expenses that may be required in and for the completion and maintenance during the defects liability period of all the work described and as shown on the drawings as well as all overheads, profits, incidentals and the cost of all general risks, liabilities and obligations set forth or implied in the documents on which the Tender is based.
