#### Nature of the works:

The required cleaning services consists but not limited to the adhoc removal of sewage silt/debris that tends to accumulate in the sewer pump station wet wells. Service Provider(s) will be required to assist with routine (planned work) and emergency cleaning of the sewer pump station wet wells when Council resources are not available. The waste removal service is hazardous, complicated and dirty, therefore Service Provider(s) will be required to take all precautions to protect their workers, site staff and the general public during cleaning services and transportation of the sewage debris from the pump station to the Vissershok Solid Waste disposal site .

### Overview of the Works:

- a) the cleaning of sewer pump station wet wells;
- b) the placement of sewage debris into water-tight tanks
- c) transportation of the sewage debris from the pump station to the disposal site
- d) the disposal of all the sewage debris at Vissershok Waste Management Facility.
- e) high pressure cleaning of wet well

#### Important factors to consider:

- clarify nil rates, or items regarded as having nil rates; and the CCT may also perform a risk analysis with regard to the reasonableness of such rates.
- f) Provide fixed rates and prices for the duration of the contract that are not subject to adjustment except as otherwise provided for in clause 17 of the Conditions of Contract and as amplified in the Special Conditions of Contract.
- g) In order to be considered responsive for this tender, the tenderers are required to price for all regions when tendering.
