## SPECIFICATIONS OF GOODS REQUIRED

### 1. Background

- Umngeni-uThukela Water requires the service provider to supply and deliver one (1) on-field rain gauge calibrator, as well as two (2) 12V, 7Ah rechargeable batteries for automated rain gauges. The calibrator must be compatible with the automated rain gauges installed at sites managed and operated by Umngeni-uThukela Water. The type of automated rain gauges used by Umngeni-uThukela Water is tipping bucket automated rain gauges (0.2 mm per tip).
- The Service Provider should use specialised skills in rainfall station installation and maintenance in line with SAWS, DWS and SABS standards. In addition, the Service Provider should use hydrological or/and meteorological reasoning, knowledge, skills and standards to produce the desired deliverables.
- The service provider must, in their team, have a technician with at least three (3) years' experience in either the supply, usage, installation or maintenance of the required or related (i.e. automated rain gauges) hydro-meteorological equipment. The technician's experience report, or resume should be submitted together with quotation.
