DETAILED TECHNICAL SPECIFICATION

1. PURPOSE AND BACKGROUND

SABC's is responsible to support broadcasting by providing uninterruptible power distribution and cooling of broadcasting facilities. The current air-conditioning system does not have service contract. We therefore desire to obtain the service of a professional HVAC (Heat Ventilation and Air conditioning) mechanical company to maintain our air-conditioning systems and chiller plants which will include the supply of new units where old ones fails and unrepairable, to ensure the supply of fresh air to the offices and the cooling off our broadcasting facilities and office environments.

On that note, we are looking for suitable service provider for the maintenance, repair, and service of Chiller systems and Air conditioning systems for a period of five (5) years (60) Months.

2. SCOPE OF SERVICES

The Works for this Contract comprises the servicing, repairs and supply of air-conditioning systems and chiller plants spares. The works in general comprises the provision of maintenance services including Provision of all labor, material, tools, machinery, equipment, supplies, transportation, storage, utilities, appliances, hauling, hoisting, excavation, backfill, supervision and services necessary to maintain all air conditioning system. Carrying out maintenance and repairs to the existing and new air conditioning systems.

(A) Preventative Maintenance

The contractor will be responsible for carrying out preventative maintenance on all air conditioning systems on a scheduled basis in line with the manufacturer's manual. The preventative maintenance shall include but not limited to the following.

Where the service contractor is required to provide spares or services the Contractor shall first submit a quote for approval and can only provide the spares and services after approval has been granted in writing.

10.1. The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.

4.6. I, the undersigned, who is duly authorised to do so on behalf of the company/firm, certify that the points claimed, based on the specific goals as advised in the tender, qualifies the company/ firm for the preference(s) shown and I acknowledge that:

- i) The information furnished is true and correct;
- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;

 - (a) disqualify the person from the tendering process;

- (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
- (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and

ANNEXURE E

SBD 9
CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.

Bid rigging is, therefore, an agreement between competitors not to compete.
