## **TERMS OF REFERENCE FOR**

### **THE SUPPLY AND ON-SITE INSTALLATION OF SELF-CONTAINED MAGNETIC MOUNT MINI-BARS WITH A BUILT-IN P.A., SIREN, AMPLIFIER & SPEAKER AND MAGNETIC REFLECTIVE TRAFFIC INSIGNIA FOR TRAFFIC VEHICLES**

#### **1. INTRODUCTION**

The Traffic division of Elias Motsoaledi Local Municipality (EMLM) subsidize Traffic Officers to purchase vehicles as working tools for the execution of traffic duties. The mentioned traffic vehicles must be clearly marked with traffic insignia and equipped with a blue light and siren for execution of their duties.

The Traffic division of Elias Motsoaledi Local Municipality (EMLM) therefore requires a Service Providers to tender for the supply and on-site installation of self-contained magnetic mount mini-bars with a built-in P.A., siren, amplifier & speaker and magnetic reflective Traffic Insignia for the Traffic Officers' subsidized Traffic vehicles.

The equipment must be durable and of high quality and standard.

#### **2. SCOPE OF THE WORKS**

- A. Elias Motsoaledi Local Municipality requires a service provider to tender for the supply and on-site installation of self-contained magnetic mount mini-bars with a built-in P.A., siren, amplifier & speaker and magnetic reflective Traffic Insignia for Traffic vehicles.
- B. Proof is required that the product has passed SAE J845, which includes SAE J575 & J578 testing.
- C. SAE J845 is the test standard for 360-degree equal light output from combined modules which have already passed SAE J595. The product is tested for 180-degree hemispherical light output from each side to insure the product is emitting equal light output 360 degrees. **This is important for Light bars & Beacons**
- D. Confirmation that the product was tested for and passed Class 1 & 2.
- E. For the above, the prospective bidder only needs to submit page One (1) and the pages which contain the photos of the product that was tested in the test report with any tender document.

## GENERAL SPECIFICATIONS

### BILL OF QUANTITY (BOQ)

#### I. Twenty-two (22) x Blue light Mini-bar with built-in siren

- The mini-bar shall have at least one (1) flashing mode and incorporate a static “cruise” mode.
- The mini-bar shall have an extruded & anodized aluminum top & base.
- The lenses shall be manufactured from high impact resistant UV treated Polycarp.
- The mini-bar shall be low profile and aerodynamic for minimized wind drag.
- The mini-bar shall measure between 500mm & 600mm in length when measured from end cap to end cap and measure between 200mm & 300mm in width when measured from front lens to rear lenses.
- The mini-bar profile shall measure between 60mm & 70mm when measured from the base extrusion to the top extrusion. This will not include the mounting brackets and magnets.
- The mounting brackets shall be manufactured from 304 stainless steel and be powder coated. The brackets shall be made in such a way as to give adequate clearance between the roof of the vehicle and the underside of the mini-bar. The mounting brackets shall be fitted with four (4) magnets. Each magnet will have a pulling strength of not less than 90kg and be housed in a protective rubber boot.
- The mini-bar shall be constructed using all stainless fasteners (screws, nuts, bolts & washers) to avoid rusting.
- The mini-bar shall house the P. A., siren, amplifier and speaker driver and solid state flasher.
- The siren, amplifier and speaker shall be 100 Watts 11ohms and produce no less than 123 Db as per SAE J1849
- The mini-bar shall be fitted with a speaker trumpet to allow maximum sound output from the speaker. The speaker trumpet shall be injection moulded glass filled nylon or poly-carb.
- The mini-bar shall be fitted with 2 x rear facing and 2 front facing NEW GEN 6LED modules and no less than 2 x wide angle NEW GEN 3LED modules will be fitted to each side. The minibar shall emit light 360 degrees as per SAE J845.
- The mini-bar wiring harness shall be sheathed in a durable PVC sleeve and be fitted with a glassed fused cigarette lighter plug. The harness shall be fitted with a handheld controller incorporating the public address microphone and lights and siren controls. The controller shall be backlit illuminated for easy night time identification. Each button on the handheld controller shall be clearly marked with a non-removable print for easy function identification by the operator.
- An additional & suitable power cable extension shall be supplied with the unit. The extension shall be fitted with a female cigarette lighter socket on one end and the other end shall be permanently connected to the vehicles battery terminals. Where required, PVC sleeve will be used to protect the extension cable from heat & chafing.
- The mini-bar shall automatically activate when any siren tone is activated. The ability to switch the minibar on without activating the siren must be incorporated. A silent function shall be incorporated whereby the siren can be deactivated with a single button press leaving the minibar on.
- The Siren shall have the following warning tones.
  1. Wail,
  2. Yelp,
  3. Phasor,
  4. Air horn.
- The cruise mode must be overridden and revert to a flashing pattern when the siren is activated in wail, yelp or phazer.
- The mini-bar & siren when in operation shall not exceed a current draw of 12.5 Amps @ 13.8VDC
- The unit shall have a warranty period of not less than three (3) years.
