Background

Airchefs as an airline caterer operating within four (4) sites, namely, Johannesburg, Durban, Cape Town and Gqeberha. We need a service provider to provide **FOOD GRADE** cleaning chemicals at Airchefs SOC LTD for a period of 36 months on an as and when required basis.

1. Scope of Work

1.1 To provide cleaning equipment's:

- General purpose detergent- 25LX40 Monthly
- Surface sanitiser-25L X10 Monthly
- o Chlorine based dis-infectant sachets- 2Bags Monthly
- Hand soap-25LX5 Monthly
- Hand sanitiser-25LX5 Monthly
- o Pine gel-25L X5 Monthly
- o Ovenklean-25LX10 Monthly
- o Dishwashing machine detergent-25LX10 Monthly
- Dishwashing machine rinse aid-25LX10 Monthly
- o Drain cleaner-25L X2 Monthly

2. Safety & Compliance Requirements

2.1 Proper Labelling (GHS Compliant)

All containers must carry:

- o Product name & chemical composition
- o GHS pictograms (flammable, corrosive, irritant, oxidiser, etc.)
- Signal word (Danger/Warning)
- o Hazard statements (e.g., Causes severe skin burns and eye damage)
- o **Precautionary statements** (e.g., *Wear protective gloves, Keep away from heat*)
- Supplier contact details (if the bidder is not the manufacturer)

2.2 Certifications

- SABS/SANAS Approved
- o ISO 9001

2.3 Safety Data Sheets (SDS/MSDS)

- Supplier must provide an up-to-date SDS for each chemical including the below:
- Ingredients and hazards
- Handling & storage requirements
- o PPE recommendations
- o First aid measures
- Spill/leak response
- o Transport classifications

NB: If the bidder is not the actual manufacturer of cleaning materials and will be sourcing the products from another company, a signed letter from that Company, Retailer, or / Supplier confirming a firm supply arrangement, including lead time in this regard, as well as SANAS Certification on products, must accompany your bid at the closing date and time

3. The Evaluation Process

3.1 Mandatory Requirements

A bidder will be disqualified if they fail to meet the following Mandatory Requirements.

a) Submission of all mandatory returnable documents as stated on page 2.

The contract shall be awarded at the sole and absolute discretion of Air Chefs, whereas Air Chefs reserves the right to retract this quotation at any time as from the date of issue, if justifiable. At the same time Air Chefs shall not be obliged to accept the lowest of any quotation, offer or proposal (where defensible).

Once the minimum compliance requirements above have been met, the qualifying quotation will be evaluated according to the below listed Evaluation Criteria.

3.2 Application of the applicable Preference Point System

The applicable preference point system for this tender is the 80/20 preference point system.

The 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

Points for this tender shall be awarded for: (a) Price; and (b) Specific Goals. The maximum points for this tender are allocated as follows:

3.2.2 POINTS AWARDED FOR SPECIFIC GOALS

In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

PROOF REQUIRED

CIPC Enterprise registration certificate, certified ID copies of company owners and certified Accredited B-BBEE Status level contributor certificate or fully completed sworn affidavit

Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

4. The Standard Conditions for Request for Quotation

Conditions:

- 4.1 All prices quoted must be inclusive of Value Added Tax (VAT).
- 4.2 All goods/services purchased will be subject to Air Chefs Conditions of Contract and Order, available when requested.
- 4.3 All prices submitted must be firm whilst "Firm" prices are deemed to be fixed prices.
- 4.4 Although Air Chefs would prefer to award this contract to one service provider, it remains at Air Chefs discretion (where applicable) to award to more than one service provider to ensure flexibility in provision of the required goods or services.
- 4.5 Air Chefs is not obligated to award this quote to any Bidder- thus entitled to retract this quote at any time as from date of issue, without any refunds whatsoever. Air Chefs is also not obligated to award this quote to the bidder that quotes the lowest.
- 4.6 Service, pricing and availability will be taken into consideration.
- 4.7 Pricing should be given based on an individual component that would make up the solution based on technical and functional requirements.

4.8 Air Chefs reserves the right to increase or decrease the scope, should the need arise.

Additional Requirements

In addition to the requirements of the Condition of Tender, offers will only be accepted if:

- 4.9 The Bidder or any of its directors is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector;
- 4.10 The Bidder has not abused the Air Chefs' supply chain management system; and
- 4.11 The Bidder has not failed to perform on any previous contract and has not been given written notice to this effect;
