- 3.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**

- 3.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 3.4 **Bidder responses must include a soft copy of the submission in the form of a USB Flash Drive (stick).**
- 3.5 Any additional conditions must be embodied in an accompanying letter. 4 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Foskop through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. - Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in Table 3.2 of the specific goals Claim Form.

5 COMMUNICATION

In the interest of fairness and transparency, Foskop's response to such a query will be published on the e-tender portal and Foskop website.

- 5.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 5.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Foskop in respect of this RFP between the closing date and the date of the award of the business.
- 5.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- 5.6 Foskop will publish the outcome of this RFP in the Foskop website with 10 days after the award has been finalised. Respondents are required to check the Foskop website for the results of the tender process. All unsuccessful bidders have a right to request Foskop to furnish individual reasons for their bid not being successful. 6 CONFIDENTIALITY

7 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Supplier/Service provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

8 EMPLOYMENT EQUITY ACT

Respondents are hereby advised that Foskop is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Foskop reserves the right to:

- 9.1 modify the RFP's Goods/Services and request Respondents to re-bid on any such changes;
- 9.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- 9.3 disqualify Proposals submitted after the stated submission deadline [closing date];
- 9.4 award a contract in connection with this Proposal at any time after the RFP's closing date;
- 9.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- 9.6 split the award of the contract between more than one Supplier/Service provider, should it at Foskop's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- 9.7 cancel the bid process;

10 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Foskop's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

11 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

12 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

13 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to FOSKOR and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

SECTION 3: BACKGROUND AND SCOPE OF REQUIREMENTS

1 BACKGROUND

Foskor is one of the world's largest producers of phosphate rock (concentrate) and phosphoric acid. It is one of the world's few vertically integrated producers of phosphoric acid and is the second-largest supplier to India, the world's largest consumer of phosphoric acid.

The Company owns and mines phosphate resources and beneficiates the mined material to produce a phosphate concentrate at Phalaborwa, in the Limpopo Province of South Africa. The phosphate concentrate is sold locally and transported to the Richards Bay plant on the coast of Kwa-Zulu Natal to produce phosphoric acid, sulphuric acid, and granular fertilizers MAP and DAP from phosphoric acid and is the leading supplier of fertilizers to South Africa. In all about 95% of the phosphoric acid is exported and the granular sales are divided between exports and local markets. Since 1951 Foskor has supplied more than 95% of South Africa's fertiliser requirements.

2 SCOPE OF REQUIREMENTS

Detailed Site Structural inspection and survey followed by Survey Report of the Bush pumps filters building is to determine the extent of deterioration and the quantum of concrete and structural refurbishment required for optimum extension in serviceable life span (Preferably about 7 years to 10 years).

Phase 1 – Feasibility on temporary repair design, support installation for 2-year life extension

The work entailed for Phase 1 should be read and determined in conjunction with the report "MA1063-LSL-ENG-RPT-0002 – FOSKOR PLANT STRUCTURE ASSESSMENT – BOSPOMPE FILTER PLANT – Rev A Final".

- i. From the report in the section "STEEL STRUCTURES - STRUCTURAL ASSESSMENT" on Pages 12 to 20 an option must be investigated on the feasibility of a scope of repair/mitigation on the most urgent and unsafe structural elements. Locations with a priority "X" are to be considered and specific priority is for the ones which is worse off.
- ii. The feasibility study of the scope of repair should contain suggested temporary repair methods or methods of risk mitigation for a 2-year life extension throughout the feasibility and design phase until the complete refurbishment construction project can commence. The complete refurbishment (Phase 3) must resume where Phase 1 was left off at.
- iii. The scope of repair should contain detailed Tender specifications and a Bill of quantities to enable Foskor to invite tenderers to execute the proposed method of temporary structural steel repairs and structural failure mitigations
- iv. Detailed drawings of proposed repair/mitigation methods and members to be introduced must be provided by the engineering design consultant
- v. HAZOP/Change management on implementation and alterations
- vi. The installation contractor will do Shop Details; however, review and approval of shop details will be in the scope of works of the successful engineering design consultant
- vii. Class 3 - accurate Cost Estimate for executing the proposed method for structural steel repair of the Priority "X" items
- viii. Class 3 - accurate Estimated Time Schedule for executing the proposed method for structural steel repair of the Priority "X" items

Phase 2 – Filter 20 Auxiliary Plant Relocation design (See Annexure A.1)

The work entailed in phase 2 is for the design to relocate Filter 20's Auxiliary operating equipment to enable the belt filter to operate independently from the Bush Pumps filtration building whilst being under construction. Phase 2 may take place in parallel with Phase 1 due to the minimal relation between the 2 phases. The major auxiliary equipment for relocation includes:

- 2BE1 353 Vacuum Pump,
 - 185kW Motor,
 - Vacuum piping
 - vacuum vessels.
 - Barometric sump
 - Services
- i. Foundation geotechnical study to be conducted on the preferred location of equipment relocation. Information received indicates that Filter 20 was constructed on a mixture of tailings material and magnetite.
 - ii. Filter 20 slurry feed box structure height increase and piping modification design to be provided. Slurry overflow is preferred to flow back gravitationally to the Main Bush Pumps distribution box via an overflow pipe. Height to be adequate to prevent slurry material from settling in the overflow pipeline.
 - iii. Foundation Civil design for the relocated Vacuum Pump, motor, and Vacuum Vessel structure
 - iv. Vacuum system design review
 - v. Piping Design to accommodate the relocated vacuum pump, vessel, and slurry feed box increased height.
 - vi. Structural steel design for the new vessel supporting structure and additional slurry feed box height structure
 - vii. Services design to accommodate the relocation of auxiliary equipment (Electrical cable routing, piping routing, and supports)
 - viii. HAZOP Study to be conducted on execution and changes
 - ix. Detailed drawings of designs to be provided by engineering design consultants
 - x. Detailed Tender specifications and Bill of quantities to enable Foskor to invite tenderers to execute the proposed relocation design
 - xi. Class 2 - accurate Cost Estimate for fabrication and construction of the proposed designs
 - xii. Class 2 - accurate Estimated Time Schedule for fabrication and construction of the proposed designs

Phase 3 – Plant life extension refurbishment feasibility study

- i. Feasibility Study including Trade-off study to determine:
 - a. Options to:
 - i. Construct a new plant with similar output capacity for a lifespan of 30+ years
 - ii. Complete refurbishment of existing plant for a Lifespan of 7-10 years
 - iii. Complete refurbishment of existing plant for a Lifespan of 15-20 years

- b. The financial viability for the concrete and structural refurbishment of the Bush Pumps filter plant in terms of capital expenditure required to carry out a new build or complete refurbishment and the extension in serviceable life span gained by carrying out the concrete and structural refurbishment.
 - c. Care must be taken that concrete and structural refurbishment of the Bush Pumps filter plant does not adversely interfere with existing equipment's piping and other services in the plant and building. The feasibility report must also include the maintenance and care required to ensure the design lifespan is achieved on the Bush Pumps filter plant.
- ii. The Feasibility Study should include the concept design and drawing of the proposed method for concrete and structural refurbishment of the Bush Pumps and the associated cost estimate to implement the proposed method. Limited as-build designs are available, this provision should be made for 3-D scanning of the plant to consider the following disciplines:

a. Civil

All concrete and cement elements to be taken into account when conducting the feasibility study i.e.

- Core sample analysis for PH testing of concrete throughout the building to draw a dependable conclusion on the current condition.
- Internal reinforcing corrosion causing spalling
- Concrete void detection and honeycombing etc

b. Structural

All structural steel elements are to be taken into consideration when conducting the feasibility study. ie, review of structural design, current steel member thickness, and % loss. This shall include the 3 conveyors in the bush pump filter plant (Conveyor 271,272 and 275) and the 2 belt filters (Filter 21 and 22)

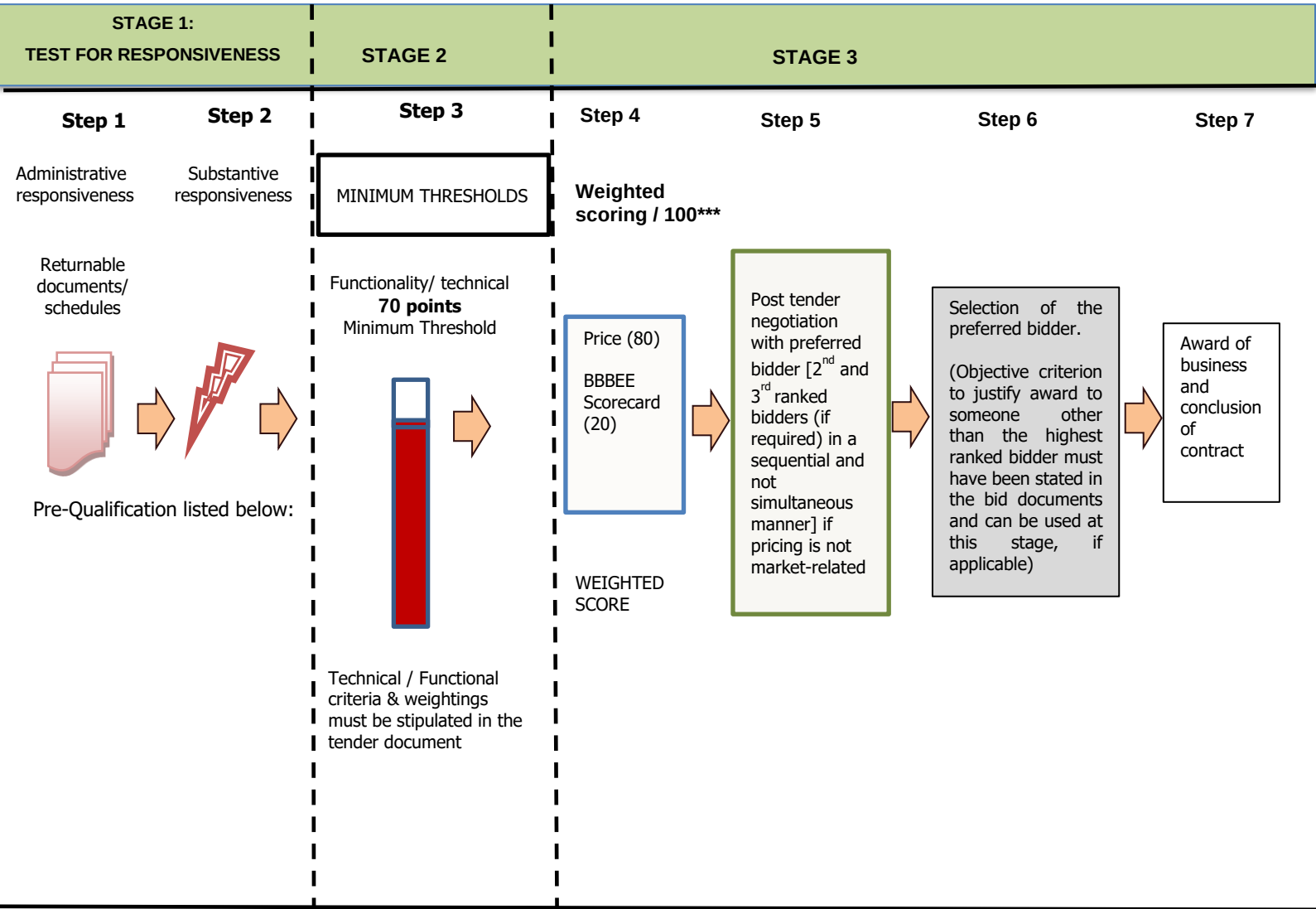

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME**INTRODUCTION**

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIPP requirements. NIPP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

1. PILLARS OF THE PROGRAMME

- 1.1 The NIPP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$5 million or other currency equivalent to US\$5 million will have a NIP obligation. This threshold of US\$5 million can be reached as follows:
- (a) Any single contract with imported content exceeding US\$5 million.
 - or
 - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$5 million.
 - or
 - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$5 million.
 - or
 - (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$5 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30% of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIPP obligation on a *pro-rata* basis.
- 1.3 To satisfy the NIPP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.
- 1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

2. REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. (d) above.

3. BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)
