1. Bidders must be registered on the National Treasury's Central Supplier Database (CSD) and have their tax matters in order prior to award of business.
2. Compliance with the Latest Circular of the Gazette Labour Rate for Contract Cleaners, in accordance with section 6(2) of the National Minimum Wage Act, No. 9 of 2018.
3. PRASA is looking to appoint different service providers for different segments. The successful contractors will be limited to single appointment in terms of awarding of business within the different segments. Bidders are required to indicate the segment they are bidding for.

Bid proposals will remain valid for a period of 90 days; PRASA is not obliged to accept the lowest or any proposal.
