SUBJECT: TERMS OF REFERENCE FOR THE SUPPLY OF THREE EVACUATION CHAIRS

1. BACKGROUND

The Security Risk Management (SRM) division is aligned with the Occupational Health and Safety Act 85 of 1993. The assessment was conducted to determine the level of required equipment in terms of Occupational Health and Safety Act regulations. Therefore, we have identified that extra evacuations chairs are needed because of the layout of the floors which is different from the old building.

2. SCOPE OF SERVICE

2.1 The appointed service provider will be expected to supply, commission and install Evacuation Chairs as follows:

Duration of the warranty of the service

This call out service contract shall commence upon SADPMR issuing a letter of appointment. The maintenance of the evacuation chairs will be required within prescribed period of warranty of service.

2.2 EVACUATION CHAIRS SPECIFICATIONS

- Adjustable patient head restraint: The sliding head restraint and padded back limit movement, securing a user in place and allow for user's comfort.

- Ergonomic adjustable handle: For ease of deployment and compact storage.

- Quick release safety belts (Head, Chest, Thigh): For increased passenger safety and security. In emergency situations, the passenger may not be conscious or have control. The chest restraint cups the body securely and the rider is strapped into the chair.

- Heavy duty wheels: Ideal for operation over uneven terrain

Lockable rear wheels: Can be applied in situations where the chair needs to remain in a stationary position.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
 - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.

Bid rigging is, therefore, an agreement between competitors not to compete.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.
