## **REQUEST FOR PROPOSALS FOR THE DESIGN AND CONSTRUCTION OF TRADEZONE II WAREHOUSE 2 TOP STRUCTURE (TURNKEY PROJECT) LOCATED AT DUBE TRADEPORT**

Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to [www.dubetradeport.co.za](http://www.dubetradeport.co.za) for more information on DTPC.

Dube TradePort Corporation (DTPC) hereby invites proposals for the design and construction of TradeZone II warehouse 2 Top structure.

The works consist of the Turnkey (Design and Construction) of a Spec Build facility at TradeZone II to provide a total bulk area of 13003m<sup>2</sup>, including offices, ablution, and sundry facilities as per DTPCs requirements.

It is estimated that tenderers must have active CIDB contractor grading designation of **8GB** or higher by the closing date of the bid. **No PE status is allowed.**

### **PREQUALIFICATION AND OBJECTIVE CRITERIA**

In line with the PPPFA regulations, 2017-sub regulation 4, the prequalification for this bid is that:

- a) **Only** B-BBEE Level 1 or 2 with 30% subcontracted to EME/QSE companies which is 51% owned by black people, eligible to tender.

It is an objective criteria of this bid in terms of the PPPFA 2001, that all the above mentioned subcontractors (targeted enterprises both professional service and construction service providers) in this bid are based in KwaZulu Natal (i.e. have operating offices in KZN).

### **LOCAL PRODUCTION AND CONTENT**

In line with the National Treasury Instruction notes, this bid has a Local Production and Content for designated sectors as follows:

- a) Steel must be 100%,
- b) Plastic pipes must be 100%,
- c) Electrical cables must be 90%
- d) Cement must be 100%

Failure to comply with the prequalification, objective, local production and content requirements in the tender proposal will result in a disqualification of your bid proposal.

### **EVALUATION OF THIS BID**

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 90/10 preference points system.
