 4. All submissions should be prominently marked with the following details in the email subject line:

 5. Bidders are advised to email electronic submissions at least thirty minutes before the bid closing time to cater for any possible delay in transmission or receipt of the bid. The onus is on bidder to ensure that the bid is submitted on time via email

DETAILED TECHNICAL SPECIFICATION

1. COMPANY OVERVIEW

South African Broadcasting Corporation (SABC) is a Public Entity founded in August 1936 and listed in terms of Schedule 2 of the Public Finance Management Act, Act No. 1 of 1999, as a public broadcaster in South Africa, and provides 19 radio stations as well as five television broadcasts to the general public.

2. BACKGROUND

SABC Northwest is currently accommodating various unserviceable, redundant, dilapidated, and/or obsolete assets that must be disposed of. The Assets Management team and IT has conducted asset verification, and these assets are physically on site but cannot be traced back to the assets register. The full list of detailed inventories is available on the **attached spreadsheets**.

3. REQUIREMENTS

The Successful bidders will be responsible for the below-mentioned scope of works but not limited to:

- a) Provide collection and transportation service of assets at SABC.
- b) The service provider is required to give SABC an offer on the assets.**
- c) The appointed service provider must provide SABC with a destruction certificate or a simple guarantee that the data will be formatted.
- d) The appointed service provider will work with SABC staff to compile a register of assets removed for SABC to remove the assets from the asset register.
- e) Business may be awarded to the service provider that will give a competitive offer to SABC.
- f) Transaction should be at no cost to SABC.**
- g) Preference will be given to the service provider that will take the whole lot.
