- 2. Minimum 5 years' experience in assessing ICT infrastructure and service suitability and readiness, locational, and building suitability as well as designing and

- implementing telecommunications solutions for GBS operations in at least 3 comparable projects.
- 3. Minimum 5 years' experience in analyzing local workforce availability and suitability, developing recruitment strategies and workforce plans, and talent acquisition in at least 3 comparable projects.
- 4. Minimum 5 years' experience in designing and implementing training and development programs for call center or customer service operations, including collaboration with educational institutions and training service providers, in at least 3 comparable projects.
- 5. Minimum 5 years' experience in market and business analysis with demonstrated capacity to estimate establishment and operational costs, develop financial models including demand forecasting, and synthesise financial and market insights into recommendations for operational models and business strategies in at least 3 feasibility studies.
- 6. Ability to identify and justify relevant GBS market segments and potential client opportunities, supported by previous market analyses.
- 7. Experience assessing risks, dependencies, and critical success factors, with documented mitigation strategies in prior projects.
- 8. Strong project management capabilities demonstrated by successful delivery of at least 3 similar projects.
- 9. Demonstrated knowledge of South African Government incentives and support for GBS.
