

RABADA IN WORLD TEST CHAMPIONSHIP FINAL SQUAD

● We have a 'balanced squad' for clash with Aussies – coach

SA have included Kagiso Rabada in the squad for the World Test Championship final against Australia at Lord's from June 11-15 following the fast bowler's return from a suspension for testing positive for a recreational drug.

Rabada, who spent a month on the sidelines at the Indian Premier League at this year's SA20 competition, is likely to lead the fast-bowling attack with seamers Marco Jansen, Corbin Bosch, Wiaan Mulder, Lungi Ngidi and Dane Paterson. Keshav Maharaj and Senuran Muthusamy are the two specialist spin options.

Captain Temba Bavuma heads the list of batters, along with Aiden Markram, Tony de Zorzi, Ryan Rickelton, Tristan Stubbs and David Bedingham, while Kyle Verreynne is the specialist wicket-keeper in the squad. "Over the past 18 months, we've worked hard to build a competitive red-ball unit. A key part of our success has been consistency in selection, and we've stuck with the core group of players who have been part of this WTC cycle. We've selected a balanced squad for the conditions we expect at Lord's,"
