### INFORMATION STATEMENT IN TERMS OF SECTION 33(1)(a)(i)(aa) & (bb) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCIAL MANAGEMENT ACT 56 OF 2003 RELATING TO THE FIVE (5) YEARS CONTRACT THAT THE MUNICIPALITY INTENDS ENTERING INTO FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR THE PROVISION AND ADMINISTRATION OF AN ELECTRICITY AND WATER PREPAYMENT VENDING SYSTEMS

In terms of section 33(1)(a) of the Municipal Finance Management Act 56 of 2003, read with section 21A of the Local Government: Municipal Systems Act 32 of 2000, the Oudtshoorn Municipality hereby publishes the following Information Statement summarizing the municipality's obligations to appoint a service provider for the **provision and administration of an electricity and water prepayment vending system**. We invite the public to submit any comments or representations, within 30 days from the date of this publication, in respect of the proposed contract.

#### INFORMATION STATEMENT

Municipalities are mandated to provide basic services and coordinate development within its boundaries as outlined in the Constitution of the Republic of South Africa 1996. To achieve this the municipality identified the need to appoint a service provider to administer the electricity and water prepaid vending. Fees payable to the service provider will be based on a percentage of the total prepaid vending per month. The process to complete such applications will be timeous and therefore the request to deviate the time of appointment of the service provider.

#### TERM OF CONTRACT

The time for the appointment of the service provider will deviate from a Three (3) year to a Five (5) year period from the date of appointment.

#### OBLIGATIONS

The municipal council will take a resolution on the new date. The service provider and the municipality will keep the community informed of progress related to any applications. The municipality will be entitled to cancel the contract and appoint a substitute service provider should it be apparent that the service provider is in default of complying legislative requirements and no performance after the service provider has been advised in writing by the municipality. In such an event the service provider will supply the municipality with all data and information collected and the municipality reserves the right to offset any payment due if required.

Any comments, in writing, must be placed in the Municipal tender box, **26 Church Street, OUDTSHOORN** no later than **12h00 on Tuesday, 17 June 2025**. Any person who cannot write may come during office hours to the office of **Jo-Verda Ladouce**, at the municipal offices at **69 Voortrekker Road**, where they will be assisted to transcribe their comments or representations.
