1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

Iziko Museums of South Africa (Iziko) invites service providers to submit proposals for converting photography negatives to digital files (digitization-scanning of heritage assets of Iziko).

BACKGROUND

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

1. Scope of Services and Brief

Struan Robertson digitization project

The primary objective of the project is to convert the Struan Robertson educational collection from photography negatives to digital images so that this collection is available for viewing to a variety of users (researchers, scholars, curators and other Museum practitioners, etc.).

- 1.1. The services of a professional photography institution to embark on a bulk scanning process of photographic negatives.
- 1.2. Scanning of a range of photography negatives (35mm, 120 negs - medium and large format) to high resolution digital images (300dpi, jpeg format, for A4 print).
- 1.3. Digital files to be named/labelled as they are on archival negative sleeves.
- 1.4. Negatives to be filed back to correct archival negative sleeve after scanning, as received from Iziko.
- 1.5. Negatives to be handled with the utmost, professional care (they are heritage resources).

BRIEF:**Digitization of the Struan Robertson negative collection**

The Struan Robertson educational collection is crucial for research on the Struan Robertson retrospective exhibition that is planned for 2025. To this end, we require the following:

- Scanning of 3600 images (from 35mm film, mainly black and white)
- Scanning of 100 images (medium format negatives: 6x4, 6x6, 6x8, and 6x9)
- Scanning of 100 images (large format negatives: 4" x 5")

Please note that the negatives are not rolled but already been cut (in rows, negative sleeves).

We require the following services for the above:

1. Scans to be standardized to high resolution, 300dpi, jpeg (A4 print size).
2. Titles, dates, roll numbers (and other information) on the negative sleeve to be transferred to scan identification (titles, dates, roll numbers, etc.).
3. Scans to be raw (entire image as negative - no cropping, and no enhancement is required).

QUOTE FORMAT:

The quote should be laid out under the following line items:

- 1) Scanning per image (35mm), as well as bulk (3600 images).
- 2) Scanning per image (medium format: 6x4, 6x6, 6x8, and 6x9), as well as bulk (100 images).
- 3) Scanning per image (large format: 4" x 5"), as well as bulk (100 images).
- 4) Any sundries/incidental costs? To be clear and specific, if any.

2. EVALUATION CRITERIA

Iziko promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

Iziko is committed to achieving Government’s transformation objectives in terms of the Preferential Procurement Policy Framework Act.

- Firstly, the bidder will have to comply with eligibility criteria as per Table 3.
- Thereafter assessment of quality will be done in terms of the evaluation criteria (Table 3) and the minimum threshold of **80** points. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.
- Proposals will be evaluated on the 80/20 preference points scoring system: that is, 80% of the points awarded will be based on price, as indicated in the table below; and 20% of the points awarded will be based on specific goals, allocated as indicated in the table below:
