1. INTRODUCTION AND PURPOSE

This bid makes provision for Quotation for the supply, delivery and off-loading of high-power flashlight (minimum 2000 Lumens) with a pouch to the Tshwane Metro Police Department.

2. BACKGROUND / DESCRIPTION

Theft of electricity cables and the vandalization of electricity substations and wastewater treatment plants has been on the increase in the last five (5) years and the situation has worsened in recent times in the City. This is a national phenomenon and up to this stage it appears as if the hand of the authorities is cut, despite the enabling legislation to address this growing crisis.

To address this growing concern, the City of Tshwane has decisively opted to establish a Cable Theft Unit within the operational mandate of the Tshwane Metropolitan Police Department. Equipment included in this technical specification is specifically aimed at

capacitating operational members with the required resources enabling them to optimally perform their duties during night operations.

3. PROJECT SCOPE

HIGH-POWER FLASHLIGHT – HIGH OUTPUT – MINIMUM 2000 LUMENS FLASHLIGHT, INCLUDING A POUCH (USED WITH 50MM WEBBING BELT)

The flashlight must conform to and comply with the following minimum requirements:

SPECIFICATION

- The flashlight must be manufactured from an aero grade aluminum alloy with a HA III military hard-anodized finish.
- The flashlight must have optical lenses with a double-sided scratch resistant coating.
- The high output fitted with a HI LED (2000 Lumens) with a maximum throw of one thousand (1000) meters and a peak of 250,000cd.
- The flashlight must be fitted with a 21700 - 5000mAh rechargeable battery and must be compatible with CR123 batteries to enable a runtime of approximately one hundred (100) hours.
- The flashlight must have dual power indicators to indicate power and must display the battery voltage.

- The flashlight must have an ion battery charging circuit with a USB C port and must be rechargeable with a USB type C charge cable.
- The flashlight must have a constant current circuit to provide a stable output.
- The flashlight must have a dual button interface/pressure switches a tactical tail switch and a metal slide switch to select and control five (5) Brightness levels and special modes.
- The flashlight must have anti impact polarity protection.
- The flashlight must be waterproof up to two (2) meters submersible, dustproof and impact resistant for up to one (1) meter.

- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where

P_s = Points scored for comparative price of bid under consideration

P_t = Comparative price of bid under consideration

P_{min} = Comparative price of lowest acceptable bid

5. POINTS AWARDED FOR B-BBEE STATUS LEVEL OF CONTRIBUTION

- 5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.
- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
