## **TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR GRAP WORKSHOP**

### **1. BACKGROUND**

The South African Diamond and Precious Metals Regulator (SADPMR) is a Schedule 3A PFMA entity established in terms of section 3 of the Diamonds Act, 1986 (Act No.56 of 1986), as amended (Diamonds Act as amended). The SADPMR derives its mandate from the Diamonds Act and the Precious Metals Act, 2005 (Act No. 37 of 2005).

### **2. PURPOSE**

The purpose is to provide the finance reporting team with GRAP updates workshop to assist the team in the preparation of financial statements that complies with the requirements of GRAP as set by the Accounting Standard Board and improve on the audit findings raised by the Auditor General.

### **3.SCOPE OF WORK**

The GRAP workshop should cover the scope as follow:

3.1 Review accounting policies for compliance with GRAP and assist the team with improvements where necessary.

3.2 Review disclosure notes to the financial statements for compliance with GRAP and assist the team with improvements where necessary.

3.3 Review the 2022/23 audited financial statements together with the management report and provide recommendations on shortcomings identified.

3.4 Provide guidance on updated and new GRAP standards.

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
