This erratum serves to notify all prospective bidders of the following important amendment to the published tender document:

An error was identified in the tender document regarding the CIDB grading requirement.

The following mandatory requirement in the tender document has been revised to avoid ambiguity:

- **Mandatory Requirement – Requirement Number One (01):
CIDB GRADE 4ME & 4EP or higher.**

The original wording appeared to indicate that bidders were required to have both CIDB Grade 4ME and 4EP or higher, whereas the intended requirement was CIDB Grade 4ME or higher, or 4EP or higher.

Page 15 of the tender document has been updated accordingly to reflect this amendment.

All bidders are requested to take note of the above amendment.
