Repair Crane Hoist operation completely in all operation. All to work correctly and safely as to spec on Crane M261428010795. The Overhead crane at the Wheels Bearing workshop 3 Ton (Lasch). The operation needs to be repaired correctly and completely in all hoist's operations.

The Crane hoist operation is failing and has overwound the hook assembly damaging the hoist and components. All damaged components to be replaced and hoist operation repaired back to correct condition.
