- A submission submitted in response to this RFQ will constitute a binding offer which will remain binding and irrevocable for a period of **thirty (30) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFQ validity period is still in force. **(RFQ Validity Period: 30 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFQ.
- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.
- There shall be no discussions with any enterprise until evaluation of the proposal has been complete.
- RFQ's received after closing time and date will be classified as **LATE** and will not be considered.
- With regards to pricing, where a bidder submits both a quote and SBD 3, should the total bid prices differ, or calculation errors be identified, the one indicated on the SBD 3 pricing schedule shall be considered the correct price.

TERMS OF REFERENCE/SCOPE OF WORK

1.1 OVERVIEW

The Mine Health and Safety Council (MHSC) is a national public entity (schedule 3A), established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The MHSC is mandated to advise the Minister of Mineral Petroleum and Resources on Mine Health and Safety (MHS) issues in the mining industry relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of mining MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in South African Mining Industry.

1.2 DETAILED SPECIFICATIONS/SCOPE OF WORK

The Mine Health and Safety Council seeks to appoint a specialist to undertake specialist testing and investigations into the affected slab areas and provide documented findings, results, and recommendations where applicable.

The appointed specialist service provider shall carry out the following investigations:

1.2.1 Slab Deflection / Level Survey

The contractor shall:

- Take levels along and across all major cracks identified on site
- Identify and record:
 - Sagging
 - Rotation
 - Differential slab levels
 - Uneven slab profiles
- Provide survey results referenced to a suitable datum

- Indicate areas of concern on marked-up drawings

1.2.2 Reinforcement Scanning

The contractor shall:

- Perform reinforcement scanning to the suspended ground floor slab
- Focus investigations on:
 - Areas adjacent to major cracks
 - Beam/slab interfaces
- Identify and record where possible:
 - Top reinforcement positions and sizes
 - Bottom reinforcement positions and sizes
 - Reinforcement spacing and cover
- Identify any:
 - Reinforcement congestion
 - Discontinuity or irregular reinforcement layouts
- Mark reinforcement positions on site where required
- Provide scan outputs and marked-up drawings indicating reinforcement layouts.

1.2.3 Concrete strength Testing

The contractor shall:

- Carry out Schmidt hammer testing to determine indicative concrete surface hardness
- Record test locations and results
- Correlate findings to indicative concrete strength ranges where applicable.

1.2.4 Deliverables

The contractor shall submit the following:

- Site investigation report
- Level survey results
- Reinforcement scan results
- Marked-up drawings indicating scan areas and findings
- Concrete test results

- Photographic record of investigations where applicable
- Summary of observations and identified concerns

All reports shall be submitted in PDF format, with drawings in PDF and editable format where available.

1.2.5 Access and Site Requirements

The contractor shall:

- Visit site prior to submission of quotation if required
- Confirm access requirements and any limitations
- Provide all necessary equipment and competent personnel
- Ensure all work is carried out in accordance with applicable health and safety regulations

1.2.6 Programme

The contractor shall indicate:

- Lead time to commence works
- Duration of investigations on site
- Estimated turnaround time for reporting


1.2.7 Contact and Coordination

All communication and coordination regarding the investigations shall be directed through the appointed project representative.

1.2.8 Area of Investigation and Annexures

Area of Investigation

The investigations shall be carried out at the identified affected slab areas within the building as indicated by the Mine Health and Safety Council (MHSC) representative during the site inspection and commencement meeting. The total building area is approximately **3,600m²** to **4,200 m²**., with investigations focused on the affected slab sections identified on site and in the annexed drawings. The approximate investigation area is estimated at **3,600m²** to **4,200 m²**.



The specialist contractor shall familiarize themselves with the affected areas and confirm the extent of access required prior to commencement of the investigations.

Annexures

The following drawings shall form part of this Terms of Reference and shall be attached as annexures where available:

- Annexure A: Architectural Layout Drawings

The contractor shall review all annexed information prior to commencement of the works and shall verify dimensions and site conditions during the site visit.

1.3 CONTRACT PERIOD

The contract will be valid for a period of two months.

Specific goals

Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:

- (i) **Price** - with the lowest priced bid receiving the highest price score as set out in the Preferential Procurement Regulations 2022.
- (ii) **Preference** - preference points are allocated in accordance with the Preferential Procurement Policy Framework Act (Act 5 of 2000) and its Regulations 2022 as claimed in the specific goals claim form (SBD 6.1) are added to the price ranking scores. The points for specific goals must be supported by a valid B-BBEE certificate or certified sworn affidavit.
