#### 1. PURPOSE

Amajuba District Municipality hereby wish to appoint a suitably qualified professional service provider to supply and install CCTV system and access control system.

#### 2. OVERALL AND SPECIFIC OBJECTIVES OF THE PROJECT

The purpose of this bid is to appoint a professional service provider for installation of CCTV system and access control system.
