1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.2 To be completed by the organ of state

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

1. Screen & Projector Setup

- A cinema projection screen with advanced coating and perforation for enhanced image quality, capable of top/bottom masking and fitting a width of up to 510 cm.
- High-performance cinema projectors compatible with 3D content.

2. 3D Equipment

- A 3D polarization modulator system suitable for passive 3D technology.
- A set of 500 passive 3D glasses for audience use.

3. Audio System (7.1 Setup)

- Three front loudspeakers for high-quality sound projection.
- Four surround sound loudspeakers for immersive audio experience.
- Four subwoofers for powerful bass.

4. Processing & Amplification

- A surround sound processor capable of managing 16 channels.
- Two amplifiers capable of driving 16 channels with a power output of 200W at 8Ω or 400W at 4Ω.

5. Control & Playback Devices

- A centralized control system with wireless gateway, touch screen controllers (front and rear), and remote controls for easy operation.
- Standard playback devices, including a Blu-ray player and streaming device.

6. Cabling & Infrastructure
