<b>Race</b>	100% Black owned = 5 points, more than or equal to 51% Black owned = 3 points, less than 51% Black owned = 1 point, Maximum points of 5 points
<b>Disability</b>	100% people with Disability owned = 5 points, more or equal to than 51% people with Disability owned = 3 points, less than 51% people with Disability owned = 1 point Maximum points of 5 points
