1. PURPOSE

The purpose of this RFQ is to appoint a service provider to pest control services in Groenkloof National Park for a period of 3 years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

Specification of the Pest Control is as follows,

- Annual fumigation services of all 150 offices plus 8 boardrooms
- Spray and gel all the offices for ants, termites, mosquitoes, and cockroaches
- Spray and gel all 19 kitchens and 1 cafeteria for ants, termites and cockroaches, annually
- Submit treatment report per each service

Measures of performance will be further stipulated and agreed in the Service Level Agreement and be based on the following principles:

- i) After every three months (quarterly) inspections treatment report
- ii) Call – Outs and complain responding (Re-active Respond to complain):
- iii) One free call out between service intervals
