

#### PART 2 - TERMS OF REFERENCE (BID SPECIFICATIONS)

#### **BACKGROUND**

Sarah Baartman District Municipality (SBDM) is made up of seven (7) local municipalities and covers the following areas:

- 1. Makana Municipality
- 2. Ndlambe Municipality
- 3. Kouga Municipality
- 4. Dr. Beyers Naudé Municipality
- 5. Blue Crane Route Municipality
- 6. Koukamma Municipality
- 7. Sundays River Valley Municipality



Section 46(1)(a) of the Disaster Management Act 57 of 2002 mandates a municipal disaster management centre to assist the National Centre and the Provincial Disaster Management Centre to:

- identify and establish communication links with disaster management role-players in the municipal area for the purpose of developing and maintaining a directory of institutional role-players that should be involved in disaster management in its area. The list should include the following:
  - Their names, telephone and fax numbers as well as the physical, postal and electronic addresses

- Their involvement in disaster management
- The nature, capacity and location of emergency and relief services under their control.
- ii) Establish effective communication directory of persons identified including: -
  - National, Provincial and Municipal organs of State and Statutory functionaries involved in Disaster Management
  - NGOs involved in Disaster Management
  - Disaster Management experts in South Africa
  - Private Sector organizations with specialized equipment, skills, or knowledge relevant to disaster management.
  - Private sector voluntary agencies involved in disaster management
  - Foreign non-governmental organizations; and
- iii) Furthermore, the disaster management centre must act as a repository of and conduct for information concerning disaster, impending disaster and disaster management in the Municipal area. For this purpose, the SBDM Disaster Management Centre wants to develop a web enabled electronic database
  - Storing information on all aspects of disaster and disaster management phenomena, occurrences, activities and circumstances that cause or aggravate disaster (include indigenous knowledge)
  - Process and analyze the abovementioned information to enable prevention and mitigation
  - Early warning systems
  - Disseminating information especially to communities that are vulnerable to disasters
  - Developing and maintaining an electronic spatial database containing information on disasters
    that occur or may occur in its area, including recurring occurrences that results in loss, but which
    are not classified as disasters in terms of the Act
  - Emergency response resources and capacity of government and non-government sectors in the national, provincial and within the district, including the location and size of:
    - Police station
    - Hospitals, clinics and other health institutions
    - Emergency Medical Service
    - Schools, churches, public buildings and other facilities that could be used as emergency shelters
    - Firefighting service and
    - Airports, airstrips, harbors, seaports and railway stations
  - Emergency response capacity in neighboring District Municipalities and relevant national and international relief agencies operating within the district.

#### **OBJECTIVES OF THE PROJECT**

The ultimate objective of this project is to have a district-wide integrated disaster management information and communication system to enable local municipalities to communicate with each other and with the District Municipality. The information on the system will be utilised to manage and take decisions during a significant incident or a disaster.

#### **SCOPE OF WORK**

The Sarah Baartman District Municipality invites bids from prospective bidders for the development, cloud-hosting, maintenance and support of a web-based Integrated Disaster Management Information and Communication System for its head office, and seven (7) local municipalities for a period of three (3) years.

The system must be an online (web-based), operational management, reporting and communication tool, developed for Disaster Management and fire services with a wide variety of incidents including but not limited to veld fires, structural fires, social unrest, public events, automobile accidents, hazmat spills, specialist technical rescue.

The system must be user-friendly, easy to use collaboration tool which would enable authorities to communicate across organizational boundaries.

#### **MIGRATION OF HISTORICAL DATA**

The service provider will be required to migrate historical data from the old system to the newly developed system.

#### **REPORT CAPTURING**

The system must be able to capture the reports below in line with Disaster Management Act and the Disaster Risk Management Policy Framework.

#### Incident report

The system must allow for users to capture incident reports for a collection of incident types or categories. The incident capture process must guide the user through the process of obtaining the essential information required in order to provide an efficient response and to provide information on specific Standard Operating Procedures related to the incident which is being responded to.

The system must allow for these Standard Operating Procedures to be defined within the application on an incident-by-incident basis should it be required. Once the initial data has been captured, the system should automatically trigger a notification to key persons as setup in the system and then direct the user to capture the secondary information associated to the incident type. All additions and changes to incidents must be stored with information pertaining to the responsible capturer and the time in which the information was added or changed.

The workflow process for incidents must be completely customizable with associated authority levels for each workflow state change.

#### Interactive Standard Operating Procedures

The system must allow for the creation of dynamic and interactive Standard Operating Procedures which prompt those involved in the response as to the steps required in order to comply. This should include a prompt alongside the incident capture with a range of pro-active integrations to assist in the compliance of the Standard Operating Procedure such as click to dial, automated text message notifications to the relevant stakeholders or notifying of other assisting agencies.

#### Mapping

The system must allow for all incidents to be loaded with an address and a latitude and longitude. This function must allow the operator to plot the incidents on an overview map which must be able to show a high-level overview of all incidents active within the jurisdiction.

Boundary Marking

The system must allow incident boundaries that would allow the user to track the area of an incident at given intervals. Each boundary added must at least allow for a description to be added to be stored against the incident record. With each boundary added, the operator must be able to add a description in order to provide additional context.

This data is useful for statistical purposes over time in order to find common trends.

#### Occurrence report

The occurrence report must be a combination of occurrence book messages (which are not associated to an incident) and incident action updates as and when they are captured into the application. All messages and incident action updates must allow for an action time (for cases when the messages need to be backdated) as well as a system capture time to ensure that an audit of the interaction is kept.

By clicking on any of the occurrence book entries, you must have access to a full incident report to provide additional information and context. From the Occurrence Book, you must be able to send a text via email or text message as well as add it to a situation report in cases where the operator has to manage a collection of associated incidents.

#### Situation Reports

In cases where the operator might have a collection of associated incidents that might need to be grouped for situational reporting purposes, the system must be able to group incidents together into a single view with information about the location of each of the incidents overlaid with applicable risks and points of interest.

#### Reports and Printouts

Sarah Baartman

The system must allow the operator to export all entries loaded into the reports by date range. This report must be provided in a PDF report, broken up by day with all entries loaded from the different incidents as well as the general occurrence book entries. Additionally, the operator must be able to send any of the entries to authorized contacts via e-mail or SMS.

The system must come standard with at least the following reports:

- Immediate Incident Report contains limited information only;
- Full Incident Report contains all information captured;
- Incident Action Report contains only action updates loaded;

#### SYSTEM FUNCTIONALITY

#### Contacts

The system must cater for a built-in contacts book which allows for a central storage location and communication platform for all key personnel and contacts associated with the organization. The user must be able to add and edit contacts. The system must allow for the logical grouping of contacts based on communication needs, severity of incidents from a notifications perspective or geographically, such as a dispatch center, public events location or fire station.

#### **Users and Access Permissions**

The system administrator must be able to create a system user and assign access permissions.

#### Places and Groups

The system must allow the user to create places and groups such as fire stations, disaster management centers and other services, e.g., a police station or community center in a hierarchical style structure. Attached to any one of these structures, you should be able to associate resources and personnel, as well as see further information such as a map of the location.

#### Search

The system must have an incident search tool which allows the operator to specify criteria from a collection of incident fields ranging from category, date, actions, addresses and references to personnel and resources. The operator must have the option to either export the incidents into an Excel spreadsheet or to display them on a map. The export tool must allow the operator to specify which fields he/she would like included in the spreadsheet and then it should allow for the report to either be downloaded or emailed to a recipient.

#### Rostering

The rostering system must at least allow users to create shifts and to add personnel to a particular shift period and resource. Once created, users must be able to download a PDF printout of upcoming shift assignments and distribute accordingly. This information must also automatically be included in the live occurrence book when completed, ensuring that all key parties are kept informed of changes in personnel availability.

#### Data Upload / Download

The system must have a document management system integrated allowing for documents to be uploaded against an incident. These must include PDF documents, Spreadsheets, XML files or even photos or videos. These should all automatically be allocated into a structured folder hierarchy accessible via either the incident or the document management page.

#### Security and Compatibility

- Provision of Secure Socket Layer Certificate (SSL) for the Integrated Disaster Management Information System
- Service provider must have multiple layers of security for 24 hours, 7 days and 365 days a year (information must be encrypted).
- Limit login attempts to avoid brute force attacks.
- The Integrated Disaster Management Information System must be compatible with various devices including but not limited to notebooks, personal computers, tablets, iPads, smart phones including android and iOS operating systems.
- The Integrated Disaster Management Information System must be a responsive and adaptive website that can be accessed by the aforementioned devices, irrespective of screen size or resolution.

#### COMMUNICATION

#### **Notifications**

The system must allow you to allocate personnel to receive notifications either at a generic level (for all incidents at a place) or to specific incident categories and severity levels, ensuring that all individuals are kept up to date with information applicable to them and their portfolio.

The system must have full integrated email and SMS Text Message communication allowing for real-time updates for key role players directly from the system. The system must be capable of sending messages to

individuals or all contacts within a group or place. The system must maintain a full message history that could be searched, not only on message content, but on recipient and date range as well.

Sending of SMS Text Message or Email must be available from any page within the application, from the Occurrence Book or from within an incident from the action updates based on predefined notification groups.

The system must be able to monitor an SMS to allow for the public to SMS a dedicated number to report incidents. These messages must then go into a moderation queue for verification to be added to an existing incident or to be used to initiate a new incident.

#### SYSTEM SUPPORT

#### Hosting, Maintenance and Support

At least a working day support team, both for user as well as technical support, must be available that could be contacted from Monday to Friday between 08h00 and 17h00, as well as after hours on a standby arrangement, either via telephone or via a ticket email option.

The Integrated Disaster Management Information System must be hosted in the cloud by the bidder and must be available without interruptions.

Maintenance and support required for the Integrated Disaster Management Information System required includes, security updates, backups, bug fixes and ensuring the system's availability is 99.9% uptime (24 hours, 7 days, and 365 days a year).

Respond to all tickets logged and requests submitted by SBDM officials as follows, for the system disaster recovery and service continuity:

- A maximum of 2 hours response time for all high priority incidents and requests.
- A maximum of 4 hours response time for all medium priority incidents and requests.
- Telephone and/or email support.

#### INFORMATION SECURITY REQUIREMENT

- The bidder must perform daily website database backups.
- Security on the system must be ensured for proper login detail verification.
- Ownership of data must remain the property of Sarah Baartman District Municipality (SBDM) and cannot be shared for any purpose unless formal approval is granted by SBDM.
- Ownership of IT Infrastructure remain with the service provider.

#### INTELLECTUAL PROPERTY RIGHTS

Copyright, patent rights and other similar rights in any works or products created as a result of the performance of this bid and its assignments shall vest in and must be transferred to the Sarah Baartman District Municipality.

#### **TRAINING**

Conduct a handover process which is all encompassing and includes:

 Training to the staff, provision of all relevant documentation as deliverables, i.e., end user and technical manual that will be used for the training and administering of the system.

#### **EVALUATION CRITERIA**

The evaluation of this Bid will be conducted in the following two (2) stages:

#### 1. Assessment of functionality

The assessment of functionality will be done in terms of the evaluation criteria. A Bid will be disqualified if it fails to meet the minimum threshold of 70% for functionality as per the Bid invitation and will not proceed to the 2<sup>nd</sup> stage of evaluation.

# THE NATIONAL TREASURY - GOVERNMENT PROCUREMENT GENERAL CONDITIONS OF CONTRACT

The purpose of this document is to:

- a) Draw special attention to certain general conditions applicable to government bids, contracts and orders;
   and
- b) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.
- c) The General Conditions of Contract will form part of all bid documents and may be amended.
- d) Special Conditions of Contract (SCC) relevant to a specific bid should be compiled separately for every bid and will supplement the General Conditions of Contract.
   Wherever there is a conflict, the provisions in the SCC will prevail

### 1. **DEFINITIONS**

The following terms shall be interpreted as indicated:

- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 **"Countervailing duties"** are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "**Delivery**" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the goods are so delivered and a valid receipt is obtained.
- 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the to, acts of the purchaser in its sovereign capacity, wars or evolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any Bidder and includes collusive practice among Bidders (prior to or after Bid submission) designed to establish Bid prices at artificial non-competitive levels and to deprive the Bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is.
- 1.16 "Imported content" means that portion of the Bid price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the goods covered by the Bid will be manufactured.

- 1.25 **"Supplier"** means the successful Bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.26 "Tort" means in breach of contract.
- 1.27 "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.28 "Written" or "in writing" means hand-written in ink or any form of electronic or mechanical writing.

### 2. APPLICATION

- 2.1 These general conditions are applicable to all Bids, contracts and orders including Bids for functional and professional services (excluding professional services related to the building and construction industry), sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the Bid documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific goods, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

### 3. GENERAL

- 3.1 Unless otherwise indicated in the Bid documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a Bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 Invitations to Bid are usually published in locally distributed news media and on the municipality/municipal entity website.

### 4. STANDARDS

4.1 The goods supplied shall conform to the standards mentioned in the Bid documents and specifications.

### 5. USE OF CONTRACT DOCUMENTS AND INFORMATION INSPECTION

- 5.1 The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain he property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier's records relating to the Performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

### 6. PATENT RIGHTS

6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

6.2 When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

### 7. PERFORMANCE SECURITY

- 7.1 Within thirty (30) days of receipt of the notification of contract award, the successful Bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3 The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
  - a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the Bid documents or another form acceptable to the purchaser; or
  - b) a cashier's or certified cheque.
- 7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

### 8. INSPECTIONS, TESTS AND ANALYSES

- 8.1 All pre-bidding testing will be for the account of the bidder.
- 8.2 If it is a Bid condition that goods to be produced or services to be rendered should at any stage be subject to inspections, tests and analyses, the Bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or organization acting on behalf of the purchaser.
- 8.3 If there are no inspection requirements indicated in the Bid documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5 Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6 Goods and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7 Any contract goods may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods, which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier

fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

### 9. PACKING

- 9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, and in any subsequent instructions ordered by the purchaser.

### 10. DELIVERY AND DOCUMENTS

10.1 Delivery of the goods and arrangements for shipping and clearance obligations shall be made by the supplier in accordance with the terms specified in the contract.

### 11. INSURANCE

### Sarah Baartman

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

### 1. TRANSPORTATION

1.1 Should a price other than an all-inclusive delivered price be required, this shall be specified.

### 2. INCIDENTAL SERVICES

- 2.1 The supplier may be required to provide any or all of the following services, including additional services, if any:
  - (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
  - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
  - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
  - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

### 14. SPARE PARTS

- 14.1 As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
  - (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
  - (b) in the event of termination of production of the spare parts:
    - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
    - (ii) Following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

### 15. WARRANTY

- 15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.
- 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4 Upon receipt of such notice, the supplier shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

### 16. PAYMENT

- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated.

### 17. PRICES

17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his Bid, with the exception of any price adjustments authorized or in the purchaser's request for Bid validity extension, as the case may be.

### 18. VARIATION ORDERS

18.1 In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price, and such offers may be accepted provided that there is no escalation in price.

### 19. ASSIGNMENT

19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

### 20. SUBCONTRACTS

20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the Bid. Such notification, in the original Bid or later, shall not relieve the supplier from any liability or obligation under the contract.

### 21. DELAYS IN THE SUPPLIER'S PERFORMANCE

- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, it's likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the goods are required, or the supplier's services are not readily available.
- 21.4 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22.2 without the application of penalties.
- 21.5 Upon any delay beyond the delivery period in the case of a goods contract, the purchaser shall, without cancelling the contract, be entitled to purchase goods of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

### 22. PENALTIES

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

### 23. TERMINATION FOR DEFAULT

- 23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
  - (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
  - (b) if the supplier fails to perform any other obligation(s) under the contract; or
  - (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner, as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess posts for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.
- 23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
  - (i) the name and address of the supplier and / or person restricted by the purchaser;
  - (ii) the date of commencement of the restriction
  - (iii) the period of restriction; and
  - (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Bid Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

### 24. ANTIDUMPING AND COUNTERVAILING DUTIES AND RIGHTS

24.1 When, after the date of Bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the supplier to the purchaser or the purchaser may deduct such amounts from moneys (if any) which may otherwise be due to the supplier in regard to goods or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

### 25. FORCE MAJEURE

- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

### 26. TERMINATION FOR INSOLVENCY

26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy, which has accrued or will accrue thereafter to the purchaser.

### 27. SETTLEMENT OF DISPUTES

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.

- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Notwithstanding any reference to mediation and/or court proceedings herein,
  - (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
  - (b) the purchaser shall pay the supplier any monies due the supplier for goods delivered and / or services rendered according to the prescripts of the contract.

### 28. LIMITATION OF LIABILITY

- 28.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6:
  - (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
  - (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

### 29. GOVERNING LANGUAGE

29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

### 30. APPLICABLE LAW

DISTRICT MUNICIPALITY
Province of the Fostern Cape

30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

### 31. NOTICES

- 31.1 Every written acceptance of a Bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his Bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

### 32. TAXES AND DUTIES

- 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any Bidder whose tax matters are not in order. Prior to the award of a Bid SARS must have certified that the tax matters of the preferred Bidder are in order.

32.4 No contract shall be concluded with any Bidder whose municipal rates and taxes and municipal services charges are in arrears.

### 33. TRANSFER OF CONTRACTS

33.1 The contractor shall not abandon, transfer, cede assign or sublet a contract or part thereof without the written permission of the purchaser.

### 34. AMENDMENT OF CONTRACTS

34.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

### 35. Prohibition of Restrictive Practices

- 35.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of **restrictive practices** 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a Bidder(s) is / are or a contractor(s) was / were involved in collusive Bid.
- 35.2 If a Bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 0f 1998.

35.3 If a Bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the Bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the Bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the Bidder(s) or contractor(s) concerned.
