1.1 DESCRIPTION OF SERVICE: SUPPLY AND DELIVERY GRAPEVINE ROOTSTOCKS FOR TABLE GRAPES TO NIETVOORBIJ RESEARCH FARM, R44 KLAPMUTS ROAD, STELLENBOSCH, 7600

BACKGROUND: Grapevine rootstocks come from a different vine species (or a cross of several different species) selected to help table grapes thrive in difficult growing conditions. Grapevine rootstocks are selected based on drought resistance, pest resistance or even tolerance for certain soil conditions like high pH. Rootstocks are also used to improve vigour, increase production and help sustain the health or survival of the vineyard and may increase winter hardiness due to healthier less stressed vines.

PURPOSE: Table grape selections will be grafted onto rootstocks.
