# **SECTION A**

## **1. BACKGROUND**

The Social Housing Regulatory Authority ("SHRA") was established in August 2010 by the Minister of Human Settlements in terms of the Social Housing Act, No. 16 of 2008. The SHRA is classified as a public entity in terms of Schedule 3A of the Public Finance Management Act.

### **1.1 MISSION**

The SHRA will regulate and invest to deliver affordable rental homes and renew communities.

### **1.2 VISION:**

Affordable rental homes in integrated urban environments through sustainable institutions.

### **1.3 FUNCTIONS**

- Promote the development and awareness of social housing by providing an enabling environment for the growth and development of the social housing sector.
- Provide advice and support to the Department of Human Settlements in its development of policy for the social housing sector and facilitate national social housing programmes
- Provide best practice information and research on the status of the social housing sector
- Support provincial governments with the approval of project applications by social housing institutions
- Provide assistance, when requested, with the process of the designation of restructuring zones
- Enter into agreements with provincial governments and the National Housing Finance Corporation to ensure the co-ordinated exercise of powers

## 2. RFB SUBMISSION CONDITIONS AND INSTRUCTIONS

### 2.1 FRAUD AND CORRUPTION

2.1.1 All Providers are to take note of the implications of contravening the Prevention and Combating of Corrupt Activities Act, Act No 12 of 2004 and any other Act applicable.

2.1.2 The company name must be the Trading name and be exactly the same as the one to be provided on the Bid submission register.

## **2.5 LATE BIDS**

2.5.1 Bids received late shall not be considered. A bid will be considered late if it arrived only one second after 11h00 or any time thereafter. Bids arriving late will not be considered under any circumstances. Bids received late shall be returned unopened to the bidder. Bidders are therefore strongly advised to ensure that bids be despatched allowing enough time for any unforeseen events that may delay the delivery of the bid.

2.5.2 The official Telkom time (dial 1026) will be used to verify the exact closing time (11h00)

2.5.3 Bids sent to SHRA via normal post or any other mechanism shall be deemed to be received at the date and time of arrival at the SHRA premises (tender/bid box or reception). Bids received at the physical address after the closing date and time of the bid, shall therefore be deemed to be received late.

## **2.6 DIRECTIONS TO SHRA OFFICE FOR DELIVERY OF BIDS.**

2.6.1 **Bidders should allow time to access the premises due to security arrangements that need to be observed.**

## **2.7 FORMAT OF BIDS**

2.7.1 Bidders must complete all the necessary bid documents and undertakings required in this bid document. Bidders are advised that their bid should be concise, written in plain English and simply presented.

2.7.2 Bidders are to set out their bid in the following format:

### **Part 1: Invitation to Bid**

Bidders must complete and submit the Invitation to Bid document.

### **Part 2: Pricing Schedule**

Bidders must complete and submit the pricing schedule document.

The appointed Service Provider will:

- Claim travel costs applicable to this contract as per the AA rates
- Book only economy class flight and preferably Group A hire cars, otherwise Group B are to be used for Service Providers outside of Gauteng.
- Book only hotels, or other equivalent accommodation up to a Rand value of R1 400 per night per person (including dinner, breakfast and parking).

**The value of this bid is estimated not to exceed R50 000 000 (all applicable taxes included) and therefore the 80/20 system shall be applicable**

### **Part 3: Declaration of Interest**

Each party to the bid must complete and submit the Declaration of Interest.

### **Part 4: Preference Points Claim Form in terms of the Preferential Procurement Regulations 2017**

Bidders must complete and submit the Preference Points Claim Form.

A trust, consortium or joint venture:

- ☐ will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate OR a Letter from a registered Accounting Officer/ Auditor OR a sworn affidavit in terms of the Amended B-BBEE Codes from Exempted Micro Enterprises (EMEs) of R10 000 000 annual turnover.
- ☐ will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.

### **Part 5: Broad Based Black Economic Empowerment Certificate**

Bidders are to submit an Original/Certified copy of a valid BBEE Certificate.

### **Part 6: General Conditions of Contract**

Bidders must initial each page of the General Conditions of Contract and submit with their bid document.

### **Part 7: Technical approach**

Bidder must at least:

Describe, in detail, exactly how they propose to carry out the activities to achieve the outcomes identified in the terms of reference. Bidders are required to have the basic office equipment and the resource/s (which must include, laptop, 3G connection, landline, own office with the basic office equipment) will be located within the region where the work will be done. They should identify any possible problems that might hinder delivery and indicate how they will avoid, or overcome such problems.

Describe how the work will be managed. Provide an organisation chart clearly indicating:

- ☐ The lines of reporting and supervision within the bidder's team.
- ☐ The lines of reporting between the bidder and SHRA.

Identify the position(s) involved in the direct delivery of the service to be provided and in the overall management of the work and name the people who will fill these positions.

Provide a work plan of activities. In addition to providing details of the estimated number of workdays for each activity, bidders are to supply a detailed timetable that identifies when certain activities will be undertaken and over what period they will be spread. The timing of activities, the time needed to complete them, and the order in which they will be undertaken must be explained and justified.

Please note that part 9 should be no longer than 10 single-sided A4 pages in Arial 11 (font size).

### **Part 8: Team Details**

The bidder must provide:

### **Part 9: Experience in this field**

It is essential the service provider displays:

## **2.8 PRESENTATIONS**

2.8.1 SHRA reserves the right to invite Bidders for presentations before the award of this Bid. Only Bidders who have met the minimum functionality criteria will be invited to presentation.

## **2.9 NEGOTIATION**

2.9.1 SHRA has the right to enter into negotiation with a prospective service provider regarding any terms and conditions, including price(s), of a proposed contract.

2.9.2 SHRA shall not be obliged to accept the lowest of any quotation, offer or bid.

2.9.3 SHRA issues this bid invitation in good faith; however, it reserves the right to:

- ☐ Cancel or delay the selection process at any time, without explanation,
- ☐ Not to select any of the respondents to this bid invitation, without explanation,
- ☐ Exclude certain services, without explanation.

2.9.4 All bidders will be informed whether they have been successful or not. A contract will only be deemed to be concluded when reduced to writing in a contract form signed by the designated responsible person of both parties. The designated responsible person of SHRA is the Chief Executive Officer or his/her written authorised delegate.



## **2.10 REASONS FOR REJECTION**

- 2.10.1 SHRA shall reject a bid for the award of a contract if the recommended bidder has committed a proven corrupt or fraudulent act in competing for the particular contract.
- 2.10.2 SHRA may disregard the bid of any bidder if that bidder, or any of its directors:
  - 2.10.2.1 have abused the Supply Chain Management systems of SHRA.
  - 2.10.2.2 have committed proven fraud or any other improper conduct in relation to such systems.
  - 2.10.2.3 have failed to perform on any previous contract and the proof exists.
- 2.10.3 Such actions shall be communicated to the National Treasury.

### **3. TERMS OF REFERENCE**

#### **3.1 INTRODUCTION AND BACKGROUND**

The Social Housing Regulatory Authority (“SHRA”) was established by Parliament as prescribed by the Social Housing Act (16 of 2008). The SHRA is classified as a national public entity in terms of Schedule 3A of the Public Finance Management Act (1 of 1999) (“PFMA”).

The SHRA’s mandate is to invest in and regulate the social housing industry. The primary intention of the Social Housing Act is to deliver affordable rental housing to the low to medium income groups. The main aim of the SH Act is to achieve spatial, economic, and social integration of the urban environments in South Africa.

#### **3.2 CONTEXT**

Accredited Social Housing Institutions, accredited Co-operatives, and Other Delivery Agents (ODA) submit social housing project applications for the Consolidated Capital Grant (CCG) to the SHRA. The SHRA has an internal assessment tool herein after referred to as Quick Scan B (QSB) which is utilised to assess project readiness. This tool is then submitted by the Grant applicants as part of the application pack including supporting documents.

The QSB needs to be assessed and adjudicated for each social housing project. On collation of the outcome from the assessment and evaluation of the QSB, the service provider will present the outcome as invitees to both the Project Application Committee (PAC) and Technical Evaluation Committee (TEC).

#### **3.3 PURPOSE OF THE ASSIGNMENT**

The SHRA seeks to appoint a panel of service providers to provide independent assessments of the QSB and make a recommendation to PAC and TEC.

#### **3.4 DESCRIPTION OF THE ASSIGNMENT**

The CCG award application process requires applicants to complete the following tool:

##### **QSB: PROJECT TECHNICAL FEASIBILITY**

The QSB tool examines the technical readiness of a social housing project. The assessment entails but is not limited to the following criteria:

- Real rights to the land (Regulation 19).
- Confirm that the 7 minimum investment Criteria are met:
  - Medium to high density rental units.
  - Targets beneficiaries with income between R1850.00-R22000.00/ mon.
  - Min 30% primary target market.
  - Restructuring Zone
  - Support from Municipality & Province
  - Self-contained units/ multi-storey/ min size 30 m<sup>2</sup>
  - SHI – Conditionally accredited / ODA – 20% equity.
- Confirm project readiness criteria is met:
  - Confirmation of project funding
  - Confirmation of land ownership /rights to development of land
  - Town-planning approvals in place.
  - Valid Environmental Impact Authorisation (EIA)
  - Bulk services capacity sufficient
  - Market demand study (Responsive to local demand)
  - In advanced stage of design development
  - Cost estimates in an advanced stage
- Project delivery model, contracting strategy, project procurement strategy, SMART principles project implementation plan
- Professional team appointments.
- Site Development Plan (SDP), building plans, engineering designs, Structural Integrity reports of existing buildings (if required), provision for maintenance.
- Ensure unit functionality (space planning) is achieved.
- Enrolment with National Housing Builders Registration Council (NHBRC).
- Cost estimates, Bill of Quantities (BoQ), financial viability studies and cash flows etc.

The service provider to ensure that the social housing projects are well packaged, technically ready, and thus ensuring that project construction would start within four (4) months of CCG award as this has a direct impact on SHRA's achievement of its Annual Performance Plan (APP) Targets.

### **3.5 SCOPE OF WORK**

- a) Assess the application tool and supporting documents (QSB).
- b) Develop a query list of outstanding/incorrect documents and/or questions to be clarified - send list to SHRA.
- c) SHRA will liaise and forward the query list to the applicant.
- d) SHRA will forward the documentation received from the applicant to the service provider.

- e) The service provider must ensure that additional information and supporting documents from applicants are incorporated in the assessment.
- f) Service provider must conduct site visit to the subject property (project location) and incorporate findings into the final assessment report.
- g) Prepare a draft project assessment report that includes a summary of the recommendations for the outcome and detailed conditions. In addition, this report should highlight what the applicant still needs to address and the timeframes for obtaining those outstanding information.
- h) Prepare a consolidated report and presentation of project(s) including high level project risks assessment.
- i) Liaise with Project Development and Funding (PD&F) team regarding any concerns and provide regular updates on the status of the process and progress per project assessment.
- j) Be available to present the report with findings and recommendation to the Project Application Committee (PAC) and Technical Evaluation Committee (TEC),
- k) The TEC may request that the service provider undertake further work on the social housing project, to ensure that any outstanding conditions are met or to review any new information/documents and to update the assessment report.
- l) Be available for telephonic, or email verification of queries

### **3.6 DELIVERABLES IN SHRA TEMPLATES**

- a) Query list
- b) Draft assessment report
- c) Consolidated assessment report
- d) Standard SHRA Consolidated PowerPoint presentation

Final deliverables to be provided to SHRA both electronic format and hard copy that needs to be signed by the successful service provider.

### **3.7 DURATION OF THE CONTRACT**

The duration of the contract will be three (3) years from start date.

### **3.8 TIMEFRAMES**

The service providers will be allocated work relating to projects that are to be finalized within a period of 7-10 calendar days in preparation for a PAC meeting and subsequently within one week before a TEC meeting.

The TEC may request that the service provider undertake further work on the social housing project, to ensure that any outstanding conditions are met or to review any new information/documents and to update the assessment report.

The deliverables and timeframes will be monitored and managed by the SHRA and will be governed and agreed to in the Project Initiation Document (PID) to be signed between SHRA and the successful service providers.

### **3.9 REQUIRED LEVEL OF EXPERIENCE, QUALIFICATIONS AND EXPERTISE**

The service provider needs to have within their team, the following working knowledge/experience in the following areas:

- The team leader /bidder must be a registered professional within the built environment with a minimum of five (5) years' experience in any of the following:
  - Thorough understanding and demonstration of the affordable rental housing development process, statutory requirements, project packaging
  - Exposure and knowledge of municipal, provincial and national legislative and statutory policies, processes and procedures related to packaging a project.
  - Project Technical Feasibility and readiness
  - Understanding development planning and town planning requirements.
  - Understanding different procurement strategies.
  - Experience in residential project packaging.
- The team that holds relevant qualifications as required and related professional registrations certificates in:
  - Town Planning
  - Quantity Surveying
  - Architecture
  - Engineering (Civil and Structural)
  - Project Management
- Bidder has done at least three (3) similar assignments / projects successfully in the past. (Attach reference letters. **NB: Appointment letters will not be considered.**
- Members of the team are registered with a professional body (attach valid professional certificates) i.e. ECSA, SACAP, SACQSP; SAIA; SACPLAN; SACPCMP
- Submission of the professional indemnity insurance cover

***\*The appointed service provider will be required to work under intense pressure / short turnaround timeframes.***

### 3.10 ACCOUNTABILITY AND REPORTING

The Service Provider will report administratively to the nominated Portfolio Manager of each project and be accountable to the Project Development and Funding Executive for the duration of the contract. The service provider will report progress made at mutually agreed timeframes (to be established once the service provider has been contracted).

### 3.11 PRICING

The fixed bid price for the Assessment of QSB is **R35 742.53 per project (inclusive of VAT and excluding disbursements)** and increased annually thereafter by the CPI as indicated by Stats SA (inclusive of VAT) on 1<sup>st</sup> April every year.

**Service Providers must confirm that the above costing is acceptable to them if appointed by SHRA on this project.**

The pricing submitted for this assignment must be all-inclusive but excluding any actual disbursements. The rate above increases annually thereafter by the CPI as indicated by Stats SA (inclusive of VAT) on 1<sup>st</sup> April every year.

Disbursements should be in line with the National Treasury Cost Containment Measures Instruction notes No.7 of 2022/2023 related to Travel and Subsistence which will be reimbursed to the appointed service provider based on the pre-approval by the SHRA and a disbursement invoice is to be always submitted separately proof of payments for all disbursements must be attached to the disbursement invoice claimed.

The Bid will be evaluated on Functionality and B-BBEE status only as this is a panel with a pre-determined fee per assessment.

Please note that service providers:

- May be required to travel to the grant applicants during this process.
- All communication with grant applicants will be channelled via SHRA.
- The rate above is inclusive of VAT and excluding disbursements.

**Service providers are to disregard all the sections in this RFB that require pricing as the fees are pre-determined by the SHRA in this for this panel as indicated above.**

### 3.12 CONTRACTING PERIOD

The contracting period will be for a **period of thirty-six (36)** months and specifically for the assessment of the social housing projects. During the contracting period, there might be multiple assessment assignments. The confirmed timeframe for each assignment is dependent on the number of proposals/submissions received for the CCG award application. Service providers need to ensure that the scope of work is completed within each given assignment period. There will be no extensions of time granted for each assignment due to subsequent approval processes. Delay in submitting the deliverables to SHRA may be considered as non-performance and may lead to future work not being allocated/ termination of contract to the service provider.

**Service providers will be appointed on a rotational basis subject to their availability and performance. If the service provider is found to have committed a misconduct, they will be removed from the panel.**

### 3.13 DISCLAIMER

**The SHRA has not appointed external consultants to liaise with service providers on any matter and all matters regarding this bid will be channeled in writing via supply chain. It is also to be noted that SHRA will not at any given time solicit money from service providers.**

### 3.14 SUBMISSION REQUIREMENTS

**Service providers are required to submit the following consolidated proposal in response to this Bid:**

**a) Consolidated Proposal (document):**

**▪ Scope of work (to be separate in the proposal)**

- Understanding of the scope of the work/project as per the ToR above (Deliverables, Timeframes/Milestones, etc.)

**▪ Technical Approach Methodology**

- Detailed approach and methodology to the project to ensure that the scope of work and deliverables are met (approach, methodology, detailed workflow process Steps and actions, points of contact with SHRA, etc.)
- Specifically outline anticipated programme risks and concerns and how it will be mitigated

- **Resources/ Experience and Skills of Team** – summary of each service provider outlining previous work experience in the Affordable Rental Housing Field, undertaking similar work (organizational due diligence, technical feasibility and financial viability analysis) include detailed CVs highlighting similar work done.
- **Timeframes** - Confirmation of availability for the period of project and ability to deliver within these timeframes. **Noting that no extensions will be granted.**

## 4. EVALUATION PROCESS

### 4.1 COMPLIANCE WITH MINIMUM REQUIREMENTS

4.1.1 All bids duly lodged will be examined to determine compliance with bidding requirements and conditions. Bids with obvious deviations from the requirements/conditions, will be eliminated from further adjudication.

### 4.2 PRE-QUALIFICATION CRITERIA FOR PREFERENTIAL PROCUREMENT

4.2.1 As per the preferential Procurement Regulations (PPR) 2017, the SHRA is applying Pre-Qualification Criteria this bid in an effort to advance certain designated groups.

### 4.3 FUNCTIONALITY, PRICE AND PREFERENCE POINTS

4.3.1 All remaining bids will be evaluated as follows:

4.3.2 The functionality calculation will be done based on the defined criteria and weighting thereof. Functionality will be scored out of a 100. If it is deemed necessary, presentations may be held with Bidders who have met the minimum functionality criteria. If presentations are held, the functionality score will be adjusted whereby 80 percent will be awarded to during the bid evaluation and 20 percent will be for presentation score. **If a bidder fails to score a minimum of 70% out of 100% for functionality, the bid will be disregarded from further consideration.**

4.3.3 The second part will then be done on the 80/20 split whereby (80) points will be awarded for price and 20 points will be awarded for B-BBEE Status Level Contribution.

### 4.4 ELIMINATION OF BIDS ON GROUNDS OF FUNCTIONALITY

4.4.1 Bids that score less than 70% of the 100% available for functionality will be eliminated from further consideration. Points will therefore not be awarded for their cost bids or for B-BBEE Status Level of Contribution

4.4.2 The percentage scored for functionality should be calculated as follows:

4.4.3 Each panel member shall award values for each individual criterion on a score sheet. The value scored for each criterion shall be multiplied with the specified weighting for the relevant criterion to obtain the marks scored for the various criteria. These marks should be added to obtain the total score. The following formula should then be used to convert the total score to a percentage for functionality:

$$Ps = \frac{So}{Ms} \times Ap$$

where

Ps = percentage scored for functionality by bid/bid under consideration

So = total score of bid/bid under consideration

Ms = maximum possible score

Ap = percentage allocated for functionality

The percentages of each panel member shall be added together and divided by the number of panel members to establish the average percentage obtained by each individual bidder for functionality.

After calculation of the percentage for functionality, the prices of all bids that obtained the minimum score for functionality should be taken into consideration.

## **4.5 PRESENTATIONS**

4.5.1 SHRA may decide to have compulsory presentations made by Bidders who met the minimum functionality criteria once the functionality score has been calculated.

4.5.2 Presentations shall only affect the marks awarded for functionality. If SHRA wishes to use presentations as an additional selection criterion between bidders, the evaluation criteria to be affected shall be determined in advance and due allowance made in the mark scheme.

4.5.3 If the date of the presentation meeting is not indicated in the bid document, at least three days' notice will be given to bidders required to attend a presentation.

4.5.4 Presentations will be made to the full Evaluation Committee.

4.5.5 Points determined by the presentation will be awarded to each bidder by each member of the Evaluation Committee and then an average calculated.

## **4.6 AWARDING OF PREFERENCES POINTS**

4.6.1 Points for B-BBEE Status Level of Contribution will be awarded according to the table indicated in the preference points claim form(s).

## **4.7 COMBINING PRICE AND PREFERENCE POINTS**

4.7.1 The B-BBEE Status Level of Contribution marks for each bid will now be added to the price points for that bid

4.7.2 The Evaluation Committee may recommend that the contract be awarded to the bidder obtaining the highest aggregate mark as determined by 4.5.1 or to a lower scoring bid based on firm, verifiable and justifiable grounds.

## **4.8 ADJUDICATION OF BID**

- 4.8.1 The Adjudication Committee will consider the recommendations and make the final award. The successful bidder will usually be the service provider scoring the highest number of points or it may be a lower scoring bid based on firm, verifiable and justifiable grounds or no award at all.

- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **“prices”** includes all applicable taxes less all unconditional discounts;
- (h) **“proof of B-BBEE status level of contributor”** means:
  - 1) B-BBEE Status level certificate issued by an authorized body or person;
  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act;
- (i) **“QSE”** means a qualifying small business enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (j) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

#### 3.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

P<sub>s</sub> = Points scored for price of bid under consideration

P<sub>t</sub> = Price of bid under consideration

P<sub>min</sub> = Price of lowest acceptable bid
