REQUEST FOR QUOTATIONS FOR DEVELOPMENT OF SAFETY CRITICAL GRADES REGUATIONS

1.1. The Railway Safety Regulator (RSR) requires the services of a suitable service provider to assist with the development of safety critical grades regulations.

2. Considerations/background

- 2.1. The RSR regulates the railway safety by issuing operating Safety Permits to railway operators on the basis of an established and robust Safety Management System. The overall purpose of an SMS is to ensure that operators achieve their business objectives in a safe manner.
- 2.2. Since its inception, the RSR has therefore developed and/or adopted a number of Railway Safety Management System Standards, including the Human Factors Management standard, SANS 3000-4, which provides minimum requirements for the management of Safety Critical Grades.
- 2.3. The railway industry has however continued to experience a concerning number of railway occurrences attributable to human errors in the category of employees undertaking Safety Critical Grades, which is core to safe railway operations, and with the envisaged growth of the Railway Industry, provision of more detailed guideline requirements for the certification of safety critical grades is required to ensure comprehensive management of risks related to undertaking of safety critical work, and to support the growth and development of the Railway Industry. The Safety Critical Grades Regulation has therefore being prioritized to enable the Regulator to provide more detailed requirements and management of risks related to employees undertaking safety critical grades

5. Functionality Evaluation Criteria

5.1. The suitable service provider must demonstrate capacity and capability to execute this project by complying with the functionality criteria on the table below:

Service Providers must attain a minimum threshold of 70 points or more to be considered for evaluation on the 80/20 Preference Point System.

Failure to attain the set minimum threshold will result in a disqualification.

6. Evaluation 80/20 Preference Point System

6.1. The price quotations will be evaluated in accordance with the pre-scripts of the Preferential Procurement Policy Framework Act (PPPFA) and its regulations, in particular Preference Procurement Regulation 2022 which stipulate 80/20 preference point system for acquisition of goods or services



- with Rand value equal to or below R50 million (inclusive of all applicable tax).
- 6.2. A maximum of 80 points for price and 20 points for the specific goal specified on the request for quotation may be awarded to a Service Provider.
- 6.3. Points for the specific goal will be awarded as specified on the table below:
